Annual Progress Report - Part I

1. Overview of the Project

· · ·

Strengthening Planning and Monitoring Capacity of NPC (SPMC-NPC) project is under implementation since October 2009. This project supports the National Planning Commission to make its planning and monitoring systems inclusive as well as help NPC to strategize to meet the MDG goals. It aims to produce this result by i) making the national plans and current planning and monitoring processes, tools and system inclusive and in line with MDG goals; ii) making the processes of national level data collection, monitoring and analysis gender and social inclusion responsive; and iii) developing institutional capacity of the NPC with a focus on strengthening planning and monitoring systems, institutionalization of inclusive processes and formats, and capacity building of the relevant human resources

2. Key results in 2010

i) One of the important achievements of 2010 is the preparation of the MDG Progress Report 2010. This work has made significant contribution towards making the upcoming plan document MDG friendly. A section of the Approach Paper to the plan document is dedicated to MDGs. This process has encouraged the policy makers and planners to work towards commitment for MDGs.

Due to continued effort on MDG progress report preparation and dissemination, government is well aware about the MDGs and is making efforts to make the deliveries in line with MDG targets and indicators. The MDG targets and indicators are often referred while working on indicators and deliveries.

- ii) The exercise on MDG Needs Assessment has been completed. The intervention list in the sectors under study was provided to NPC to prepare approach paper to the TYP. The findings from the costing has been used for preparing chapters on Three Year Plan.
- iii) Another major area that the project is being involved is the support for preparation of the Three Year Plan. In 2010, support was provided to review the draft approach paper from the Gender and social inclusion perspective. A number of technical experts are being hired to review and finalise the sectoral chapters for the full plan document. This activity will continue until the first quarter of 2011.
- iv) The inputs provided to complete the DPMAS software and its handover to the MoLD has ensured the continued commitment of government and NPC on DPMAS implementation. In 2010, DPMAS software finalized, training manual prepared and the pilot training conducted covering 10 districts eight districts of Bagmati zone plus Dolakha and Ramechhap. The new leadership at the M&E Division at NPC and Planning Division at MoLD is seriously and completely engaged in DPMAS operationalization. The MoLD intends to implement it in all 75 districts. The UNDP and NPC started to put efforts on it since 2004. Such a long time required for its operationalization indicates need for stakeholders' strong and continued commitment and necessary action. However, it may take further several years if the scale of current effort by NPC and MoLD is continued and UNDP's technical support is continuously available.
- v) The support provided to CBS has been helpful in making the Census 2011 preparations Gender and Social Inclusion (GESI) friendly. While the consultation and the technical inputs provided to the CBS has been helpful to make the central level officials aware on the efforts towards GESI, the training materials prepared with this view will be helpful to make the field workers (enumerators and supervisors) GESI friendly. But this effort needs to be continued.

4. Results in Gender Equality, Women's Empowerment, and Social Inclusion

The Project supports NPC to mainstream GESI perspectives in the planning and monitoring process. In this process following results have been achieved:

GESI perspective has been incorporated in the third MDG progress report more than that in the second progress report. Analysis of data, findings and recommendations are presented by incorporating GESI perspectives.

Similarly, while preparing MDG Needs Assessment (MDG NA), analyses were done and interventions recommended from the GESI perspective.

The project had couple of Census related activities such as development of Census related training materials. While two consultants were hired to work on technical matters, a separate consultant was hired to review the training materials from GESI perspective. A separate paper on 'incorporation of GESI in the Census 2011' was presented to enhance awareness on GESI to the relevant staff members and stakeholders to be involved in the upcoming census. Therefore, albeit few, these activities have helped CBS to start incorporate GESI perspective in the Census 2011.

5. Implementation Challenges

- 5.1 Support to the Three Year Plan preparation is a very challenging work for the project. Although the project has made all preparations for facilitation of the Plan document preparation process, it is delaying as it is a highly politically sensitive work.

- 5.3 Implementation of DPMAS, PMAS and PPIS is challenging task. There is limited practice of using the results from monitoring and evaluation. Therefore, there is limited understanding and attention on the importance of monitoring and evaluation. This situation, in a way, has not been encouraging for the effectiveness of M&E. This challenge can be addressed with continued efforts by all the concerned stakeholders.
- 5.4 The project has multiple components with different objectives and therefore, requires different expertise. However, during 2010, there was only limited technical capacity with the project. It needs to be changed.

6. Lessons learned and next steps

- 6.1 The planning and budgeting processes are continuous process but they are not sufficiently integrated together. Therefore, there is need for reviewing these processes and find ways to integrate these processes together so that plans are realistically prepared and implemented.
- 6.2 MDG concepts are slowly getting internalized. In order to fully internalize MDGs, UNDP needs to continuously engage government in MDG related activities unlike the present practice of doing it intermittently on 'as and when needed basis'.
- 6.3 This project intends to provide inputs at the policy and planning level. The past experience shows that this work is time taking and complex. Often it requires lot of coordination and consultation to initiate and complete any action. It also requires lot of communication to maintain good relationship with people coming from different political background which is often complicated.
- 6.4 The support to preparation of TYP is a politically sensitive but important work for the project. In order to ensure right technical support through right experts, the project had to work in a well balanced manner. While the project had to work in consensus with the present NPC members, it has to consider potential change in the political situation which could affect the support it has extended to the NPC.

6.5 In order to ensure smooth implementation of the project, it is a must to understand the complex political dynamics within NPC. Further, it is critical to maintain a neutral role in such situation. Only such approach may help to facilitate project delivery.
