Description:

The United Nations Development Program and the Government of Pakistan (through ENERCON) entered into an Agreement in July, 2009 with a view to:

- Improve and produce Energy Efficient Home Appliances.
- Set Standards and Labels for the six targeted home appliances i.e. Fans, CFLs, Ballasts, Motors, Refrigerators and Air-conditioners.

Project BRESL aims at rapidly accelerating the adoption and implementation of energy efficiency standards and labels (ES&L) in participating countries of Asia, i.e. Bangladesh, China, Indonesia, Pakistan, Thailand and Vietnam, and in so doing bring about energy savings through use of energy efficient appliances/ equipment.

Output I

ID: ES&L Policy Making Program

Description:

ES&L policy making program provides a legal basis for prescribing and enforcing energy efficiency standards and labelling regime.

Targets 2013:

- ES&L Policy Formalization
- Adoption of Testing Protocols for BRESL Targeted Appliances & their Regional Harmonization
- Development of MEPS for six Targeted Appliances
- Adoption of labelling regime

Achievements Up to 3rd Quarter 2013:

- The revised Pakistan Energy Efficiency Conservation (PEEC) Bill, prepared by ENERCON has been submitted to Ministry of Water & Power (MOWP) for further processing by Council of Common Interests (CCI) and passage by the Parliament.
- Amended Summary regarding Energy Efficiency Standards & Labelling (ES&L), since submitted to MOWP for approval of the Federal Cabinet, is being pursued for early approval.
- EE Labelling Procedure along with Energy Efficiency Logo has been approved by Project Steering Committee (PSC). The procedure has been updated for regional harmonisation and energy performance rating criteria. It is now planned to be launched in 4th Quarter on the availability of Prime Minister/ Minister for Water & Power.
- A meeting of Technical Committee of PSQCA was organized by BRESL Project for approval of Testing Protocol for Air conditioners. The committee approved the Protocol in principle and is under processing for notification. (Testing Protocols for remaining 5 BRESL targeted appliances have already been approved/adopted).
- PSQCA requested for adoption of another International EE Testing Protocol for Refrigerators to cover temperature range differences in the newer class of refrigerators using inverter technology, which is under processing.
- A meeting of Technical Committee of PSQCA was organized for approval of MEPS for fans and electric motors, which were prepared by BRESL Project. MEPS for fans and electric motors have been approved and notified. MEPS for CFLs, Magnetic & Electronic Ballasts have already been adopted/ notified.
- MEPS for Air conditioners, prepared by BRESL, were submitted to PSQCA for approval. These have been approved and are under process of notification.

ID: ES&L Capacity Building Program

Description:

To facilitate awareness and implementation of ES&L regime, and to enhance the support mechanism.

Targets 2013:

- Training to strengthen and enable Public Institutions to support development and implementation of ES&L Programs
- Capacity enhancement in the development and implementation of Standards & Labeling for the six Targeted Products
- Strengthening of National and Regional Testing and Certification Infrastructure
- Strengthening of Data Collection and Reporting Procedures on Equipment Availability and Sales by Efficiency Level in Participating Countries (In last three Quarters)

Achievements Up to 3rd Quarter 2013:

- Meetings were held with manufacturers/ dealers of Pumps and Motors in Gujranwala. More than 70 participants were apprised of the benefits of upcoming ES&L regime being launched by ENERCON/BRESL. Participants desired more of such interaction, which is being planned.
- Liaison developed/ maintained with R&D Organizations, academia and Associations of Manufacturers to facilitate implementation of ES&L regime.
- PC-I prepared and submitted by PCSIR EMTL (Electrical Measurements & Testing Laboratory) for seeking approval for funding to upgrade their facility/ laboratory for EE testing of BRESL targeted appliances, particularly motors, air conditioners and refrigerators. MoST is being persuaded to expedite finalization/ establishment of requisite facility.
- PCSIR was facilitated for participation in EE comparison tests of fans, arranged by RPMU China.
- Public/Private Sector being encouraged through awareness campaigns to establish EE testing facilities.
- As a result of awareness campaign and consultative meetings, many of the manufacturers are on board for adoption/launching of ES&L regime. Working Group for Fans, consisting of public and private sector representatives, is devising the strategy for adoption/implementation of the regime in fan sector.
- RPMU was requested to arrange training of personnel from public sector stakeholders regarding
 implementation of ES&L regime and EE Testing in Accredited Laboratories in China. A study
 tour is being organized by RPMU in October 2013.

• TWG Feasibility Study Report for enhancement of harmonization for Fans was reviewed, revised and circulated to concerned stakeholders. The report has been electronically communicated to RPMU.

Achievements Up to 3rd Quarter 2013:

- BRESL Project Pakistan web-site developed and maintained.
- Requisite input provided by BRESL Pakistan to TWG/ RPMU for Regional ES&L harmonization.
- Participated in 5th Regional Project Steering Committee (RPSC) meeting held in Malaysia in April 2013.
- As per recommendations of Annual Technical Working Group (TWG) Meeting held in China in September 2012 and also of RPMU, TWGs Pakistan has been reconstituted. Two new members, one for fans and other for lighting, have been appointed, and are on board.
- Participated in 1st TWG 2013 meeting held in Malaysia in April 2013.
- As per recommendations/ resolutions of above meetings:
 - Feasibility Study Report for fans has been revised and completed through incorporating inputs

- from all the participating countries and in-country stakeholders. This revised report was circulated to all the in-country stakeholders for review and comments. The report has been electronically communicated to RPMU for approval/regional adoption.
- Needed inputs have been provided to TWG Indonesia, lead country for CFLs, for finalization of Feasibility Study Report on CFLs.
- Draft BRESL specifications for EE standards for fans have been developed. After regional approval of above report, these will be finalized in light of inputs from participating countries and submitted to RPMU for approval and regional adoption.
- MEPS for fans and CFLs have been revised to harmonize with the participating countries. These have been discussed with PSQCA and PCSIR in a meeting. After incorporating their suggestions, these have been re-submitted to Technical Committee of PSQCA for adoption/ notification.
- RPMU has established Regional Energy Efficiency Standards & Labeling Network (REESLN) to share resources and information among BRESL participating countries. BRESL Pakistan invited 25 stakeholders for participation in this forum. So far seven have applied for registration.
- BRESL Project Pakistan established information sharing network with Lites. Asia based in China for data collection, R & D on global EE lighting products.
- Plan for regional activities and coordination after the GEF Funded Project ends is being initiated by TWG/RPMU.
