1. Background

On June 2010, UNDP has been entrusted by the Swedish International Development Agency "SIDA" through a grant in the amount of SEK 4.8 million supports to the Environment Quality Authority (hereafter abbreviated as "EQA"). The envisaged effort is set up to improve environment monitoring compliance and enforcement of the environment in the occupied Palestinian territory (hereafter abbreviated as "oPt").

The project proposal prepared jointly by UNDP and EQA and approved by SIDA comprises two components. The first component focuses on carrying capacity assessment of EQA, identifies gaps and assesses strengths while the second component focuses on formulating action plan and supports better performance of EQA monitoring function.

UNDP draft report for EQA capacity assessment highlights several challenges that particularly impact on EQA's efficient functioning. Although environmental law exists, there are issues with its adequate enforcement, in particular with regard to the following aspects:

- The legal framework needs further development
- More directives, standards and bylaws need to be formulated and enacted
- Overlap of functions and competencies among authorities need to be resolved
- Environment needs to be perceived and asserted as a priority concern for the government and donors.
- Lack of information flow and a central information system need to be overcome
- Technical capacities in environmental monitoring or accountability frameworks need to be built
- Week internal capacities magnified by insufficient staffing, tools and equipments and funding need to be overcome.

This implementation plan prepared to translate the project objectives stated in the project proposal into a specific results and activities, redefines some of the activities in order to accommodate the following:

- Lack of set of regulation assumed to be formulated by EQA with support from other donors. Reference is made for EnSWG minutes of meeting, January 2011.

- Implement some of the key issues addressed by EQA and were highlighted at the capacity assessment report. Reference is made for EQA capacity assessment reports.

2. Project Objective

The project aims at strengthening the regulatory function of the EQA with focus on controlling pollution of industry activities and waste which have the potential to impact on a wide range of environmental areas including emissions to air, land and water by achieving the following objectives:

- Formulating short and long term strategies and action plan,
- Establishing clear monitoring process and procedures including clarification of roles and responsibilities for line ministers and authorities involved in the enforcement of environmental regulations and;
- Enhancing the capacity of the EQA environmental protection directorate regarding environmental monitoring and inspection in the areas of industrial waste and air pollution in addition to other areas that can be recommended by the consultant.

3. Project Outcome

The EQA is better able to carry out its monitoring and enforcement function with regard to environmental compliance

Output 1: Short and long term strategies and action plan formulated with full participation with EQA and other key actors in the sector

5. Project Activities

Activity 1.1: undertake capacity Assessment of Environment Quality Authority

The activity will support providing technical assistance through mobilizing UNDP Capacity Development Advisor for Arab region to assess capacities "strengths and Gaps" in EQA. The assessment shall target the three levels of capacity: enabling environment, institution and staff capacities. UNDP advisor shall carry desk review study and undertake at least 3 missions to complete the assessment and formulate action plan for developing EQA capacity as environmental regulator

Activity 1.2: formulate action plan for the environment sector strategy 2011-2013

On March 2010, EQA in joint efforts of governmental institutions and civil society and private sector has developed Environment Sector Strategy (ESS) for the period 2011-2013. The ESS identifies six strategic objectives to be achieved over this period. These objectives are:

- Palestinian environment to be clean, safe and free from pollution
- The natural environment and cultural heritage in Palestine are protected and conserved
- Palestinian natural resources are managed in a sustainable manner
- All necessary measures to adapt to climate change and to combat desertification and to address environmental and natural disasters are taken
- The institutional framework and environmental law are strong and working effectively in an integrated and consistent manner
- State of Palestine is committed to international conventions and treaties on the environment

In relation to above defined strategic objectives the ESS also highlights a number of environmental priorities to be carried by EQA as sector lead and other priorities to be carried out by main actors in the sector. However, the ESS lacks a detailed action plan to implement the set objectives and list of priorities.

This activity will support providing consultancy services to formulate action plan for ESS. The consultant will be based at EQA and work closely with the National team who prepared the sector strategy. The consultant will lead the formulation process and will be accountable for delivering the detailed action plan.

Activity 2.1: develop management plan for EQA environmental monitoring and enforcement



Weak regulatory framework and enforcement capacity was identified as one of the key challenges that have serious impacts on EQA's efficient functioning as sector regulator. The environmental law enacted in 1999 has been poorly enforced even in areas under the Palestinian Authority control (area A and B) due to the following:

- Lack of endorsed regulation, by-laws, specification, standards and environmental conditions
- Overlap and duplication of role between EQA as sector regulator and other actors in the sector such as Ministry of Health, Ministry of Local Government and Ministry of Agriculture
- Lack of clear management plan for EQA to bring the law into full enforcement
- Insufficient EQA monitoring and enforcement capacity, and
- Weak internal capacity in general magnified by insufficient staffing, tools and funding

EQA issues in accordance with the environmental law and environmental assessment policy environmental permits after reviewing application submitted by public and private agencies where the applicant has to comply with environmental conditions set by EQA stated in the service license issued by the licensing authority. The figure below presents the interrelation between EQA as regulator for the environmental sector and key actors responsible for issuing facility license and regulating service.

EQA has drafted several by-laws and environmental standards such as medical waste management, wastewater and protection of nature. However few by-laws were recently approved by the Cabinet of Ministries such as stone and marble cutting industry, ready mixed concrete factories, and tile factories.

This activity will support undertaking consultancy services to prepare management plan for EQA environmental monitoring. The consultant shall undertake the following:

- Mapping out facilities licensed and regulated by PA ministries, Authorities and municipalities which have the potential to cause harm to human health and environment and required an environmental permit to be granted by EQA as a prerequisite for issuing a facility license. The inventory shall include industrial, and commercial facilities, provided by private or public entity
- Mapping out drafted and endorsed environmental by-laws, standards in relation to the industries identified in the above item and identify gaps
- Draft set of environmental by-laws standards and instructions for regulated industries activities identified in the above items
- prepare operating manuals and procedures
- Develop coordination mechanism between EQA and line Ministries and authorities such as Ministry of Health, Ministry of National Economy, Ministry of local Government, for implementing environmental protection regulation. MOU shall be prepared and signed by agreed parties.

Activity 3.1: procure monitoring equipment

This activity will support consultancy services to undertake inventory of required monitoring equipment, preparation of specification, bill of quantities and cost estimate. The consultant shall split the list of needed equipment into lots and rank them in connection to EQA management and monitoring plan. The activity will also support supply of equipment ranked as top priority and development of management and maintenance plan for the equipments procured under this activity

Activity 3.2: carry out structure training programme for EQA's environment protection directorate

The activity will support undertaking training program for EQA's environmental protection directorate on undertaking monitoring and inspection, using monitoring equipment, manuals, gathering and analyzing data and prepare inspection reports including recommendation for decision makers. The training programme will include on job training on undertaking monitoring usage of monitoring equipment procured under activity 3.1, reporting and coaching through the process of testing the drafted regulations. Three pilot projects (case studies) will be designed to validate and establish management interface between EQA and key actors in the sector. In addition Exchange visits to Arab countries and Sweden will be explored during year 2011where EQA staff expected to gain knowledge and learn from other countries experience on enforcement of environmental protection regulation, planning for monitoring and inspection, flow of business processes and decision making in relation to environmental protection. 9. Project management arrangement

Implementation Modalities

UNDP/PAPP works in close coordination with PA, UN agencies, local Civil Society organizations, and local authorities in the implementation of projects and delivers through the Direct Execution (DEX) modality which will be the mechanism for the implementation of this project.

UNDP will report to the Swedish International Development Agency (SIDA) on quarterly basis as well as upon request by SIDA whereas the accountability of the project results and financial management rests with UNDP/PAPP.

On October 2010, UNDP/PAPP has entered into letter of Agreement with the Palestinian Environment Quality Authority (EQA) where responsibilities of each party has been articulated towards realizing the project desired results

UNDP/PAPP in cooperation with EQA will identify and pre-qualify National consultants to provide the technical assistance described in the project work plan. The technical Assistance providers will be based at EQA and will work closely with EQA projects and international relations and environment protection directorates in order to transfer and sharing knowledge and promote ownership of the project deliverables

Planning and management of activities

UNDP will assign a Project Manager who will be responsible for day-to- day management and decision-making for the project. The Project Manager's prime responsibility is to ensure that the project produces the results specified in the project document to the required standard of quality and within the specified constraints of time and cost. In order to ensure effective implementation and continuous activities progress monitoring, the Project Manager will be assisted by project assistant.

Project Oversight and Assurance

The project board will be established to undertake project oversight and assurance responsibility. The Project Board is a group responsible for making management decisions on a consensus basis for the project when guidance is required by the Project Manager, including recommendations for approval of project revisions. Project reviews by the board are made at designated decision points during the running of the project, or as necessary when raised by the Project Manager. The Board will be consulted by the Project Manager for decisions when project tolerances (i.e. constraints

- *Senior Beneficiary:* to ensure the realization of project benefits from the perspective of project beneficiaries (EQA and representatives from PA line Ministries)



10. Project Monitoring and Evaluation

In the last year, this review will be a final assessment. This review is driven by the Project Board and may involve other stakeholders as required. It shall focus on the extent to which progress is being made towards outputs, and that these remain aligned to appropriate outcomes
