With reference to the Specific Agreement_between the Norwegian Ministry of Foreign Affairs (the Donor) and the United Nations Development Programme/Programme of Assistance to Palestinian People (UNDP/PAPP), signed on 15 August 2017 with agreement No PAL-17/0004, (UNDP Ref. 00106652), amendment number o1 dated 19 August 2019, and amendment number 02 dated 16 February 2020, under which the Parties agreed to cooperate in the implementation of the "Access Coordination and Monitoring Support, Project, Gaza" (the Project) in the Occupied Palestinian Territory (oPt)

WHEREAS the Parties agree to amend certain provisions to the Agreement;
