QUESTION 1A How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The project directly contributes to Sustainable Development Goal 14 related to support Conserve and sustainably use the oceans, seas and marine resource. The Project will support mainstreaming the human-rights based approach by assisting fisheries organizations to develop and implement fisheries management plans and actively engage into fisheries governance without marginalization, exclusion and discrimination. The project has a highly participatory approach that will promote participation, inclusion and relationships among users and stakeholders (including authorities responsible for fisheries administration). The main tool will be a community of practice in which participants equally participate in a collective learning exercise to address a common problem (in the present case overfishing and fisheries governance). There are specific actions to support the building of human and social capital, and to promote multi - level dialogue and coordination among key actors (e.g., fishermen, participants of the value chain, fisheries and environment authorities, Peruvian regional governments). With this, it is expected that fishers and local stakeholders will benefit from their strengthened participation in decision-making processes, secure access to fishery resources, and improved partnerships and trust among public and private actors.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project has highly participatory approach and incorporates actions to promote gender equality and women's empowerment. In the scope of action of the project, women do not participate as fishers, but are a main element of the processing phase (as workforce) and participate in a range of activities in the public and private sectors. This opens an opportunity to encourage their engagement into fisheries governance. To ensure the gender equality and women's empowerment, the project will recognize the needs and constraints faced by women and men as well as their concerns and perceptions through the diagnosis of information needs and interests of users and stakeholders and the project's communication strategy. The integration of women in the communities of practices, as well as their integration into decision-making processes will be promoted in the project.

Briefly describe in the space below how the Project mainstreams environmental sustainability

The core of the project is to promote sustainable use of fishery resources within an ecosystem-based approach. The project will facilitate that stakeholders test ways to improve fisheries governance and use the lessons for decision-making. An element of work will be the synergy between fisheries and coastal and marine protected areas. In addition, the coastal and marine spatial planning exercises will place sensitive habitats and protected species into analysis process.


