### QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

#### Briefly describe in the space below how the Project mainstreams the human-rights based approach

The project aims for environmental and social impacts that could possibly affect vulnerable groups by including them in the positive effect of the changes proposed at an urban level to reach a sustainable city and environment. The communities that will be involved in this project will have the opportunity to be active participants whether it is a park and green areas brigades, help with recreational areas, information centers and even recycling projects. During the coordination stage of the project, one of the tasks that will be considered will be the coordination with the groups within the influence area of the project such as recyclers, neighbors and such, which will actively participate during the project processes and their opinions will be taken into consideration.

#### Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project's main goal in the social area is to have positive impacts on women and men. Each component of the project, whether it is urban transportation, waste management or biodiversity, considers the role women play in the different activities that are part of those components. Despite the fact that there is no much data available, one of the goals of the application of the project is precisely to include more gender oriented objectives to reach out to women empowerment in the different activities. Outcome 1 will mainstream gender issues through several strategies including: i) political and technical dialogue to ensure the participation of women in the development of the land use plan and sustainable development plan of the AMA, in multi-stakeholder platforms and other project processes; ii) specific training to build the capacities of public institutions for mainstreaming gender into the afore-mentioned plan, in institutional processes (e.g. gender sensitive budgets, generation of gender disaggregated data) and in citizen participation protocols, among others; iii) promoting participation and involvement of women in project activities (e.g. training activities); iv) developing actions to promote masculinities in institutions; and v) awareness raising on gender issues in the private sector. Outcome 2 mainstreams gender equality through several strategies, including: i) measures to facilitate the use of bicycle lanes by women; ii) generating disaggregated data for traffic related information that will serve as inputs for traffic management measures; and iii) safety measures to reduce

gender based violence in public transport. In outcome 3 Gender mainstreaming will therefore be an important aspect of the interventions. This will be done through identifying the positive measures that are needed to ensure the participation of female waste pickers (gancheras) and improving their livelihoods.

#### Briefly describe in the space below how the Project mainstreams environmental sustainability

The project has been designed to have a positive result on degraded and modified habitats as well as on increasing the protection of natural and critical habitats. By improving the management of the protected urban areas the project will increase their conservation. The establishment of green corridors between the green areas of Asuncion will facilitate the mobility of species from one area to another. This will increase genetic exchange, seed dispersal and gene flow between populations increasing sustainability of the species. In the case of Bahia de Asunción, the project will support habitat restoration of sand banks which will lead to the restoration of critical sites for birds and other migratory species. This will increase the protection of global populations of 5 endangered bird species during migration periods. In addition, the project will develop specific biodiversity monitoring program that will be used to guide future urban development and facilitate the protection of Asuncion's biodiversity and green areas.

The project has also been designed to significantly reduce UPOPs emissions that result from uncontrolled burning of waste in uncontrolled landfills or dumpsites. The project will support the Municipality of Asuncion to clean up and close illegal dumpsites, while designing and opening a new sanitary landfill. In addition, it aims towards implementing a separation and recycling facility to improve waste management and support waste derived products.

Furthermore, the project aims to reduce emissions by applying a sustainable urban transportation system, including the extensions of bike ways and a network of urban buses that will be designed to reduce CO2 emissions as well as other GHG.
