

AMENDMENT No.1 TO THE THIRD-PARTY COST-SHARING ARRANGEMENT

BETWEEN

THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

DFAT ARRANGEMENT NUMBER: 72409/8

1. On 8 December 2016, DFAT and The United Nations Development Programme (“the Partners”) entered into Arrangement 72409/8 in the form of Third Party Cost Sharing Arrangement for Fiji Parliament Support Project-Phase 2 (“the Arrangement”).
2. The Partners have now decided to amend the Arrangement as set out below:
