Background:

UNDP has been providing advisory services to the Ministry of Foreign Affairs (MOFA) within the framework of its efforts to develop its administrative and organizational structure since 2001. The support is aimed at building the capacity of the Ministry's administrative and organizational structures as well as targeting human resources development within the Ministry.

In line with the Kingdom of Saudi Arabia's development priorities, currently UNDP Saudi Arabia aligns its work along the 9th National Development Plan. The areas addressed are tailored to meet some of the challenges raised in the Ninth Development Plan. UNDP's focus in Saudi Arabia has, in recent years, shifted from assistance in infrastructure to a softer assistance in terms of development and implementation of national strategies and planning, provision of policy options, water and energy efficiency, and the promotion of Youth participation. As a continuation of the support to Ministry of Foreign Affairs, UNDP is planning to implement a project to support the capacity development of the Ministry of Foreign Affairs' Translation Department.

MOFA is at the forefront in representing Saudi Arabia in the G20 and as such its translation services strive for a higher quality and visibility in the diplomatic interactions with the international community. In view of the fact that the UN has a legacy of excellence in translation (through the UN's Department of the General Assembly and Conference Management) assistance will be viewed along two separate lines: interpretation and text translation, in addition to copy editing, this initial assistance will review the possibility of benefiting from the available translation resources at the UN and other partnerships

This will include identification of raining and mentoring needs of the staff in addition to the provision of technical support needed in order to review systems and procedures that have to be put in place with a view to streamline and update with greater efficiency.  - b) Translation services strengthened and modernized through improved communication, training and coordination
 - c) Increased partnerships and enhanced collaboration and integration of functions with relevant partners in the area of translation and interpretation


