I am writing on behalf of the International Development Association (IDA) to indicate IDA's agreement, as administrator of grant funds provided by the Multi-Donor Trust Fund for Sudan (MDTF-NS) to make a grant in an amount not exceeding thirteen million United States Dollars (US\$13,000,000) (the Grant) to the United Nations Development Program (UNDP) (the Recipient) for the benefit of Sudan (the Beneficiary).

The Beneficiary further hereby undertakes to take all action necessary or appropriate to enable the Recipient to carry out its obligations set forth in this Letter Agreement and the Annex and the Attachment hereto.

Please note that it is IDA's policy to make publicly available this Letter Agreement and any information related thereto, after this Letter Agreement has become effective and the


Recipient has given its consent to such disclosure. The Recipient, by countersigning this Letter Agreement, confirms its consent to such disclosure.


