1. GENERAL SITUATION

A - Political Situation in Abyei

No major developments were noted over the week.

B - Security Environment

The security situation in Abyei remained calm, with no incidents reported.

2. PROGRAMME (ACTIVITIES IMPLEMENTED, ACHIEVEMENTS AND PLANS)

A: Strengthening Access to Justice and Human Security

Output 1: People's awareness of their rights is enhanced

A scheduled meeting with the Abyei Human Rights Society did not take place due to lack of transportation for members coming to Abyei from Agok (approximately 40 km south of Abyei).

Output 2: People have access to an operational legal aid system

The project held a meeting with the Head of Legal Administration and the Paramount Chief, on 10 March 2009, to discuss the mandate of the traditional court. This had been necessitated by the protracted detention of women, sentenced by the court, for failure of paying court fees. UNMIS Human Rights had noted a number of cases in both Abyei and Agok where women convicted of adultery were detained for months for inability to pay fines. Similar cases of protracted detention had been reported about minors.

The Paramount Chief committed to share the formal legislation/document outlining the jurisdiction of the court for further discussion, to avoid wrongful and inconsistent judgments.

The Legal Administration will work closely with traditional court to streamline its operations and provide capacity building.

Output 3: Capacity of rural courts and traditional leaders to provide justice is enhanced

Output 4: Training capacity of law enforcement institutions is enhanced

4.1. Support to establishment of the JIPU

The project presented an assortment of medical items to JIPU on 11 March 2009. This followed a request forwarded by JIPU in November 2008. The items will be shipped to Abyei in different consignments by road and air. The first consignment arrived in Abyei last week and was presented by the Governance and Rule of Law Head of Unit, who was on mission in Abyei at the time.

4.2 Construction of the Agok Police Station

Works were on-going and completion was expected by mid April 2009.
