I. Executive summary

Since the launch of Constitutional Review Committee (CRC) by His Excellency, President Ernest Koroma in July 2013, the committee, with the support of United Nations Development Program, has carried out a series of activities, including inclusive civic education, stakeholder consultations, consultative dialogue, workshops and expert meetings on national issues of prime importance.

During the Ebola Virus outbreak a state of emergency led to the suspension of CRC's major activities such as public consultation in the provinces. Moreover, international experts were also reluctant to visit Sierra Leone during the outbreak. All these challenges led to serious delay in the process and on CRC's request the President of Sierra Leone extended the Mandate of the CRC till March 2016.

However, at the height of the EVD Virus UNDP-led constitutional review project was able to consults several MDAs and Civils Society Organizations including State House, Ministry of Information and Communication, National Commission for Democracy and Ministry of Youth Affairs among others. Several technical training were conducted for all subcommittees to improve on knowledge sharing on the CRC Process.

Soon after EVD subsided, CRC resumed and intensified its public engagement and embarked on nationwide consultation in March 2015 at districts and ward levels to solicit public opinion on the 1991 Constitution and 2008 Commission Report. During the consultation meeting general public enthusiastically participated in the process. All thematic issues of the 1991 Constitution relating to Executive, Legislative, Judiciary, and Information & Communication, Fundamental principles of State Policy and Human Rights, citizenship, local government and Natural Resources were thoroughly deliberated upon.

Furthermore, to consolidate National Peace-Building and State-Building efforts through a consultative, transparent and widely inclusive course of action, UNDP has also organized series of dialogues to facilitate discussion on the process with women groups, political parties, Youths, MPs, paramount chiefs, councillors including ministries, department and agencies.

With support of UNDP, CRC have enhanced it media engagement activities on radio and television and the sub-committees are having focused civic education on broad thematic issues with national institutions and government MDAs.

The CRC has received 150 position papers from different organizations and individuals. Also, the CRC has printed 30,000 copies of the combined 1991 Constitution and the Peter Tucker Report, 70,000 submission forms for individuals and institutions, produced 20,000 flash drives and other civic education materials including the 20,000 hours airtime over the Sierra Leone Broadcasting Corporation (SLBC) and other radio stations and has held 10,000 public consultations with various stakeholders nationwide.

Civil Society led engagement in the review process has also been remarkable. CSOs comprising of WANEP, OXFAM, SLBC, NCD, SDI/CCC and CGG have educated majority of Sierra Leoneans about the review process and this to an extent have helped

raised awareness on the CR process which has improve public contribution and participation.

II. Background

Following his re-election for a second term in November 2012, Sierra Leone's President Koroma pledged to undertake the long awaited review of the country's 1991 Constitution, as envisaged under the Lomé Peace Agreement and recommended by the Sierra Leone Truth and Reconciliation Commission (TRC). The President also assured the wider public and the international community, including the United Nations, that the review process would be inclusive and transparent. If properly undertaken, this review process will provide Sierra Leone with a unique opportunity to ensure its own transformation into a fully-fledged democracy, based on the rule of law and international human rights standards. A reformed Constitution, based on public input and participation, should also help Sierra Leone on the road to enduring peace and prosperity. It is for these reasons that UNDP continues to provide support to the national constitutional review process.

III. Progress Review

Capacity of CRC members developed to undertake effective constitutional review process and produce final recommendations:

During first quarter of 2015, fourteen Experts Meetings were organized for all Sub-Committees on key constitutional and governance related issues concerning to their thematic areas. This engagement provided an added opportunity to the veteran and expert sierra Leoneans to discuss and share their ideas on operational aspect of the 1991 constitution. To address the shortcomings of referendum related rules and regulations, a detailed workshop was held on the conduct of the constitutional referendum. Workshop brought together a crop of legal experts and stakeholders who critically examined the legal framework of Sierra Leone, bordering the conduct of Referendum and made recommendations for inclusion for legal provisions. Experts also drafted a comprehensive referendum act which is has been sent to the MoJ.

Capacity of CRC Secretariat to provide legal and research services to CRC developed. Develop organization structure and prepare job description and TORs for staff:

CRC Communication & Messaging Strategy designed and implemented:

During 2014 and 2015 UNDP in consultation with CRC developed an inclusive civic education strategy and engaged country's leading TV, radio and print media outlets to disseminate and educate general public on the thematic issues and review process. Sierra Leone Broadcasting Corporation produced jingles, drama, quiz and thematic discussion all during 2014 and 2015. Eighteen community radio stations partnered with SLBC to simulcast SLBC thematic discussions and programs at national level. Regular spots and drama messages aired on SLBC and community radio stations.

In addition, UNDP partner CSOs also played a pivotal role sensitizing the public on the constitutional issues. OXFAM Produced CRC messages in the four key languages of Mende, Temne, Limba and Krio and the message is broadcast in 10 radio stations across the country. One regular radio programme developed in collaboration with target groups to discuss the review process at district level. All CRC related videos, dramas and slideshows has been uploaded on the Channel to make it accessible not only to viewers who couldn't watch the live programme but also to Sierra Leoneans in the Diaspora.

The 1991 Constitutional and 2008 Commission report was serialized in ten leading newspapers during 2015.

Moreover, 20, 000 USB flash drive containing all relevant documents and public submission forms of thematic sub-committees, with the inscription '' I Love the Constitution'', has been produced and distributed in all 14 districts of Sierra Leone. CRC WhatsApp group is ongoing and thematic issues relating to Youth, Women, Political Parties, and Paramount Chiefs among others are debated on regular basis. CRC website and facebook page is ongoing and updated daily for public viewing and comments. CRC's monthly newsletter is also providing regular updates to the public on the process.

Civil Society led inclusive and informative civic education process;

During the process UNDP empowered CSOs to sensitize their people about the process to get their views on-board. Over 60 Civil Society Organizations (CSO) from across the country pledged their commitment to the Constitutional Review Process and replicated messages of the review process to their constituents. In addition, more than sixty CSOs have been directly engaged and facilitated Campaign for Good Governance (CGG) and SDI, CSOs have expressed satisfaction that the Constitution was being reviewed noting that the need to bring the Sierra Leone Constitution up-to-date with current developments was significant.

In last quarter of 2015 UNDP developed and brought together more than twenty leading CSO's to lead an open public consultation plan through establishment of "Constitution Kiosks" to share information and assist the public to fill out submission forms and have greater understanding of issues in the review process. CSOs effectively engaged citizens across the country in a two-month long 'Open Public Consultations'. This covered all the thematic areas on focus within the CR process to achieve a consensus-based constitution which is representing majority of citizen's aspirations.

Society for Democratic Initiative and Citizens for Constitutional Change engaged several media outlets to showcase civil society participation and perspective in the constitutional reform process. They produced radio and TV discussions, Newspapers articles published on the CRC process

They also engaged University Students on the CR Process in Freetown to capture students' opinions on specific areas of interest and opportunity to complete the CRC public submission forms.

WANEP organized regional consultations for the establishment and operations of infrastructures for peace in Sierra Leone. They trained youth from ten districts as Community 'Mobilizers' (CMs) on the Constitutional review process; organized 14 days door-to-door information sharing sessions in 7 border districts. They also initiated essay competition for school going children on the CR Process. In addition, WANEP produced

and aired 14 jingles in local languages to educate public on key thematic issues and on the CR process.

OXFAM organized civic education sessions with people living with disabilities in Freetown also a national conference on land, environment and natural resources issue. They also engaged print media and published informative material on the CRC process. From OXFAM engagement with women and marginalized groups they completed and submitted three hundred public submission forms to the CRC. They held ten sessions with members of the Governance stakeholders' coordination forum (GSCF) and organized interviews, questions and answer sessions on radio and TV featuring GSCF members.

Moreover, they produced Training Materials developed by CRC and 50/50 Group. Conducted five training of trainers workshops conducted and trained fifteen women and 10 men on gender and constitutional issues. They organized nine dialogue sessions between leaders and constituents in Freetown and 3 target districts. Based on their workshops and community dialogue four substantive Constituency Position Papers developed for presentation to the CRC.

National Commission for Democracy extensively engaged general masses through constitutional review sensitization and promotional materials; produced videos and translation of the constitution into 5 local languages; engaged eighty five Constituencies and communities nationwide.

Campaign for Good Governance organized Civic and Consultative Forum for village heads in the western area; Tribal Heads in the Western Area and Committee Members from five wards in each district. Engaged CRC and Tribal heads to discuss issues pertaining to land, local government, human rights and rule of law. Tribal heads developed their collective position paper and submitted to the CRC.

CRC led inclusive and transparent civic education and public consultation process;

During second quarter of 2015 CRC's national Public consultation were held nationwide in all districts simultaneously including Bonthe Island, consultation in Freetown in all 69 Wards in Western Rural and Urban respectively. In addition, CRC consulted eighty two ministries, departments and agencies on the process and received one hundred thirty position papers from different interest groups and stakeholders.

Enhance capacity of MP's, political parties and traditional leaders to effectively support and participate in the review process;

CRC held several engagements with parliamentarians to discuss issues relating to State Policy and Fundamental Principles of Human Rights, legislative, local government and issues related to proposed citizenship chapter. In addition, UNDP developed and implemented serious of dialogue sessions between paramount chiefs, civil society, women groups, youth, parliamentarians and local councillors during first and second quarter of 2015.

The purpose of the meeting was to define to other members present to explain the requirement for a person to become a State president.

On the 16th of February 2015 experts meetings were held for the Research Committee on the Consistency and Sustainability of political parties in Sierra Leone's Democracy. There were altogether 18 participants who were present including 5 females.

Deliberations focused on:

- Definition of political party
- History of political party formation in Sierra Leone
- Requirement for ensuring consistency and sustainability of Political Parties

On the 18th February 2015 expert training was held for the Research sub-committee on Civil Societies their independence and biases in terms of advocacies and their overlapping functions. There were 10 members who participated in the training including 3 females.

On the 20th February 2015 Expert engagement was held for the Local Government Sub- committee to discuss on Financial Decentralization and issues surrounding it.

On the 4th March 2015, a three days training was held for the Natural Resources Sub-committee at the CRC Secretariat to present to all present a Comparative Study of the 1991 Constitution, Dr. Peter .Tucker's Recommendations and Constitutions of other countries relating to Natural Resources and Land issues

33 participants including 6 females representing Government institutions like State House, Human Right Commission, Ministry of Agriculture Forestry and Food Security and Environmental Protection Agency. NGOs like Green Scenery, members representing political parties like UDM, RUFP and APC. CRC Natural Recourses Sub-committee members, UNDP etc, were present

A three days training was held for the Natural Resources Sub-committee at the CRC Secretariat to present to all present a Comparative Study of the 1991 Constitution, Dr. Peter .Tucker's Recommendations and Constitutions of other countries relating to Natural Resources and Land

The Subcommittee on State Policy and Human Rights held a two-days' workshop to develop a chapter on citizenship (Ch.2) for the revised constitution40 participants with 10 females attended the workshop

In March 2015, a referendum workshop was held at CRC Secretariat that brought together a group of legal experts and stakeholders who critically examined the legal framework Sierra Leone, bordering the conduct of Referendum and make recommendations for inclusion for legal provisions that will stand out clearly for use by the Commission in the conduct of Referendum.

In early 2015 on the request of CRC the President of Sierra Leone extended the Mandate of the CRC till March 2016.
- 2. Lack of donor's interest in the process
- 3. Lack of resources for civic education on the draft report (constitution)
- 4. Lack of resources on post draft engagement with key stakeholders
- 5. Lack of commitment and resources for the conduct of the constitutional referendum

a. Updated project risks and actions

Project Risk 1: Time-lapse:

Actions taken:

During the height of the EVD Virus UNDP-led constitutional review project was able to consults several MDAs and Civils Society Organizations including State House, Ministry of Information and Communication, National Commission for Democracy and Ministry of Youth Affairs among others. Several technical training were conducted for all subcommittees to improve on knowledge sharing on the CRC Process.

Project Risk 2: Delay in the conduct of the referendum:

Actions taken:

Delay in the conduct of the referendum will result in to serious credibility and legitimacy issues. Referendum close to the election may also undermine the process and may politicize the draft constitution that has been achieved through national consensus.

To ensure that referendum is held on time, referendum related laws and regulations have been developed and processed for further legislation to the attorney general's office. In addition, a detailed budget was also developed for the government and donor's consideration. Moreover,

donors and stakeholders have been reminded time to time on the issue and encouraged their commitment in this regard.

a. Updated project issues and actions

Project Issue 1: Lack of donor's interest in the process:

Actions taken:

Due to overspending by the donors to deal with the EVD crisis and delay in the census process has lessened the traditional donor's interest in the constitutional review process. Several meetings have been held to encourage and highlight the importance of continuity and investment in the process for desired results and outcome.

Project issues 2 Lack of resources for Civic Education:

Current needs for the civic education and public consultations are much greater than anticipated in early project planning. Civic education on post draft report (constitution) is very crucial for the success of referendum and this has been highlighted to the donors during several engagement and meetings. A detailed proposal has been developed to discuss and share with donors.

Project issues 3: Post Draft Engagement Process:

Actions taken:

CRC draft will be submitted to the government of Sierra Leone in March 2016. Continuity of project is very crucial during 2016 and 2017 to continuously engage key stakeholders i.e. government, parliamentarians, political parties and NEC to ensure that draft report is processed to the parliament and debated thoroughly and transmitted by the president to the NEC for the referendum.

Any break in the process and in the project will lead to a serious delay and ambiguities in the process. A detailed proposal for the continuity of the project has been developed and discussed with donors.

V. Lessons Learned

- 1) So far project has achieved remarkable attention regionally and internationally. Inspite of EVD crisis the process manged to maintain the momentum and attract people attentions. Increased trust on the process has evident through the number of position papers and response forms that are submitted to the CRC.
- 2) The main lesson from the process is evident that during the project design project financing, local context and challenges have not been thoroughly considered which resulted in low funding. Moreover, for the successful outcome of constitutional processes in fragile countries more time and resources need to be allocated. However, in case of Sierra Leone the architects of the project have overlooked the fact which has resulted to serious challenges during the process.

VI. Conclusions and Way Forward

During January-June 2014 project gained remarkable progress towards its goal. However, outbreak of Ebola overshadowed the CRC process. During first and second quarter series of activities implemented that include civic education, national dialogue with key stake holders such as MPs, Political parties, Youth, Women and Paramount Chiefs on issues national importance.

The UNDP-led constitutional review project provided substantive technical support to the CRC which resulted sustaining of the process during EVD and later on in spite of lack of resources.

CRC plenary meetings are ongoing and process is on time to submit its report to the government of Sierra Leone in March 2016.

Referendum related legislation has been forwarded to the government and referendum budget is shared with donors and government.

UNDP will continue to engage donors and government on allocation of resources for the civic education on the draft report and conduct of the referendum.
