





Enhancing Climate Resilience of the Vulnerable Communities and Ecosystems in Somalia

Minutes of Project Board Meeting
12 December, 2016: UNDP Office, Mogadishu; Video Connections with UNDP Office,
Garowe and UNDP Office, Hargeisa

Agenda Item 1 - Opening Remarks and Introduction of the Participants:

Mr. David Akopyan, Deputy Country Director, UNDP-Somalia, co-chaired the meeting with the State Minister of Environment and welcomed the participants from the Federal Government, Federal Member States (South West, Galmudug, Jubaland and Puntland) and Somaliland to the Project Board meeting. In his opening remarks he stated that the Climate Change Resilience project is aimed to build coping capacities of the Somali communities to the impacts of extreme climate events. He emphasised on the need for shifting the focus towards development response to meet the emerging challenges due to climate change. He added that the climate and environment portfolio is expanding. As part of this expansion, UNDP foresee greater engagement and ownership of national partners. He then invited H. E. Said Haji Mohamud, State Minister of Environment, for the opening remarks.

H. E. Said Haji Mohamud, State Minister of Environment, Office of the Prime Minister, as co-chair on behalf of the government, appreciated UNDP support to Somalia. He highlighted the key priorities for the Federal Government and Member States. These include: 1) capacity building of institutions mandated to address issues of environment and climate change; 2) support for the Federal Government to negotiate with GEF for allocating resources from "System of Transparent Allocation of Resources (STAR)"; and, 3) support to the Office of Environment in the Office of the Prime Minister to regularly engage with Member States on issues relevant to environment. This was followed by opening statements from the Director General (Environment), Ministers and Director Generals from Member States.

<u>Agenda Item 2 - Presentation and Progress Update and 2017 Plan for "Enhancing Climate Resilience of the Vulnerable Communities and Ecosystems Project in Somalia":</u>

Mr. Abdul Qadir Rafiq, Project Manager, Environment and Energy, presented the background of the project and progress update on 2016 activities and plan for 2017. The presentation also covered the status of follow-up on the decisions of previous project board meeting held on 28 October 2016. He

informed the participants that the project consists of two components. Component 1 covers capacity development, awareness raising, policies formulation and strengthening institutions dealing with climatic disasters. Component 2 focus on building the capacities of communities in 8 districts to cope with cyclic droughts and floods. While covering the progress update, he mentioned that the on-ground implementation is progressing well in Puntland and Somaliland. Whereas, progress in 4 districts of Galmudg, South West and Hirshabelle States is slow because of delays in procurement process. Other activities with delayed implementation are the ones covering setting up of Agro-pastoral Schools and awareness raising activities in Southern States of Somalia. He also shared with the participants ongoing and pipeline projects that would help in upscaling the activities under the Climate Change Resilience Project. The delays in procurement processes has impacted on the financial delivery that stands at 61% against 2016 budget. Copy of the presentation is attached at Annex 2.

Mr. Akopyan opened the discussions with the need to have more interaction with the federal institutions, member states and other relevant stakeholders as part of drafting of National Climate Change Policy, Land Use Plans and Disaster Management Policy. He further highlighted the importance of looking into strategies for long-term solutions to minimise the impacts of droughts and floods.

Mr. Jonathan Brooks, Programme Manager, UNDP/PREP, flagged the need for assessing the impact of trainings and capacity development activities under the project as part of Mid Term Review (MTR). He added that expanding the project to new districts is impending discussions. Commenting on the land use plans, he highlighted the importance of taking these plans beyond the objective of having them climate compatible as land use plans need to be cross sectoral or multi-dimensional.

Dr. Mohamud Mohamed, Director General, Ministry of Agriculture, suggested to add timelines to the proposed activities for 2017. He also emphasised on the need to undertake activities beyond the policies support. Such activities could be water harvesting schemes, catchment management, groundwater development etc. These activities would be more beneficial for the communities and help in building their resilience to droughts and floods.

Mr. Abdulkani, Advisor, Ministry of Livestock, Forest and Range, raised the issue of capacity gaps in new member states. He recommended to allocate resources under climate change resilience project and other projects of UNDP to build the institutions dealing with environment and climate change in new member states.

Mr. Abdi Abokor Yusuf, Programme Officer, UNDP Somaliland, informed that in Somaliland government is leading the project implementation. He added that the project has helped in building strong link between the government institutions and local communities.

H. E. Dr. Ali Warsame, Minister of Environment, Puntland State of Somalia, highly appreciated UNDP/GEF support under the climate change resilience project. He informed the participants that the on-going drought is having devastating impacts on the local communities. 60% of Puntland is under severe drought conditions and the government is expecting international organisations to support humanitarian response. He added that the innovative techniques being promoted by the Climate Change Resilience Project, i.e., Sand Dams, Gullies Rehabilitation, climate action through Pastoral Communities and reforestation, are extremely relevant for minimising the impacts of cyclic droughts. He also informed the participants that Puntland Environment Law has been approved. This is the first Environment Legislation ever in any State of Somalia. He extended invitation to new member states

to learn from Puntland experience and also to set-up environment institutions that have similar capacities or structures as in Puntland.

Mr. Abdiwahab Ahmed, Director General, Ministry of Water and Energy, said that the resources under the project are limited and there is need to have more funding to build on this project. He added that having schemes to provide safe water to the local communities is essential and should be supported by the project. He questioned on the linkages of the project with the National Development Plan.

Mr. Abdirashid, Environment Expert, Office of Environment, Office of the Prime Minister, commented that the needs of new member states should be assessed so that resources for the capacity development are utilised as per states priorities.

Responding to the points raised by the participants, Mr. Abdul Qadir confirmed that the project is evolving and has opened discussions with the Member States and national institutions, such as, SDMA. He added that the presentations for the next board meetings will include the timeline and targets. He also informed the participants that the project contributes to the National Development Plan and the Sustainable Development Goals. He also informed that the MTR will help in assessing the results achieved in first two years of implementation and recommend re-focus as per new realities for the larger impact of the project.

Agenda Item 3 - Summary of Decisions by the Chair:

Summing up the key points raised by the participants, Mr. Akopyan summarised the following decisions and action points:

- 1. Mid-term review to look into the possibilities of scaling up project activities for wider impact.
- 2. There is a need to keep a balance between policies and on-ground actions, particularly, for the benefit of new member states.
- Have a visual presentation with pictures from on-going activities. This should help the board
 members to get some idea of on-going activities with the communities in different parts of
 the country.
- 4. The presentation to the next board meeting to include timelines and achievement against annual targets. Project Board endorsed the proposed plan for 2017.
