## **1. SITUATION ANALYSIS**

The first case of corona virus in Somalia was reported on 16th March 2020. Since then, the number of cases has continued to rise. As of 8<sup>th</sup> May 2020, there were a total of 928 laboratory confirmed COVID-19 cases and 42 deaths reported in Somalia<sup>1</sup>. After a handful of initial cases related to travel, community transmission now accounts for the vast majority of cases<sup>2</sup>. With almost non-existent detection and prevention facilities, the impact of COVID-19 in Somalia is likely to be significant, particularly on the already impoverished population groups which could result in an increasing number of youths being drawn to violent extremism. Concerns remain over the possible spread of the virus to some 2,000 congested IDP settlements where social distancing is impossible and adherence to infection prevention control measures is challenging.

In response to COVID-19, the Federal Government of Somalia (FSG) has put in place several measures including closure of schools, suspension of domestic and international flights, overnight curfew and restrictions of mass gatherings. The Government established a National COVID-19 Task Force and designated \$5 million for COVID-19 response. In addition, noting the socioeconomic impact of COVID-19, the Government has announced tax relieve measures to prevent price hikes on basic foodstuffs during the crisis. Further, the Government has sought emergency international financial and technical aid to confront the economic and health challenges of COVID-19.

If the crisis persists and the measures put in place by the Government continue, many people will find themselves unable to provide for their families as economic activities and business interactions are negatively impacted. This leads to the risk of youth, women and IDPs losing their livelihoods. It is estimated that there will be a decline of 35% of exports, 20% of imports, 10% of household consumption and 15% of gross capital formation<sup>3</sup>. While the economy in its entirety will be impacted, specific sectors including education, aviation, hospitality, trade, agriculture and retail are likely to be hit in particular. Employment both in the public and private sectors are also expected to decline in the medium to long run. This will almost certainly have a differentiated impact by gender, with women more impacted than men.

To support the national efforts, the UN system in Somalia has put in place several structures, including the Emergency & Crisis Management Team (ECMT) and the Humanitarian Country Team (HCT). To take forward it's support in a coordinated manner, the UNCT has developed a Country Preparedness and Response Plan (CPRP) which outlines immediate/short-term humanitarian response actions as well as actions aimed at ensuring socio-economic response

and recovery in the medium to long-term. Within these structures and in taking forward the CPRP, a division of labour has been agreed to in which WHO is leading on the immediate response and functions as the technical lead in providing guidelines and specifications for necessary medical equipment and supplies, OCHA is leading on humanitarian response, while UNDP is leading on awareness creation and communication as well as on socio-economic response and recovery.

UNDP Somalia is adopting a **coordinated approach** to its support, with the National COVID-19 Task Force serving as the entry point for all support/interventions The Country Office has adopted a number of strategies including: i) **reprogramming and rephasing** existing projects to identify activities and funding which would be reprogrammed, and identification of new initiatives within the respective projects in response to COVID-19; ii) identifying existing projects to serve as **entry points for response and recovery initiatives on COVID-19**, particularly on socio-economic recovery; iii) **resource mobilization** from various streams to complement existing resources in support of national COVID-19 response initiatives; and iv) ensuring **continued functionality** of government entities to facilitate implementation of key national priorities. The Country Office adopts a number of **key guiding principles** targeting the most vulnerable populations and marginalized areas (reaching the 'unreached); enhancing equality and ensuring no one is left behind (targeting those farthest left behind); ensuring alignment to national strategies, plans and structures; and factoring in sustainability strategies. Furthermore, the Country Office strategy has been divided into short, medium- and long-term initiatives.

Key interventions linked immediate/short-term priorities are already ongoing. These measure include: awareness raising and communication on COVID-19; advocacy for release of low risk prisoners to decongest the prisons in Puntland, Central Prisons in Mogadishu and Somaliland to mitigate any potential outbreaks in these facilities; provision of WASH facilities in collaboration with the COVID 19 Detention TASK Force<sup>4</sup> of the UN for prisons and police to facilitate practicing of hygiene measures in line with WHO guidelines; monitoring of SGBV cases anticipated to increase due to COVID-19 related impacts (loss of livelihoods, lockdown and related stress); and provision of VTC facilities to facilitate functioning of key government entities in line with COVID-19 restrictions.

**Prepare:** UNDP will support countries to strengthen their health systems, including by helping them procure much-needed medical supplies, use digital technologies, and ensure health workers are paid.

**Respond:** UNDP will support a whole-of- government and whole-of-society response by working across key sectors to slow the spread of the virus and to provide protection for vulnerable populations.

**Recover:** UNDP will support countries to assess the social and economic impacts of COVID-19 and undertake urgent recovery measures, especially for poor and marginalized groups.

The initiatives/activities will be implemented though direct implementation modality (DIM), where the UNDP Somalia country office through technical inputs from various staff, will be overall responsible and accountable for the management of resources and the achievement of results. Government partners will be engaged as responsible parties (RPs) through Letters of Agreement (LOA), to allow for the delivery of specific project outputs with specified results as outlined in the

LOA. Programme staff in UNDP Somalia will serve as focal point for delivering the defined outputs/activities and providing technical guidance to RPs under the overall direction of the Resident Representative.

Technical and advisory support for specific initiatives such as the socio-economic impact assessment/study, will be sought from relevant UNDP units/departments including the GPN network, BPPS, BERA and the Regional Hub as need be.
