Preface

According to the scope of services for the project and beforehand agreed with the Client, an Inception Report shall be prepared by the Consultant. The Inception Report is aimed to include a brief overview of the project, a detailed planning of the activities and its methodology, the project implementation period as well as the project time schedule. The Inception Report shall also contain a summary of design criteria, industry standards and codes of international or local practice.

Background and Context

The importance and the roles statistics plays to enhance the overall development of Somalia can not be over-emphasized as data is required at all levels for measuring progress of development. It is consequently essential to fill in gaps in data provision, develop effective data systems and standards in data production, and to create a uniform development across the various statistical systems. It then becomes critical for Somalia to address to strengthen the National Statistical System (NSS) and allow it to operate in an integrated and coordinated manner.

The stratgic route to take is in developing and strengthening the strength and infrastructure of The National Bureau of Statistics, which was established under the Somalia Statistical Act. Following the passing of the act, there is a need to develop policies and regulations that are in line with and make operational the mandates set out in the Statistical Act. These regulations would need to be drawn out from the Statistics Law and international standard and practices.

Objectives and Deliverables

The objective of this consultancy is to work with National Statistics Bureau to:

- Develop regulations that supports the DNS transformation to SNBS (Develop regulations and procedures from the Statistics law on how to select the board members and develop the TORs of the Director General and his Deputy of the Bureau.
- Achieve organizational and institutional development, e.g selection criteria of the National Statistics Staff;

The deliverables, per the TOR, include:

- Draft regulations for the implementation of the Statistics Bill in anticipation of enactment of the Bill as legislative drafting instructions for the SNBS.
- Draft regulations for SNBS both Somali and English
- Progress reports on the Act regulations
- Consultant's end of assignment report to guide development of complementary mechanisms

Project Period
