However, the project also assist all national partners to set up their administrative structures and to actively engage in the constitutional review process. The project provides capacity development initiatives to the duty bearers and support them in conducting consultations and public outreach for them to claim their rights.</p>

<p>The project is supporting the duty bearers in identifying areas where expertise is needed and, consequently, drafts Terms of Reference (ToR) for the experts to be hired. The vacancy announcements explicitly include a Gender Mainstreaming clause, whereby the duty bearers announcing the job commits to being an equal opportunity employer and qualified women are strongly encouraged to apply. The project promotes inclusion of women and gender mainstreaming in capacity building activities the project endeavors for the inclusion of women at every stage of the project. The project collects gender- and age-disaggregated data to aid sound decision making and programming, and to maximize benefits for target groups.</p>
