### **Executive Summary**

This marks the end of the project initiation phase of the "evidence for economic and social transformation of South Sudan" and the start of a fully-fledged project on "Managing Development for Peace and Prosperity in South Sudan". The project document continues to be aligned to achieve "Output 2.2 National data collection, measurement and analytical systems are enabled to monitor and report on national development and sustainable development goals" of the Country Programme Document.

The main achievements of the project are clustered in 4 areas:

- National policy debates: launched the national, continental and global human development reports together with policy dialogues attracting key policy makers. For example, the national human development focuses on pathways to peace and prosperity, while the Africa Human Development in partnership with UNWOMEN highlighted the need for sex-disaggregated data and gender analysis as a critical gap in articulating pathways to accelerating gender equality.
- 2. **UN System coherence:** The project initiated a UN task team and the UNCT agreed to jointly deliver an inaugural Sustainable Development Goals for South Sudan and allocated up to US\$30,000 to deliver it.
- 3. **Development cooperation effectiveness:** the project developed and rollout a course on Economics for Public Sector Managers as a tangible way to improve public service delivery in partnership with University of Juba.
- **4.** Thought leadership: the completed 21 edited essays from university students on how the Agreement on the Resolution of Conflict in South Sudan will help achieve the global goals on Sustainable Development. In addition, the Weekly Media Digest and the Weekly Management Update continued. Furthermore, a thought leadership series was initiated as well as blogs on topical issues.

No new risks were identified in the conduct of the project and no changes made to the original design. The total expenses for the project in 2016 was US\$ 605,490.66 and the total so far is US\$ 885,490.66.

# 1. Situational background

The economic outlook remains difficult and the development narrative as reflected in the media rather negative. The economic outlook for the Country is largely due to fiscal challenges associated with a reduced oil revenues and the slow implementation of economic and fiscal reforms. The impact of this has been significant increases in commodity prices as measured by the Consumer Price Index with inflation in triple digits for the thirteenth month in December 2016 that is largely driven by changes in foreign exchange rate. The economy remains undiversified and the impact of thirteen months of triple digit inflation remains to be determined.

The purpose of this project is to make data and analysis available to inform policy dialogue that will shape the narrative in the nation towards peace and prosperity, and influence the design and implementation of policies. The strategy has three components. First, make available data and analysis to inform policy dialogue – while at the same time leveraging tools and systems designed within the framework of Sustainable Development Goals and Africa Agenda. Second, use the data and analysis to organize policy dialogues that will the narrative towards peace and prosperity. Lastly, strengthen the design and implementation of policies that create a predictable environment for the conduct of public and private business, as well as create incentives for peace. The ambition is to bring about transformation through evidence, conversation and positive influence respectively. This will facilitate the realization of peace dividends where the citizens conduct their business in a predictable manner and therefore creating disincentives for perpetuating conflict.

The strategy contributes to the realization of the UNDP Country Programme document and to the UNDP Strategic Plan. With regard to the Country Programme Document, the strategy address "*Output 2.2: National* 

data collection, measurement and analytical systems are enabled to monitor and report on national development and sustainable development goals". The expectation is that the data used in national development reports meets the minimum standards of quality in terms of consistency, accuracy, timeliness and completeness; and the development reports (e.g. on human development, economic outlook, and sustainable development goals) inform policy dialogue and strengthen policy design and implementation. The project strategy also contribute to the realization of UNDP Strategic Plan - "Outcome 7: Development debates and development actions at all levels prioritize poverty, inequality and exclusion, consistent with our engagement principles". The outcome indicators of greatest relevance are: the number of countries integrating and adapting the post 2015 agenda and sustainable development goals into national development plans and budgets; and the number of countries with post-2015 poverty eradication commitments and targets (See Annex 1).

**Data and analysis:** The ultimate goal is transformation through evidence. Data disaggregated according to sex, age, time, and geography is assembled in an accessible format. It is then used to undertake analysis along the dimensions of gender analysis, intergenerational, temporal, and spatial. And finally, the focus will be on measuring and explaining outcomes the desired changes. The key deliverables will be:

- Weekly basis: Media Digest, and Development Updates,
- Monthly basis: Development statistics, and Public policies,
- Ad-hoc basis: vulnerability analysis, media content analysis, and fiscal space analysis
- Flagship: Development Pulse a gauge of the development narrative

**Policy dialogue:** The ultimate goal of policy dialogue is transformation through conversation, and what systematic evidence-based dialogue does is enable conversation that shapes development narrative not just that one of today but of generations to come with a clear focus on shaping the narrative towards peace and prosperity. Specific aspirations will guide the policy dialogues, notably: Sustainable development, Human development, Economic prosperity, and Peace. The key deliverables will to the extent possible shape the narrative towards peace and prosperity. These include:

- Monthly basis: Policy Dialogue Forums,
- Quarterly basis: Though Leadership Series
- Annual basis: Sustainable Development Report, African Economic Outlook Country Note
- Biennial basis: Human Development Report

**Design and implementation of policies:** Strengthening the design and implementation of policies is to create a predictable business environment as well as creating incentives for peace. It is about transformation through positive influence. Three elements guide this component:

- Integrated coaching for national institutions;
- Access to design and implementation of policies; and
- Critical knowledge and expertise.

Key deliverables include:

- Integrated Coaching in specific critical areas of national macroeconomic, development planning as well as foreign and domestic policy;
- Public Policy Dashboard focusing on the availability, design and extent of their implementation.
- Making available critical knowledge and expertise in creating and maintaining fiscal space, development effectiveness and the use of the economic language in the execution of public policy.

#### 2.3 Human Interest Story

Students (mainly youth) from major universities in South Sudan have picked interest in promoting the SDGs in the country. A total of Five hundred and ten students who participated in the SDG awareness and engagement workshops registered with SSuNDE as volunteers to promote the SDGs and support SSuNDE's work on these global goals. About 30 of these Volunteers worked alongside SSuNDE program staff on data entry and analysis.
