The project seeks to integrate the overarching principles of human rights which entails, participation, accountability, non-discrimination and empowerment of individuals and institutions about ensuring that standards and principles of human rights are integrated into policy making and frameworks. Considering the country context, human rights-based approach is critical in ensuring fairness in the implementation of policies, administrative procedures and mechanism. To this end, the project through the new Country Programme Document (CPD 2019-2021) recognizes human rights as a prerequisite for prosperity and inclusive development in terms of duty bearers and rights holders in the delivery of public services ensuring quality of capacity building, coaching and mentoring.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

South Sudan is a very traditional society where cultural and institutional constraints prevent women from the right to play an effective role in the development. Empowerment remains largely a serious concern for the majority of South Sudanese women. To address this gender disparity, the Support to Public Administration project promote women participation in public life and their representation in the legislative and executive organs by at least thirty percent as an affirmative action to redress imbalances due to customs, and traditions. The project will continue to work with the Ministry of Gender, Child and Social Welfare.
