The project strengthens the availability, accessibility and quality of HIV prevention and Care and treatment services for affected and vulnerable population. People living with and affected by HIV are effectively involved in project implementation as well as project oversight decision making through the CCM.

The project incorporates age and sex-disaggregated data in relevant indicators. In addition, the project has specific interventions targeted at women and female sex workers, a population with a documented HIV prevalence in South Sudan. The project provides for supporting resilient and sustainable health systems to ensure proper handling and disposal of medical waste and hazardous materials.
