# Support for Capacity Strengthening of the Parliament of Suriname to Undertake its Functions regarding Law-Making and Oversight

# 1. Introduction and Background:

Suriname is a democracy based on a Constitution which was established in 1987. After two military coups, the first one in 1980 (with the military's rule lasting up until 1987) and the second one in 1990 (with the military rule lasting one year), the country has fully returned to the democratic fold. Most recently, elections were held in Suriname on 25 May 2010 and according to reports from the Electoral Observation Mission of the Organization of American States and the local media, elections were conducted in a peaceful and harmonious manner.

An efficient, effective, knowledgeable and productive parliament is critical to the existence of a viable democracy and an open society. Such institutions are critical to the establishment and consolidation of democracy because they empower ordinary people to participate in the policies that shape their lives. Parliaments are fundamental to establishing the rule of law, protecting human rights, overseeing transparent governance processes, and ensuring national compliance with international obligations<sup>1</sup>. Parliaments are established to guide and critically follow the work of the Government.

It is therefore that the parliament would like to implement a programme aimed at institutional strengthening of its functioning, so as to be able to effectively exercise its oversight and governance

functions, but also to strengthen its capacity to guide the government based on international developments.

The Parliament of Suriname and UNDP have worked together in the past and with that fruitful collaboration in mind, UNDP engaged in discussions with the Speaker of the recently-elected Parliament on the framework for a full, multi-year project for strengthening the capacity of Parliament to undertake its law-making functions. This project which aims to strengthen one of the critical governance institutions in Suriname is fully consistent with the Government's Multi-Annual Plan and is critical for achieving the Millennium Development Goals in Suriname.

This Initiation Plan and the full project to be formulated are in line with the current United Nations Development Assistance Framework (UNDAF 2008 - 2011) signed between the Government of Suriname and the United Nations and will contribute to UNDAF Outcome 2: *By the end of 2011, good governance through decentralized participatory planning and monitoring, legal reform and effective protection.* 

This Initiation Plan is implemented to cover preliminary activities that need to be undertaken while the full project document is being discussed and subsequently finalized for signature with the Government of Suriname.

#### 2. Activities to be implemented under this Initiation Plan

- 1. Assist the Parliament with the organization of a series of briefing/learning sessions on a wide range of topics which are critical in the development of Suriname. The Parliament and UNDP have already agreed on topics such as Climate Change, Housing, and Entrepreneurship, and others will be identified for implementation in 2011 to build the substantive capacity of the Members of Parliament and inform their deliberative functions. UNDP's assistance in this regard entails partnering with the Parliament to design a programme for the briefing/learning sessions, making use of the UNDP's network of local and international expertise and knowledge products to inform the Parliamentarians; and also providing financial assistance if requested for the organization of these sessions.
- Preparation of policy briefs on topical issues for use by Parliamentarians on external missions; ad hoc briefings to groups of Parliamentarians; technical assistance to support ratification of International Conventions and other legal instruments; technical inputs for drafting key legislation to be voted on by Parliament.
- Training of Officers and the Staff of Parliament inter alia, in information technology, strategic planning, parliamentary reporting, legislative drafting, English and Dutch language skills, and support for capacity building of Officers and Staff of Parliament through external training and study visits.
- 4. Finalize formulation and signature of the full Project Document.

# 3. Duration of the Initiation Plan

As indicated in the POPP, the Initiation Plan will not exceed one year. The above activities will be implemented during the initiation phase which will end 90 days (or earlier) after signature of the document. These activities will be included within the full project document for implementing the project which will commence as soon as all parties have agreed and signed the project document.

# 5. Management and Implementation Arrangements

The activities under this project fall under Annual Work Plan (AWP) 1 – Policy Planning and Monitoring, signed between the Government of Suriname and the UN agencies on 22<sup>nd</sup> March 2010. Activities under this IP phase will be funded out of UNDP/TRAC resources. The activities will be implemented by UNDP in close collaboration with the Parliament of Suriname according to UNDP implementation guidelines. UNDP will undertake actions such as identification, recruitment and payment of consultants; organize briefing sessions; prepare briefing documents; organize training for Officers and staff of Parliament; and undertake other agreed capacity strengthening activities based on requests from the Parliament.
