The course of the meeting:

Mr. **Tojiddin Jurazoda** welcomed guests and expressed gratitude to the Government of the Russian Federation and UNDP Tajikistan for the support and productive collaboration. He outlined the importance of this partnership aimed at implementation of National Development Strategy (NDS) and Mid-term development (MTD) program to nationalize and localize SDGs. He noted that this year MTD program is coming to the end and MEDT is in the process of analyzing NDS first phase results and identification of country priorities for the coming years.

Mr. Jurazoda outlined the importance of jointly implemented initiatives that forwarded at solving socioeconomic problems and making a notable contribution in achieving the strategic goals of the country. He mentioned key results of the project implemented in Zerafshan Valley that putt strong emphasis on promoting employable skills and developing capacities for better local employment, with a particular focus on women and youth. As well he introduced everyone with the new project to be implemented in Khatlon Region and Rasht Valley where jobs and skills development embedded as key part.

Deputy Minister handed the floor to Mr. Igor Lyakin-Frolov, Extraordinary and Plenipotentiary Ambassador of the Russian Federation to the Republic of Tajikistan.

Mr. **Igor Lyakin-Frolov** the welcomed participants of the meeting. He emphasized special relations of Tajikistan and the Russian Federation, partnership of the two countries that established robust cooperation within the framework of bilateral relations forwarded on economic development.

Mr. Lyakin-Frolov mentioned about monitoring visit of Russian delegation to projects sites implemented in Khatlon region, results of the meeting with project beneficiaries on project effectiveness.

He highlighted that for the last year Russian Federation funded five projects with a total budget of more than \$ 5 million. H.E. Ambassador of the Russian Federation to Tajikistan informed about the launch of new initiative on strengthening communities in Khatlon and Rasht regions on \$ 1.85 million.

He outlined that currently, the Russian Federation pays attention to supporting business and innovation for young people where application of the Russian experience in Tajikistan may be useful, climate change in the agricultural, water and tourism sectors development.

The floor was handed to Ms. **Pratibha Mehta**, UNDP Resident Representative in Tajikistan.

Ms. **Pratibha Mehta** welcomed the participants and thanked the Government of the Russian Federation for their cooperation and financial support in the implementation of projects aimed at developing entrepreneurship, innovative ideas, and facilitation in the creation of new employment opportunities for vulnerable people.

She recalled UNDP and Russian Trust Fund collaboration that started since 2014 for addressing poverty in remote areas, empowering women and youth, strengthening disaster risk preparedness, and climate change adaptation.

UNDP Resident Representative indicated the press-conference results dedicated to the joint project; several success factors outlined by stakeholders; importance of ensuring continuity of business skill development and mentoring support for the entrepreneurs in rural areas.

Ms. Pratibha Mehta outlined about the new project which will continue the partnership approach to support vulnerable rural communities in Rasht and Khatlon regions and improve employability and agribusiness through innovative solutions.

Comment, Mr. Alexander Averchenkov: Ensure that project financial performance has disaggregated data of every stakeholder input.

Ms. Karina Burykh shared experience of Business School in Khuhistoni Mastchoh where they faced with challenges of attracting women in capacity building activities which was a new experience. She highlighted importance of continuation of these joint initiatives in the rural areas, suggested organizing more events such as study tours and platforms for networking between young people and experienced entrepreneurs in future projects.
