Result 1: Designed a new model of inclusive community-based services for children at risk of separation from parents, children without parental care, children with disabilities, youth at risk, women facing gender-based violence, people with disabilities and older persons in need of support with basic everyday care by piloting a community-based social worker model engaged in identification, assessment and case management as well as piloting specialized social services to meet specific needs and support people to live independent lives in their communities.

Result 2: To support drafting of legislative amendments and other institutional framework (standards, service specifications), develop a mechanism for social contracting, and improve a social work curriculum to ensure sustainability of the proposed model.

• The Cabinet of Ministers endorsed funding for the 45 social work specialists from the 2022 state budget. Technical support was provided to the Ministry of Labour and Social Protection and the Ministry of Finance and Economy to prepare the briefing notes on the proposed Social Service model, on the international experience with regards to budgeting source as



well as the functions and placement of the social service specialists within the structure of the Ministry of Labour and Social Protection.

- The Draft new Law on Social Services together with the Amendments to the Social Code is being reviewed by the Working Group of relevant ministries and agencies established by the Parliament of Turkmenistan. A package of bylaws is planned to be developed starting from the end of 2021. It is expected that the new Law on Social Services, secondary legislation will be adopted and approved at the national level by the end of this year.
- The methodology and instruments for the economic analysis of new and existing social services have been agreed with the MLSP. The actual analysis is to start in October 2021 and finish in February 2022.
- Child Protection System Assessment was launched in July 2021 for the functional overview of service delivery and establishment of the relationship of the social protection structure with child protection statutory bodies, including the guardianship and trusteeship authorities and the commission on minors.
- 12 specialized social services were fully launched, piloting the new services for the children at risk of separation from parents or without parental care, children with disabilities, youth at risk (including adolescent girls, graduates of residential care institutions, and those in conflict with the law), women facing gender-based violence, families with substance use abuse, people with disabilities, and older persons in need of support with basic everyday care. Capacity building seminars and trainings were conducted for the service providers in the capital and two pilot regions on each of the specialized social service. A joint session of social work specialists from 20 districts with the representatives of UNICEF, UNDP, UNODC, UNFPA, and the respective specialized social service providers was conducted to discuss the criteria and referral mechanism to the new specialized social services and future cooperation between the primary social service providers at the social work specialists level and the specialized social service providers represented by governmental and non-governmental entities.
- Social contracting mechanism is being successfully tested by non-governmental social service providers selected through a competitive small-grants award process to pilot three new specialized social services to people with official status of disability, elderly people living alone and people with chronic illnesses. Three pilots under the social contracting mechanism were registered with the Ministry of Adalat (Justice) of Turkmenistan.
- A sample package of documents was prepared for the specialized service providers to be completed by the end of the pilots, including the standards, specification, statutory document;
- The first round of online Training-of-Trainers course on building core competencies in the field of social service and social work as fundamentals of teaching disciplines of the Bachelor programme in "Social work" started for the theoretics and practitioners representing four higher education institutions, social workers of the MoLSP, Academy of Civil Servants, and NGO. The TOT training combined the online course with the Columbia University (New York) School of Social Work, and face-to-face trainings on the Fundamentals of social work conducted by UNICEF national trainers
- The online and in-person training programme for all stakeholders has been successfully completed by October 2021. Some national trainers continue their educational activities in the social services area as part of other UN projects in Turkmenistan.
