

**Addendum No. 1 to the  
Standard Administrative Arrangement  
between  
Irish Aid  
and  
the United Nations Development Programme**

**Irish Aid** (hereafter referred to as the “Donor”), and the United Nations Development Programme (hereinafter referred to as “UNDP”) acting as Administrative Agent of Joint Programme “Local Governance Support Programme (LGSP) in Timor Leste” on behalf of itself and all the Participating UN Organizations, (hereinafter referred to as the “Administrative Agent”) have agreed as follows:

Whereas in Section I, paragraph 1 of the Standard Administrative Arrangement signed between the Donor and the Administrative Agent (hereinafter referred to collectively as the “Participants”) on 30 September 2010, the Donor committed itself to make a contribution of **Seven Hundred Fifty Thousand Euros (EUR 750,000)** “and such further amounts as it may decide”.

The Donor has now agreed to make a further contribution to the Joint Programme “Local Governance Support Programme (LGSP) in Timor Leste”

The Standard Administrative Arrangement between the Participants is therefore modified as follows:

Section 1 paragraph 1: The Donor agrees to make an additional contribution of **Three Hundred Thousand Euros (EUR 300,000)**, in accordance with the schedule of payments set out below:


