



**TRANSFER OF TITLE OF ASSETS FROM
THE UNITED NATIONS DEVELOPMENT PROGRAMME
TO THE GOVERNMENT OF TIMOR-LESTE**

THIS AGREEMENT made this 16th day of October, 2009, by and between the United Nations Development Programme (hereinafter referred to as “UNDP”), for the transfer to and the Government of Timor-Leste (Secretariat of State for Social Assistance and Natural Disasters, Ministry of Social Solidarity– NDAS/MSS) (hereinafter referred to as the “Government”), accepts full title and ownership of assets (3 computers) as specified in the attached supplies and equipment list, hereto as Annex I at a total cost of 3,085 USD.

The assets transferred represent assistance of UNDP to the Government to support the training on the database for Social Reintegration package undertaken in Timor-Leste. The transfer of title is limited to the use of such assets solely for the stated purposes of NDAS.
