

**AMENDMENT N4 OF UN AGENCY CONTRIBUTION AGREEMENT SIGNED  
BETWEEN THE UNITED NATIONS POPULATION FUND (UNFPA) AND THE UNDP**

Reference is made to the UN agency to UN agency contribution agreement (hereinafter "Agreement") dated August 28, 2017 signed between the United Nations Population Fund (UNFPA), and the United Nations Development Programme (UNDP), with respect to the Program "Joint Global Programme on Essential Services for Women and Girls Subject to Violence", and as per Article H of the Agreement, any modification to this agreement including its Annex(es), may be modified or amended only by written agreement between the two Agencies.

Reference is also made to the amendments of the said Agreement in order to extend the end date of the activities to December 31st, 2018 then to November 30, 2019 between the United Nations Population Fund (UNFPA), and the United Nations Development Programme (UNDP)

Therefore, parties hereby agree on the following:

WHEREAS the UNFPA and UNDP now wish to amend the said Agreement in order to extend the end date of the activities until November 30, 2020.

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

**A- Summary of activities**

**Title:** Provide trainings and equipment for the specialized units in the police and national guard services on support to women victims of violence (activity under project "Soutien à la Réforme du Secteur de la Sécurité en Tunisie").

<b>Start/End Dates:</b>	Activities start date: January 1 <sup>st</sup> 2020
	Activities end date: November 30, 2020

**B- Budget**

The total budget for the Activities is 1850 in USD, as more fully described below.

**D- Reporting**

***Narrative reporting:***

The Recipient Agency will provide the Contributing Agency with a narrative report on the progress of the Activities on a regular basis, as set out below.

- Interim narrative report due one month after the end of each activity;
- Final narrative report including an interim expenditure report as at November 30<sup>st</sup>, 2020 when all activities are completed.

***Financial Reporting:***

The Recipient Agency will provide the Contributing Agency with the following financial reports, prepared in accordance with the Recipient Agency's financial regulations, rules, policies, procedures, and administrative instructions:

- Interim final financial report due on November 30, 2020.
- Final Certified financial report due on June 30, 2021.
