AMENDMENT OF UN AGENCY CONTRIBUTION AGREEMENT SIGNED BETWEEN THE UNITED NATIONS POPULATION FUND (UNFPA) AND THE UNDP

Reference is made to the UN agency to UN agency contribution agreement (hereinafter "Agreement") dated August 28, 2017 signed between the United Nations Population Fund (UNFPA), and the United Nations Development Programme (UNDP), with respect to the Program "Joint Global Programme on Essential Services for Women and Girls Subject to Violence", and as per Article H of the Agreement, any modification to this agreement including its Annex(es), may be modified or amended only by written agreement between the two Agencies.

Reference is also made to the amendments of the said Agreement in order to extend the end date of the activities until December 31st, 2018, signed in September 2017, between the United Nations Population Fund (UNFPA), and the United Nations Development Programme (UNDP)

Therefore, parties hereby agree on the following:

WHEREAS the UNFPA and UNDP now wish to amend the said Agreement in order to extend the end date of the activities until November 30, 2019 and transfer an additional contribution of an amount of 30 996\$.

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

A- Summary of activities

Title: Provide trainings for the specialized units in the police and national guard services on support to women victims of violence (activity under project "Projet d'appui à la prévention, à la préparation et à la réponse aux crises en Tunisie") and organise consultation with parliamentarian academy after 1 year of the entry into force of the law 2017-58 on violence against women.

Start/End Dates:

Activities start date: January 1st 2019 Activities end date: November 30, 2019

B- Budget

The total budget for the Activities is 30 996 in USD, as more fully described below.

Narrative reporting:

The Recipient Agency will provide the Contributing Agency with a narrative report on the progress of the Activities on a regular basis, as set out below.

- Interim narrative report due one month after the end of each activity;
- Final narrative report including an interim expenditure report as at December 31st, 2018 when all activities are completed.

Financial Reporting:

The Recipient Agency will provide the Contributing Agency with the following financial reports, prepared in accordance with the Recipient Agency's financial regulations, rules, policies, procedures, and administrative instructions:

- Interim final financial report due on November 30, 2019.
- Final Certified financial report due on June 30, 2020.

E- Contributions

The total amounts paid by the Contributing Agency shall match the total budget amount. For Activities less than one year in duration the Contribution will be paid to the Recipient Agency prior to the commencement of Activities.

Upon signature, but no later than May 15, 2019

The Contributing Agency acknowledges that the Recipient Agency will not pre-finance Activities. If the Contribution, or any part of it, is not received in a timely manner, the Activities may be reduced or suspended by the Recipient Agency with immediate effect.
