

**AMENDMENT No. 3 TO THE COST SHARING AGREEMENT
BETWEEN
THE UNITED NATIONS DEVELOPMENT PROGRAMME (“UNDP”)
AND
LİMAK EĞİTİM KÜLTÜR VE SAĞLIK VAKFI (LİMAK FOUNDATION) (“DONOR”)**

Reference is made to the Third-Party Cost-Sharing Agreement, entered into force on 27/06/2016, by and between the UNITED NATIONS DEVELOPMENT PROGRAMME (“UNDP”), and LİMAK EĞİTİM KÜLTÜR VE SAĞLIK VAKFI (LİMAK FOUNDATION) (the “Donor”), and together with UNDP, the “Parties”, and to its Amendment No. 2 (hereinafter all together referred to as the “Agreement”).

WHEREAS the Agreement provides that any modification thereto shall require an amendment in writing between the Parties, duly signed by the authorized representatives of UNDP and the Donor.

WHEREAS Donor/UNDP has requested, and Donor/UNDP has agreed to amend the Agreement in order to revise the payment schedule of the Turkey’s Engineer Girls Project (Project No. 00101250), while the total contribution amount remain intact;

NOW THEREFORE, the Parties agree:

1. The relevant provision indicated below are hereby amended as follows:

(a) Article 1 “The Contribution – Schedule of Payments” of the Agreement is hereby amended in its entirety to read as follows:
