

**AMENDMENT No. 5 TO THE COST SHARING AGREEMENT  
BETWEEN  
THE UNITED NATIONS DEVELOPMENT PROGRAMME (“UNDP”)  
AND  
THE ANADOLU EFES BİRACILIK VE MALT SAN. A.Ş. (“DONOR”)**

Reference is made to the Cost Sharing Agreement, entered into force on 21/01/2013, by and between the UNITED NATIONS DEVELOPMENT PROGRAMME (“UNDP”), and the ANADOLU EFES BİRACILIK VE MALT SAN. A.Ş. (the “Donor”), and together with UNDP, the “Parties”, and to its Amendments No.1, No.2, No.3 and No.4 (hereinafter all together referred to as the “Agreement”).

**WHEREAS** the Agreement provides that any modification thereto shall require an amendment in writing between the Parties, duly signed by the authorized representatives of UNDP and the Donor.

**WHEREAS** Donor/UNDP has requested, and Donor/UNDP has agreed to amend the Agreement in order to contribute to development of sustainable community based tourism with additional funding, technical support and knowledge sharing activities and improve the sustainability and impact of the project through conceptualization and implementation of multi-year regional sustainable tourism development initiatives in select destinations based on a regional multi-year and multi stakeholder approach and extend the duration of the project till 31.05.2024, in line with the revised Annual Work Plan of the “Implementation of the Future Lies in Tourism Support Fund” Project (Project No. 85037).

**WHEREAS** the Amendment will result in an increase of TRY 1,328,400.00 (equivalent to USD 139,392.00 based on UNORE Nov-2021) making this Agreement total USD 1,528,094.00.

**NOW THEREFORE**, the Parties agree:

(1) The relevant provision indicated below are hereby amended as follows:

(a) *Article 1 “The Contribution – Schedule of Payments” of the Agreement is hereby amended in its entirety to read as follows:*


