



## TUVALU COASTAL ADAPTATION PROJECT PROGRESS BRIEF AS AT 30 September 2020

### SUMMARY NARRATIVE BY OUTPUTS

# Output 1 Strengthening of institutions, human resources, awareness and knowledge for resilient coastal management.

- Negotiations with SPC on providing a comprehensive training package for our government partners in Tuvalu is ongoing. SPC will deliver hands on training in coastal hazards, coastal management and coastal adaptation. This training is essential for the project, as it is one of indicators and targets for Output 1.
- Discussions underway with Scholarship awardees to contact their institutions for online courses in 2021 until such time that covid-19 travel restrictions are relaxed

# Output 2 Vulnerability of key coastal infrastructure including homes, schools, hospitals and other assets is reduced against wave induced damage in Funafuti, Nanumea and Nanumaga.

- Tuvalu PMU staff visited Nanumaga to do consultations with the Nanumaga island community. The
  purpose of the visit is to discuss the Gender Strategy and Action Plan with different community
  groups on the island. The team also took 2 drone pilots from the Department of Lands to take aerial
  imagery of the project sites. Secondly, the Falekaupule agreed to give the sand for the project free
  of charge, provided TCAP protects the foreshore of the church and TCS building.
- Tuvalu PMU staff visited Nanumea on the Mataili (4/09) to discuss the ESIA with community groups on the island. Validation of the Gender strategy and action plan was also done during this trip.
- The detailed design plans for Nanumaga, Nanumea and Funafuti have been finalised and to be reviewed by the Maritime Construction Expert once on board
- Engagement of a Maritime Construction Expert (MCE) is anticipated by early Q3 upon approval from the UNDP regional bureau in Bangkok.
- Engagement of two (2) IC positions namely, 3D Visual Designer (15<sup>th</sup> September 2020) and the Communications Specialist (30<sup>th</sup> September 2020).
- Procurement meetings with respect to the Civil Construction works at all the 3 project islands have been ongoing involving procurement advisors from Bangkok as well as HQ. The objective was to put in place a sound procurement roadmap for TCAP especially for the civil construction works.

#### **Output 3**: A sustainable financing mechanism established for long-term adaptation efforts

- Contract of the ISP Consultant has been extended to Dec 2020.
- TCAP shared the Due Diligence report (for the Tuvalu Survival Fund) with Government of Tuvalu for their comments. Still awaiting their responses.





- Team from Department of Local Government led by ISP Consultant went to Nanumaga to conduct training for Kaupule staff on climate financing, book-keeping, and reporting.
- ISP review and formulation for Niutao, Nanumaga and Nanumea underway. ISP teams remained on the islands for one month
- Continued discussions on the disbursement of funds under the Performance Based Grant. TCAP shall do further consultations with UNCDF in Q3 looking into having an MOU with them to facilitate the baseline assessment works for the 3 project islands of Funafuti, Nanumea & Nanumaga. Under the current COVID19 situation, other alternatives may need to be looked at in view of undertaking the baseline assessments.

#### 1. Issues and Challenges

#### <u>Travel</u>

The Covid 19 restrictions are still in force and with the mandatory self-isolation periods being imposed, a single trip (by non-Tuvaluan members of the TCAP project team) could take months. It is impossible to foresee how travel will resume under such conditions. In the meantime, travels to the 2 project islands of Nanumea & Nanumaga were all be undertaken by the Tuvalu PMU team as there is no restriction on that.

With these current Covid 19 restrictions, this issue is beyond Project control.

#### Covid 19

Without doubt, Covid19 is the most important emerging risk of Q2. The project will incur delay due to the travel restrictions now in force and the full implications are yet to be fully understood and is dependant on the duration of restrictions as the pandemic runs its course. With the re-emergence of a 2<sup>nd</sup> wave of the COVID19 in Australia, New Zealand and Fiji, it is going to be much harder to anticipate a pronounced return to normal in terms of travels.

#### PART 2: PLANNED ACTIVITES FOR FOURTH QUARTER 2020

Some important headlines on planned activities for Q4 include:

- (i) Revision of scholarship workplan for MEYS and HRM (Sub-activity 1.2.1). This activity was discussed with MEYS in Q2 and was not discussed again in Q3 2020.
- (ii) Recruitment of the Operations CTA is scheduled to commence in Q4 and will be stationed in Tuvalu
- (iii) 3-D designer to work closely with the Coastal Engineer and CTA on the final designs for Funafuti, Nanumea and Nanumaga
- (iv) Submission of the ESIA's for Nanumea, Nanumaga, and Funafuti to the Dept of Environment Tuvalu.





- (v) Consultation with UNCDF on the disbursement of funds under the Performance Based Grant and the finalization of the Operational Manual.
- (vi) Further consultation with government on the endorsement on re-programming avenues for the \$3.5m
- (vii) Project Board Meeting is scheduled for November 12<sup>th</sup> 2020
- (viii) Continued monitoring of, and response to the Covid 19 situation.
