Amendment No. 2 to the Memorandum of Understanding between Participating UN Organizations, the United Nations Resident Coordinator and

the United Nations Development Programme regarding the Operational Aspects of the One UN Fund for Tanzania

All references to the "United Nations Development Assistance Plan (UNDAP) 2011-2015" in the Memorandum of Understanding are hereby amended to "UNDAP 2011-2016".

The following Sections of the Memorandum of Understanding are modified:

PREAMBLE

WHEREAS, the Participating UN Organizations have now extended for one year the United Nations Development Assistance Plan (UNDAP) 2011-2015 as part of their respective development cooperation with the Government of the United Republic of Tanzania and this extension has been endorsed by the Joint Steering Committee on 30th September 2014.

NOW THEREFORE, the United Nations Development Programme, the United Nations Resident Coordinator and the Participating UN Organizations (hereinafter referred to collectively as the "Parties") hereby agree as follows:

Section V: Reporting

- 1.c A final narrative report, as part of its reporting on the activities it has implemented under the UNDAP 2011-2016 and financial report with respect to funds disbursed to it from the Tanzanian One UN Fund account, to be provided no later than 30 April of the year following the financial closing of the activities implemented under the UNDAP 2011-2016.
- 1.d A final financial statement certified by the competent financial management authority of the Participating UN Organisation, to be provided no later than 30 June of the year following the financial closing of the activities implemented under the UNDAP 2011-2016.
- 3.d Consolidated final financial statements, based on final financial statements certified by the competent financial authority of the relevant Participating UN Organization, no later than 31 July of the year following the financial closing of the activities implemented under the UNDAP 2011-2016.
