<p>It is to be recalled that the project falls in 'low category' in the UNDP's Social and Environmental Screening Category. The project recognizes active involvement of stakeholders as key ingredient for successful implementation of the project, and plans an adaptive approach to further guarantee any social and environmental risks that may arise. For this a stakeholder engagement plan with piggy backs on existing NBI's communication and stakeholder strategy has been developed. The project embeds broader stakeholder engagement in all components of the project. <b>In component 1:</b> Wider stakeholders and beneficiaries shall participate in the various shared aquifer diagnosis activities through participation in workshops, trainings and thereby contributing derivation of key knowledge. The action plans that are going to be proposed under <b>component 2</b> of the project will make sure of consideration of gender, marginalized communities (e.g. pastoralists, agro-pastoralists, refugees, IDP's) and environmental sustainability is given due emphasis. All the piloting activities planned under <b>component 3</b> (piloting) will make sure that proper social and environmental screening has been undertaken before project implementation. The stakeholder engagement plan envisages to build capacity of the stakeholders and the beneficiaries at multiple levels including at local aquifer levels and at National/regional levels. The capacity building and KM component of the work (<b>component 4 and 5</b>) will address the needs of the local communities and targets to reach them.</p>

Socio-economic and environmental benefits for the target communities in the countries will be realized from a number of interventions proposed in the project. The Project will also contribute to countries progress towards achieving several of the SDGs. The project is designed to improve the ecosystem through policy change and various pilot projects.</p>
