Welcoming Speech of Mr. Jaco Cilliers:

Mr. Jaco Cilliers welcomed participants on behalf of United Nations Development Programme in Uzbekistan (UNDP) to a Project Board Meeting of the joint UNDP and the Ministry of Agriculture and Water Resources of the Republic of Uzbekistan project, "Integrated Water Resources Management and Water Efficiency Plan for Zarafshan River Basin". Mr. Cilliers emphasized in his speech an importance of

the project for both Uzbekistan and UNDP. He briefly mentioned that significance of water management issues in the Uzbekistan were raised during the recent visit of Head of UNDP to Uzbekistan.

Opening address by Mr. Jahongir Abdurazzakov:

Mr. Jahongir Abdurazzakov noted in his opening speech that Uzbekistan has realised the importance of implementing strong measures to address problems related to water scarcity. Therefore, government revises principles of water management to overcome existing standards in water resources management. He expressed his confidence that the project has a great importance in solving water resources problems within the country, and particularly in improving water management in the Zarafshan River Basin.

Mr. Abdurazzakov appreciated organized on-field visit for representatives of government organizations and agencies to pilot site and communities (makhallas) around pilot area. Informal meetings with all community leaders male and female were organized to discuss real challenges faced on water issues.

Presentation of Head of Zarafshan Basin Irrigation systems Authority on current situation of Zarafshan River Basin

Mr. Gofur Kasimov briefly described the current situation and recent trends in Zarafshan River Basin.

Presentation of Project Manager on overview and report on the activities and tasks implemented in the first half of 2011 and work plan for II-half of 2011

Mr. Ulugbek Islamov has informed the participants on achieved results on all three components of the project and continued with Work Plan for II-half of 2011. The participants were informed about the work that will be carried out in the second half of the year on all three components. The main focuses will be made on review and analysis work have done in the basin, develop project design documentations for pilot projects, provision of assistance on drinking water supply for pilot villages in creation of the water consumers associations and assess training needs for capacity development and outreach.

Presentation of Component Manager on pilot projects

Ms. Malika Ikramova presented a scope of work within the framework of the 3rd component and planned activities on each of them. Ms. Ikramova detail stated on connection between project main strategies and pilots were given in this presentation and objectives of the pilots and their implementation concepts. As the participants had a good opportunity to visit the project's pilot site Pumping station "Mekhnatobod-III" in Pastdargom district before the meeting. She has shortly pointed the expected outputs of pilot: reconstruction of the irrigation system at "Mekhnatobod-III" pumping station is the tool for improving of wellbeing of people living in the pilot villages through increasing of irrigation water supply. Also highlighted the community leaders point an importance of the equal involvement of men and women to manage water resources and the central role of women in provision, management and safeguarding of water.

Presentation of National Consultant on Legal issues: "Towards development of Water Code"

Mr. Yusup Rysbekov presented results of analysis of water legislation from historical perspectives. Then Mr. Rysbekov stated conflicts, overlaps, and gaps between existing legal instruments among various institutions in regards to legal responsibilities for managing water resources and related issues. Additionally he gave useful comments and explanations on the structure of the water Code.

Presentation on development of the Environmental Strategy for Zarafshan River Basin

Ms. Madina Kholmirzaeva, Specialist on Environmental Assessment of "Nazarov Business and Technology" LLC, focused participants' attention on objectives of the Environmental Strategy and proposed methodology of its implementation. Ms. Kholmirzaeva stressed that future Environmental Strategy should be accomplishable and realistic document. It is planned to implement an economical analysis of the future strategy. Further she presented a detailed working time-table of the planned activities for the strategy development. In the end of the presentation Ms. Kholmirzaeva called all participants for close cooperation in fulfilling of tasks related to development of the Environmental strategy.
