**2. SITUATION ANALYSIS**

Venezuela is suffering a severe economic crisis, which has generated a decrease in investments and caused an impact in all sectors. According to the Economic Commission for Latin America and the Caribbean, in 2018 the Bolivarian Republic of Venezuela experienced a contraction of the Gross Domestic Product for the fifth consecutive year of 15 percent, bringing the cumulative contraction to 44 percent since 2013. Since 2013, annual inflation has exceeded 50 percent, reaching triple-digit values in 2015 and 2016. All economic sectors in the country are affected by this situation, including: manufacturing, commerce, telecommunications, services, the oil industry and the financial, banking and credit systems. The decrease in investment especially affects infrastructure and public services. Government stabilization efforts have had a limited effect. After several years of economic contraction in livelihoods and the degradation of access to basic services for Venezuelans, an estimated 7 million people have priority assistance and protection needs, that is, approximately 24 percent of the total population that currently lives in the country.

To address the aggravation of the crisis, all UN agencies dramatically increased their presence in Venezuela in 2019. The RC was designated Humanitarian Coordinator by mid-June, and a Humanitarian Needs Overview and a Humanitarian Response Plan have been elaborated. The Crisis Bureau deployed two early recovery and resilience technical advisers, to assist the UNRC and the UNDP RR in programming tasks. UNDP Venezuela is developing a range of initiatives and projects to be included in the Humanitarian Response Plan, including the possibility to engage in economic recovery. Based on a recommendation of the Venezuela Country Office, UNDP has elevated on 21 June its appreciation of the crisis to Level 2, indicating that it requires large-scale, day-to-day organizational support.



### 3. PROJECT OUTPUTS AND ACTIVITIES

TRAC 113.2 resources will support resilience in Venezuela through early recovery assessment, programming and coordination, conducting the following activities:

- Ensure effective coordination of the Country Office to respond to the crisis, including the substantive participation in humanitarian coordination mechanisms in relation to UNDP mandate and operations and the preparation of regular situation reports.
- Lead assessments to orient programming efforts related to: a) the restoration of local government capacity to deliver services and lead and implement recovery; b) the stabilization and restoration of livelihoods of affected communities through cash for work, cash grants, and promotion of small and medium businesses; and c) the restoration of social and economic activities of communities through repair and reconstruction of community infrastructure.
- Prepare UNDP interventions in strategic areas including the drafting of concept notes for early and long-term recovery with areas of interventions, costs and timeline, and initiate discussions with potential donors and share project concept notes and programme documents based on their interest.

**Target:** An Early recovery framework is established through appropriate assessments, funds mobilization, coordination mechanisms and technical assistance

### 4. MANAGEMENT ARRANGEMENTS
