Dear Madam,

I am pleased to address you on the occasion of referring to Project 119238 *Innovative mechanisms for South-South & Triangular Cooperation (SSTC)*, approved by the Committee of Experts in 2019 to be funded by the Pérez-Guerrero Trust Fund (FFPG).

In this connection, please be informed that this Project, scheduled to be held during 2020 as the central theme of the Meeting of International Cooperation Directors for Latin America and the Caribbean of the Latin American and Caribbean Economic System (SELA), could not be carried out due to the COVID-19 pandemic and its side effects, which affected the full and normal development of institutional activities at the global level and the implementation of the Work Programme of the Permanent Secretariat of SELA.

In addition, taking into account the implementation of health protocols linked to restricted mobility and social distancing of global quarantine, it was impossible to carry out the Project, which provided for the holding of a face-to-face event and financing of transfers and accommodation for international cooperation directors for Latin America and the Caribbean and specialists in the field of the proposed topic. As a result of the global situation, the country that was initially proposed as the venue for the event was unable to hold it during the health emergency.

For the aforementioned reasons, and considering the importance and validity of the issue for SELA member countries given the relevance of knowing and taking advantage of new and innovative opportunities for South-South and Triangular Cooperation, I wish to submit for consideration of the United Nations Office for South-South Cooperation (UNOSSC) and the Pérez-Guerrero Trust Fund (FFPG) the possibility of granting an extension to carry out the
