SECTION B

GENERAL ASSESSMENT

1. Changes in Project

In the framework of project activities, in 2011, the Project concentrated on completing the research results to serve as inputs and recommendations for the revision process of the Land Law 2003. The project worked closely with the Land Law Revision Committee and expects to make significant impacts to change land policies for socio-economic development in Vietnam. Up to now, all project activities have followed the annual and quarter workplans. However, there were some changes affecting the progess of the project. Firstly, in this year, due to the fact that Harvard University would not continue to work as co-implementing partner of the project, in order to ensure the quality and progress of research activities, UNDP in collaboration with IPSARD recruited 5 international consultants under UNDP budget to support the project. The 5 international consultants include: Prof. Brian van Arkadie in charge of writing 2 policy briefs on The efficient use of State-owned farms and public land for national development; and The efficient use of forestry land for national development; Dr. Joop de Wit in charge of writing 2 policy briefs on Tracing and understanding the welfare, wellbeing and livelihood choices of farmers displaced by land recovery; and Evaluating efficient use of suburban land and proposing model for urban agriculture; Dr. Henry Dekker in charge of writing policy briefs on Study on land ownership system: International experiences and application for Vietnam; Dr. Bjorn Surborg in charge of writing policy brief on Land management system for ethnic minorities; Ms. Josephine Tsui in charge of writing policy brief on Improving the conditions under which women contribute to agricultural and rural development. The final reports of these international consultants were good inputs and recommendations for the Policy paper of the project. Based on the fact that the final report of international consultants were submitted in September 2011, the activities in Output 1.1 including revising and finalizing policy paper, peer review of policy paper and publishing policy paper which related to the outputs of both national and international reports had to be delayed to November 2011

Besides, the Output 3.2 which was expected to support Asian Society of Agricultural Economists Conference (ASAE) could only be implemented in October because the ASAE conference with the participation of national and international agricultural economists as well as other development practitioners, policymakers, academicians, researchers was officially organized on 13-15 October.

Due to theses raising problems, the Project Management Unit (PMU) was approved by UNDP and Vietnamese government to extend the project from September as innitial completion schedule to the end of December. These changes didn't affect the quality of project results and total budget for the project.

2. Activity report from 01 January 2011 to 31 December 2011

Continuing results achieved in 2009 and 2010, the Project concentrated on these below outputs:

- 1. Output 1: Completing final comprehensive policy discussion paper
- 2. Output 2: Developing occasional policy memos to inform senior leaders of the research findings (8 policy briefs and 5 indepth-studies)
- 3. Output 3: Organizing a series of national and local workshop
- 4. Output 4: Organizing policy dialouge and study tour
- 5. Maintaining project management regularly and effectively

	background information for policy briefs. In this fieldtrip, IPSARD						
	interviewed local officials of different departments and households						
	focusing on land issues (i) land recovery, compensation procedures;						
	welfare and livelihood of farmers displaced by land recovery; (ii) efficient						
	land use of state -own farms; (iii) land use of minor ethnicity; (iv) efficient						
	use of forestry land. The collected information and data would support the

	2. In July and August 2011, during the time in Hanoi of International						
	consultants, the project organized fieldtrips with the participants of

	the fieldtrips were organized as follow:						
	- During the time Dr. Joop de Wit in Hanoi, the project organized fieldtrips to

These 6 consultants are professors and doctors having rich experiences in land law issues. The 6 reports were completed and submitted to the PMU. Rountable Discussion with Land Law 2003 revision group With the aim share experiences, activity requirements to and recommendations for the Land law 2003 revision, Institute of Policy and Strategy for Agriculture and Rural Development (IPSARD) organized 3 open discussions in May, June and October with the participation of key consultants and officials in land issues to get comments for process of Land Law 2003 revision. Working with General department of Land Administration (GDLA) – **Ministry of Natural Resources and Environment** With the aim to create discussion platform for policy makers and researchers in land issues as well as popularize the research results of projects to the policy making bodies of the Government, the PMU collaborated with the General department of Land administration (GDLA) to organize a series of national policy dialogues. GDLA is a unit having professional capacity in land management and being assigned by the Vietnamese Parliament to be in charge of the revision process of the Land Law 2003. Therefore, the collaboration between the Project and GDLA in organizing policy dialogues has enhanced the effectiveness and impact of the project results. In this collaborative framework, 1 workshops and 2 roundtable workshops were organized. The first workshop on Role of the State as a solely representative of people in administering land was organized on 21 July 2011. The 2 roundtable

	As approved by UNDP and MARD in the project activity workplan in 2011, the
	project gave a financial support of 30,000USD for the 7th Asian Society of
	Agricultural Economists Conference (ASAE) which was organized on 13 – 15
	October 2011. This event was co-organized by ASAE's Board Members and

	IPSARD. The conference themes covered such topics as land policy, poverty
	reduction, linkages of farmers to market, value chains for the poor, sustainable
	development or green growth, food safety, food security, climate change and
	governance, and regional cooperation. Those topics were relevant to UNDP
	support in Vietnam, focusing on poverty reduction, empowerment of marginal
	and vulnerable people, governance and sustainable growth. The support to the
	7th ASAE conference served as a means to disseminate project findings among
	academic community and create a platform for sharing international experiences
	on land policies through continuous exposure to a cross-section of professionals,
	institutions, and companies in Asia and worldwide. This, in turn, contributed
	significantly to the process of finalization of the project land policy paper as
	expected.

	According to the workplan, the project organized the dialogue workshop on
	Land recall, land allocation, land lease and land conversion on 26 July 2011. In
	the workshop, vice minister of Ministry of Natural resources and Environment
	(MONRE) Dr. Nguyen Manh Hien and General director of IPSARD Dr. Dang
	Kim Son were co-chair for the meeting. The dialogue has collected many
	valuable information and opinions on revising issues on land lease and conversion.
	Organization of study tour to Europe countries
	The project organized a study tour to three countries of Netherlands, Finland,
	and Germany from 03 to 15 September 2011 in order to learn the best
	practices and appropriate models of modern agriculture and the corresponding
	land management systems. These three countries for study were recommended
	by international consultants working for the project on the thematic policy
	briefs and were carefully considered by the project to ensure relevance with
	the project outputs. The study tour was very effective and fruitful. After the
	fieldtrip, the project members developed a detailed report about the discussed

	13-15 October 2011.
Project	The project management board ensured the effective activities of project

	The project management board has followed the guides in the Audit in 2010.
	All of the project contracts strictly followed Harmonized Program and Project
	Management Guide (HPPMG) on bidding procedures.
	A new project coordinator was recruited in Febuary 2011.

3. Achievements of project

In general, the project was implemented successfully with key outputs: 8 policy briefs on different topics, 5 in-depth studies, 6 proposals for revising Land Law 2003. Above all, the final policy discussion paper was finalized as expected. Along with key topics of land conversion, land consolidation, land as an asset, food security, complementary investments that raise land productivity, land and property taxation and environmental sustainable which was addressed in 2009 and 2010, the final policy paper covered 8 more topics of Land recovery, livelihood choices of farmers displaced by land recovery; Land management system for ethnic minorities; Land and gender; Forestry land; State-owned farm and public land; Sub-urban land management; increasing land asset value; international experience on land ownership system. With these topics, the policy paper is comprehensive and covers a broad range of related issues.

4. Impact of projects

The project has generated great impacts on the awareness and policy stance of central and local authorities. The policy paper has made policy recommendations effectively and is considered as good input for the process of revising land law 2003. Besides, the project developed successfully a broad network of international and national consultants as well as high ranking leaders of different managerial levels of the Government of Vietnam. Moreover, the project created a regular platform for different stakeholders to disscuss and learn international experiences so that the Vietnamese government can address land issues in more professional manner. It is clear that the collaboration with international and national consultants as well as regular communication activitities contributed actively to strengthen research and managerial capacity of MARD and IPSARD staff as well as broaden knowledges to academic communites. The project plans to work with the Constitutional revision group of Parliament on the policy recommendations for the Land Law 2003 revision

5. Challenges in Project implementation

During the implementation, due to some changes in co-implementing partner (Harvard did not continue to work as co-implementing partner), the project had to manage and request UNDP to recruit other international consultants. This process took time leading to the delays of some other activities. Besides, the implementation raises the challenges of human resources and demands professional experts and consultants.
