1. IMPLEMENTATION PROGRESS

This report covers the period January 2019-December 2019 of the implementation of the project "Realization of a Just and Inclusive Society", funded by the United Nations Development Programme in Angola (UNDP). This four-year project (2018 - 2021) is an upscaling of previous interventions that UNDP and partners have undertaken in recent years in the areas of human rights and access to justice, gender equality and empowerment of women.

The project aims to contribute to national efforts to achieve (human rights protection and fulfilment) the human rights of all Angolans and to expand access to justice services, to achieve gender equality and empower women and girls. In this way, the project aims to contribute to the acceleration, at sectoral level, of the implementation of Agenda 2030 in Angola, mainly the SDGs 16 and 5, aligned in the new National Development Plan (2018-2022).

By the end of 2018 the project had 4 formal partnerships: the Ministry of Justice and Human Rights (MINJUDH), the Ombudsman Office (ProvJu), the Ministry of Social Action, Family and Women's Promotion (MASFAMU), Office of the Attorney General and civil society. The fact that Governance Unit was able to bring together 4 IPs together was strategic and a very strong result that enabled the alignment of efforts towards national priorities.

During 2019, based and aligned with the Project Document, another sub project was added, and formal partnerships established with the Ministry of Interior. The UNDP Governance Project signed five AWPs in 2019, namely: with the Ministry of Justice and Human Rights, the Ministry of Social Action, Family and Women's Promotion, the Office of the Ombudsman and the Office of the Attorney General and the Ministry of Interior.

6. IMPLEMENTATION CHALLENGE

As in 2018, the challenge in 2019 were the changes at central level: the ministers of MASFAMU and MININT were replaced. Regaridng MASFAMU the Gender Equality and Women's Rights National Officer was replaced which delay the implementation. With MININT the activities on the 2nd half of the year were suspended, waiting for the approval of the new minister.

This posed a challenge to the implementation of the AWP agreed with MASFAMU. From the four planned results to be achieved in 2019, only one result was partially achieved.

7. LESSONS LEARNED

- Coordination in the implementation and management of the AWP with the focal points and working teams need reinforcing to improve operational efficiency.
- Improvement of linkages between CO project management and on the field partners is critical to enhance UNDP on the ground operational capacity and entrenched stronger partnerships
- Efforts to maintain and improve the level of communication and understanding of UNDP procedures between UNDP and IPs are crucial for the project to be successful.
- Increase the opportunities for civil society to directly interact with government institutions and its members.
- A harmonized reporting template instrument developed by UNDP project management can help improve the quality of reporting and data produced by implementing partners, as well as to fill in the project's results frameworks.

8. RESULTS

The fact, that the Governance Unit was able to create a strategic portfolio for the next four years, upscaling past interventions and bringing now the 5 IPs together under the same umbrella is a very important measure for alignment of efforts towards national priorities.

The project achieved important results planned for 2019, aiming to contribute to the midterm project goal, the promotion and protection of human rights and the advance of gender equality and empowerment of women and girls. A total of 1301 beneficiaries were reached. Of the total of documented beneficiaries 39% were women and 61% were men.

- With UNDP technical assistance in collaboration with OHCHR, Angola ratified six human rights conventions, including the fundamental instruments to end torture, statelessness, death penalty and all forms of discrimination.
- UNDP technical assistance improved protection rights and access to services of citizens by increasing the awareness on the Ombudsman mandate, function and utility raised among civil society and by supporting the decentralization of PGR activities.
- Participation and inclusion of vulnerable and disadvantaged groups and discussions of challenges and obstacles faced by them integrated
- UNDP was recognized as a strategic partner to support the government on its priority to fight against corruption. In October 2019, the President of the Republic issued a decree (Decree 176/19) that created the Group, led by the State Minister and Chief-of-Staff for the presidency (Casa Civil) with the co-leadership of the Ministry of Justice and Human Rights (Minister), with key institutional memberships, including the Minister of Defense, Minister of Interior, Minister of Foreign Affairs, Minister of Finance, Secretary of the President for Diplomatic Affairs, Secretary of the President for Judicial Affairs, the General Inspection Services (IAGE) and the Financial Intelligence Unit (UIF) of the Central Bank (BNA).
- Provide technical assistance for the Angolan defense on UPR, CEDAW and ICCPR
- ToT for National Police was replicated national wide, more than 1000 National Police
- The National Anti-Corruption Plan 2018-2022 (NACP 2018-2022) as a first step and guide for the national anti-corruption efforts was developed and launched.
- National System of Gender Indicators were revised, and 150 indicators were approved.
