

AMENDMENT TO THE GRANT AGREEMENT

Reference is made to the Grant Agreement (hereinafter "Agreement") dated July 19, 2018 signed between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and ADRIATIC TRAINING AND RESEARCH CENTRE (ATRAC), with respect to the Project number 00106295 and title: Management of Marine and Coastline Pollution for Increased Safety at Sea and Ports in line with EU Maritime Law and Policy, and as per Article 2.1 of the Agreement, any modification to this Agreement shall be made in writing between both parties and in mutual agreement.

Therefore Parties hereby agree on the following:

WHEREAS the ATRAC and UNDP now wish to amend article 2.1 of the said Agreement in order to:

Extend the Grant Agreement in time until April 30, 2020

WHEREAS the ATRAC and UNDP now wish to amend article 3.1 of the said Agreement in order to:

Decrease the Third installment to USD 39,977, training programs and completion of training courses to be delivered by October 31, 2019

Add a Fourth installment of USD 13,325, final report to be delivered by March 1, 2020

WHEREAS section B, Budget is amended to reflect the changes in article 2.1 and 3.1


NEVERTHELESS, all other terms and conditions of the Grant Agreement, except as amended herein, shall remain unchanged and shall continue in full force and effect.



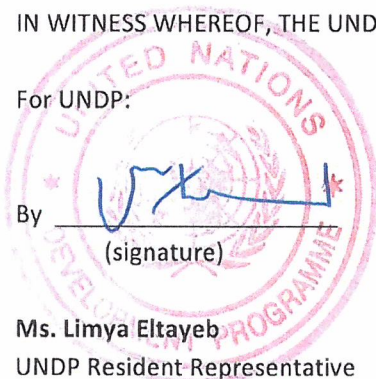
