


Narrative

The domestic violence component of the UN Joint Programme on Gender Equality and Domestic Violence (2008-2011) with its many achievements, built on UN expertise and history in tackling gender-based and domestic violence issue in Albania in the past years. In many aspects, this work plan represents an up-scaling and deepening of interventions initiated under that Joint Programme but also expands into new directions. With the recent signing of the Council of Europe Convention on preventing and combating violence against women and domestic violence, Albania will need to prepare for the process of ratification and consequently of implementation. Therefore, this work plan, based on the Government of Albania strategic priorities reflected in the revised National Strategy (2011-2015), contains interventions towards establishment of a national hotline for domestic violence survivors, development of the legal framework and estimation of costs for the implementation of the CoE Convention.

With the approval of the Council of Ministers Decision on the Community Coordinated Response (CCR) against Domestic Violence in February 2011, local government units as well as other local agencies will need to be informed of their required actions and work towards its implementation. Under the previous Programme, MOLSAEO and the UN started a few regional meetings to inform local actors about the CCR Decision, to explain the coordinated response philosophy and methodology and to highlight the monitoring role of MOLSAEO for its implementation. UN proposes to continue supporting MOLSAEO in organizing these regional meetings, with a view to spread this information in areas that have not been previously reached through CCR initiatives. Similarly, the UN proposes to specifically focus in four new municipalities, Tirana, Burrel and other ones to be determined after these initial regional meetings are organised, to assist them in 2012 and 2013 to build solid CCR systems. UN also proposes to upscale Durres and Korça CCRs to involve surrounding communes and afford the same inter-disciplinary attention to rural, in addition to urban survivors of domestic violence. Sometimes the map of services available in rural areas is much poorer, with particularly DV services nonexistent. Communes' funds and human resources are, similarly, extremely limited compared to those of municipalities. Therefore, some form of cooperation between municipalities and communes must be tested in these areas, with a view to mobilize the often limited available resources, and consequently maximize benefits.

Naturally successful initiatives, such as Durres and Korça, need appropriate resources to ensure sustainability and quality services to gender-based violence survivors. To this end, the UN will work closely with state and non-state actors to define financial resources required by Community Coordinated Response (CCR) to violence against women. Two surveys on the cost of protection orders and CCR in pilot municipalities will be the basis for MoLSAEO to further advocate for budgetary allocations with line ministries and local government units.

Under the UN Joint Programme, Albanian authorities, with UN agencies support have trained a multitude of professionals, such as judges, prosecutors, police, social service providers, education professionals, health providers and other civil servants in implementation of the Domestic Violence Law and in eliminating stereotypes and myths while dealing with gender-based violence survivors. UN agencies will continue to support MOLSAEO, Ministry of Health, Ministry of Education, Ministry of

Justice, Magistrates School and ITAP in organising similar training sessions for diverse professionals, with a view to expand the number of officials equipped with these skills:

- UNDP will primarily focus on justice system professionals, particularly in light of the new expected changes of the Criminal Code that better address gender-based violence, while extending the sessions to the list of free legal assistance attorneys (to be finalized this year by the Legal Aid Office), medico-legal personnel, bailiffs etc.
- As part of UN overall efforts to coordinated response to the gender base violence, UNFPA is engaged in supporting the Ministry of Health (MoH) to integrate GBV within health system. Development of policies and protocols to detect, treat, register and refer all victims of violence encountered in the health system along with an accredited nationwide training programme on GBV is offered to the Primary Health Care service providers since 2010 with the leadership and ownership of the MoH central and local structures.
- Social administrators, municipal child protection workers, school psychologists, educators and other care givers for children and families have daily contacts or visit poor and socially disadvantaged families to assess the situation of children and their risk of being abused, neglected or victims of violence. As such they are the main interface at the family and community level with women and girls and have a strong potential of becoming their first witnesses and advisors to help them take the difficult decision of reporting on the violence. School psychologists are also the daily interface with adolescent girls that are experiencing different forms of abuse and violence. The UN proposed intervention intends to build the capacities of child protection workers and school psychologists in preventing cases of violence and addressing them, pursuant to pertinent legal framework. A specific training tool will be developed and piloted on gender-based violence, especially for adolescent girls, designed to build these service providers skills to offer counseling and assist women and girls to make an informed decision about reporting violence they experience at home or in community, through integration of inter-personal communication techniques in the work of child protection.

Under the UN Joint Programme, the UN supported the opening of the national shelter for domestic violence survivors. This typology of service is very new, particularly for public providers of social services. There is no doubt that the personnel will continue to need further mentoring in 2012, while there is a visible need to expose them to practical models from other countries in administering shelters and offering services to gender-based violence survivors. The UN will support the shelter with these and at the same time will support with procurement of some items, such as the health room equipment, outdoor entertainment for children and establishment of a small workshop to encourage income-generation for women and strengthen their ability to lead a self-sufficient life.

Finally, UN agencies will continue the yearly tradition of organizing, together with GoA partners awareness activities against violence against women, under the umbrella of the UN Secretary General UNite campaign. Within, but also beyond this context, UN Women, UNDP, and UNFPA, based on good practices of other UN offices, will examine ways to involve Albanian men and boys in combating gender based violence.
