# EUROPEAN COMMUNITY CONTRIBUTION AGREEMENT WITH AN INTERNATIONAL ORGANISATION

[identification number of the contribution agreement]

The European Community, represented by the Commission of the European Communities, ("the Contracting Authority")

of the one part,

and

The United Nations Development Program (UNDP) with its Head office at UN Plaza, New-York, USA, ("the Organisation")

of the other part,

have agreed as follows:

# **Special Conditions**

### Article 1 - Purpose

- 1(1) The purpose of this Agreement is a contribution by the Contracting Authority for the implementation of the action entitled: Support to Burundi capacity mine action programme ("the Action") as described in Annex 1.
- 1(2) The Organisation will be awarded the contribution on the terms and conditions set out in this Agreement, which complies with the provisions of the 29 April 2003 Financial and Administrative Framework Agreement FAFA- between the European Commission and the United Nations and consists of these special conditions ("Special Conditions") and their annexes.
- 1(3) The Organisation accepts the contribution and undertakes to do everything in its power to implement the Action under its own responsibility.

# Article 2 - Entry into force and Implementation Period

- 2(1) This Agreement shall enter into force on the date when the last of the two Parties signs.
- 2(2) The implementation of this Agreement will begin on:the day following that on which the last of the two parties signs
- 2(3) The implementation period of this Agreement, as laid down in Annex I, is 15 months.

### Article 3 - Financing the Action

- 3(1) The total cost of the Action eligible for financing by the Contracting Authority is estimated at EUR 1,435,086,68, as set out in Annex III.
- 3(2) The Contracting Authority undertakes to finance a maximum of EUR 1,435,086,68, equivalent to 100 % of the estimated total eligible cost specified in paragraph 3(1); the final amount will be established in accordance with Article 17 of Annex II.

# Article 4 - Narrative and financial reporting and payment arrangements

- 4(1) Narrative and financial reports shall be produced in support of payment requests, in compliance with Articles 2 and 15(1) of Annex II.
- 4(2) Payment will be made in accordance with Article 15 of Annex II; of the options referred to in Article 15(1), the following will apply:

Prefinancing

EUR 1,035,675

Forecast final payment (subject to the provisions of Annex II) EUR 399,411,68
