



1st Amendment to the Specific Arrangement

for a cost-sharing contribution between

the Netherlands Minister for Foreign Trade and Development Cooperation

and

UNDP

With reference to the General Arrangement concluded in 2005, amended in 2008, between the Netherlands Minister for Development Cooperation and the United Nations Development Programme (UNDP);

Whereas the Netherlands Minister for Foreign Trade and Development Cooperation (the Minister) had concluded on the 1st of August 2014 the Specific Arrangement of project *d'Appui au Cycle Electoral 2015 au Burundi – PACE 2015*";

Whereas developments relating to the project justify amendment of the Specific Arrangement mentioned;

Now therefore the Minister and UNDP have decided as follows:

The maximum amount of the Minister's contribution to the project will be increased from USD 1.300.000 to USD 2.600.000.

The contribution will be provided for the period from 1 August 2014 to 31 December 2015.

The terms of the General Arrangement will apply to this Arrangement. In addition, the following will apply:

- The Minister will deposit the contribution into the agreed Account in accordance with the following payment schedule:
 - The contribution will be paid in two instalments of USD 1.300.000 each.
 - The first payment of USD 1.300.000 has already been effectuated in 2014.
 - The second payment of USD 1.300.000 to be made in 2015 upon receipt of the signed 1st
 Amendment to the Specific Arrangement.
- 2. The contribution will be charged 8% for the provision of General Management Support (GMS), which is included in the payments;
