### **Brief Description**

The Government of Bangladesh recently issued the National Strategy for Accelerated Poverty Reduction (NSAPR) and has committed the country to achieving the Millennium Development Goals (MDGs). The project "Monitoring Poverty Reduction Strategies (PRS) and MDGs" will strengthen the capacity of Government professionals to track and monitor PRS/MDG progress, estimate the costs of achieving PRS/MDG targets, link those costs with the national budget and medium-term budgetary frameworks, and prepare future PRSs. Its institutional home will be the General Economics Division (GED), which serves as the National Poverty Focal Point, and all project activities will be interwoven into GED's regular functions, ensuring sustainability. A dynamically linked, integrated modeling system developed under an earlier UNDP-supported project will be used, updated, and extended. The modeling system simulates and analyzes the social and economic effects of policy measures and economic shocks in a consistent and coherent way within the context of the national economy as a whole. Its use will enable researchers and policy makers to understand trends of the past and to develop and analyze alternative policy scenarios for pro-poor growth and equity into the future. Policy studies, economic forecasts, and analytical MDG/PRS reports will be produced, and the project will ensure that results are validated nationally and internationally. Seminars and workshops will foster public awareness and stakeholder participation in the preparation of localized MDGs and future strategies. By the end of the project, GED is expected to have highly qualified professionals, state-of-the-art planning practices, and close linkages with other government entities and stakeholders.

### **SECTION I: NARRATIVE**

### **PART I. SITUATION ANALYSIS**

### I.A Country Development Scenario

Bangladesh has achieved a mixed bag of success in its development process. According to UNDP's *Human Development Report (HDR)*, Bangladesh recently graduated from the league of low human development countries to the medium human development category and now holds a human development ranking of 139 among 177 countries. As measured by the head count ratio, poverty declined from 70 to 50 percent between the early 1970s and the year 2000, and remarkable success has been achieved in many social indicators, such as life expectancy, infant mortality, population growth, primary and secondary enrolment, and female education.

Despite these achievements, substantial challenges lie ahead as the country strives to sustain its past successes and move forward on other frontiers, particularly achieving the MDGs. Bangladesh has the third highest concentration of poverty in the world (after China and India). The country entered the new millennium with the same number of people living in poverty (around 63 million) as in 1991-92. Even with a steady decline in fertility, the population of 130 million is expected to increase by another 40 million people over the next 25 years. Child malnutrition remains among the highest in the world, and maternal mortality is among the highest outside Sub-Saharan Africa. Bangladesh is historically a poor saver, with a savings-to-GDP ratio well below that of its South Asian neighbors. The economy is also disaster-prone and vulnerable to external shocks, such as spikes in energy prices and the potential effects of the phase-out of the Multifiber Arrangement (MFA) on trade and employment. The magnitude and nature of the tasks ahead call for greater efforts to mobilize resources and to allocate those resources effectively.

### I.B National Planning and Monitoring Capacity

Multifaceted planning and policy processes—recognizing the interdependence of social, economic, political, and institutional variables—are needed to address Bangladesh's development challenges. In October 2005 the Government of Bangladesh issued the country's first PRSP, Unlocking the Potential: National Strategy for Accelerated Poverty Reduction (NSAPR). It now has the tasks of implementing the NSAPR, monitoring progress toward development goals, costing the achievement of goals, linking those costs to the national budget and medium-term budgetary frameworks, and designing subsequent Poverty Reduction Strategies. The current realities of Bangladesh, however, present numerous obstacles to effective planning:

- The existence of a wide range of actors inside and outside the Government who influence policy formulation but who do not use a common, regularly updated, and appropriate analytical framework often leads to inconsistent and counter-productive policy choices.
- Social issues related to sustainable development are addressed separately and often only at the end of the policy formulation process, rather than as integral parts of the process itself; analytical instruments and skills are inadequate to properly integrate the analysis of social dimensions of development into mainstream economic analysis.
- Micro-level program interventions are often inconsistent with macro-level realities, resulting in non-achievement of objectives and program failures; development targets are often

inconsistent with available resources and implementation capacity; and long-term objectives are often inconsistent with short- and medium-term policies.

• Inadequate monitoring and analytical feedback prevent policy adjustments that appropriately reflect implementation realities.

The Government needs to address these concerns over the coming years through a planning process that involves all relevant line ministries and agencies. As the principal agent to engineer and crystallize developmental efforts, the Government must have the capacity to formulate and implement appropriate and effective strategies. The prime institution in this respect is the Planning Commission, which is responsible for streamlining the country's overall development efforts. Within the Planning Commission, the General Economics Division (GED) is responsible for looking after PRS and MDG issues as the National Poverty Focal Point (NPFP). The acceleration of Bangladesh's progress toward poverty reduction and MDG achievement will require strengthening of the Planning Commission's institutional and professional capabilities, and particularly those of GED.

An integrated analytical framework is important for researchers and policy makers to understand trends of the past and to develop and analyze alternative policy scenarios for pro-poor growth and equity into the future. Recognizing this need, *the Government has developed a dynamically linked, integrated modeling system*. Within the context of the national economy as a whole, the system is capable of simulating and analyzing the social and economic implications of policy measures and packages in a consistent and coherent manner. It currently consists of eight interlinked and dynamic modules (e.g., demography, poverty, education).

A UNDP-supported project—Support for Monitoring Sustainable Human Development in Bangladesh (BGD/93/008), known as the "SHD Project"—enabled the development of this system. The Government and UNDP jointly commissioned international evaluations of the system in 1999 and 2004. In the first evaluation, the Millennium Institute (USA) recognized the system's efficiency and recommended its further refinement and its institutionalization within the Planning Commission. The second evaluation also recognized the high quality of the project's work. It suggested a number of actions to be taken up by a successive project and observed that the modeling system and related capacity building could help to frame successive rounds of Poverty Reduction Strategies and to track and monitor PRS and MDG progress in Bangladesh. It identified GED as the best institutional home for such a project.

Sustaining operation of the system and activating effective co-ordination mechanisms at the highest levels of policy formulation are two remaining imperatives. Following the recommendations of the 2004 evaluation, the Government and UNDP have therefore developed a subsequent project—Support to Monitoring Poverty Reduction Strategies and MDGs—to apply the immediate and potential utility of the modeling system, and the capacities built around it, to the establishment of the knowledge infrastructure needed to overcome capacity constraints to PRS/MDG monitoring and the preparation of future Poverty Reduction Strategies.

### PART II. STRATEGY

### II.A Linkage to National Goals and Priorities

The project will contribute to Bangladesh's medium-term progress toward the goals of the NSAPR and toward the objectives that the Government has set forth in collaboration with the United Nations. In so doing, it aims to strengthen the Government's foundation for long-term tracking, monitoring, and achievement of the MDGs, to which Bangladesh is committed, and the goals of future national Poverty Reduction Strategies.

The NSAPR outlines a rigorous monitoring strategy to track progress toward development goals, and it accords GED, as the National Poverty Focal Point (NPFP), a central role in this process:

"The NPFP will have the primary responsibility for developing the detailed strategies for PRS monitoring. Responsibilities will include a) collating official data on PRS monitoring, b) coordinating monitoring efforts within and outside the Government, c) facilitating effective resolution of debates on indicators and methodologies and developing new indicators where necessary, d) undertaking relevant research and studies in collaboration with independent academic/research institutions and civil society groups, and e) facilitating feedback of outcome monitoring into policy-making. To be able to respond to these challenges, suitable capacity building of NPFP will have to be addressed as a matter of priority." (NSAPR, p. 197)

In addition, the Policy Matrix of the NSAPR allocates responsibilities to GED for several components of the national policy agenda for FY05-07, as shown in the table below.

### II.B. PRS/MDG Monitoring and the Preparation of Poverty Reduction Strategies

The integrated modeling system developed under the SHD Project will provide the analytical framework for monitoring PRS and MDG progress and for the preparation of successive PRSs. Using disaggregated data, the system is expected to allow researchers and policy makers to prepare and test alternative strategies for poverty reduction and to prioritize programmes accordingly. Activities to support the monitoring of MDG/PRS progress and the preparation of future Poverty Reduction Strategies include localizing the MDGs (i.e., establishing "Bangladesh Development Goals," or

BDGs), developing corresponding targets and indicators, costing MDG and BDG achievement, linking those costs with the national budget and medium-term budgetary frameworks, and producing analytical MDG and BDG progress reports as part of GED's regular—and sustainable—functions. (See Outputs 1 and 2 in the Results and Resources Framework below.)

### II.C Sector Studies and Policy Analysis

The project will support GED in preparing sector studies and policy analysis in a variety of areas including fiscal policy, monetary policy, trade, early warning systems and shock analysis, and economic diplomacy. Other analyses may address gender budgeting, HIV/AIDS, and other crosscutting subjects. The studies will aim to identify sources of pro-poor growth and to influence policy development to the benefit of the poor. (See Output 3 in the Results and Resources Framework below.)

### II.D Updating, Strengthening, and Expanding the Modeling System

The Project will support GED in regular updating of the modeling system, strengthening the system, and developing and integrating new modules. Monitoring and preparing poverty reduction strategies will require the availability and use of consistent, coherent, and reliable data sets that are disaggregated by gender, region, rural-urban residence, vulnerability, natural resource base, and other socioeconomic characteristics. The project therefore envisions regular updating of the data used in the modeling system to reflect steadily improving data quality. Stronger linkages will be sought between GED and data producers so that data demand is effectively conveyed. The extensions envisioned for the modeling system include an environment module, a health-population-education module, and an employment matrix. Biannual and annual economic reports/forecasts will be produced. (See Output 4 in the Results and Resources Framework in Section-II of this document.)

### II.E Capacity Building

Expanded knowledge and skills are of utmost importance to ensure the smooth functioning of the country's development administration. Accordingly, the project will provide training in state-of-the-art techniques of development planning to officers of GED and other Government bodies involved with PRS/MDG monitoring, such as the Bangladesh Bureau of Statistics (BBS), Bangladesh Bank, Economic Relations Division (ERD), and the Finance Division. The training will focus on integrated micro and macro analysis of the social and economic aspects of alternative policy scenarios. The trained officers will use and further develop the modeling system as part of their regular functions. A priority will be placed on gender balance in the selection of participants in all training and higher studies conducted within the project.

To deepen and internalize the Government's monitoring capacity, the project's training component will include opportunities for selected professionals to specialize in relevant fields through higher studies. The selection process for these programs will be rigorous, competitive, and transparent. All training will take place in phases so that it does not jeopardize the day-to-day activities and performance of participating Government bodies. Upon completion of their programs, the trained government officers must be placed in government institutions where their expertise is utilized to the maximum benefit of the nation. (For further information on the training envisioned, see Output 5 of the Results and Resources Table and Annex I of this document.)

The creation of a knowledgeable group of development planners in GED will provide a basic ingredient for the design of comprehensive Poverty Reduction Strategies in Bangladesh and the ability

to influence decision-makers, politicians, and development practitioners with a clearly articulated planning approach that takes poverty eradication as its central objective. The findings regarding appropriate strategies—and the consensus built around them—will be reflected in the objectives, policies, and projects/programs set forth in successive rounds of Poverty Reduction Strategies. The work of these development planners is expected to create a receptive attitude towards the implementation of Poverty Reduction Strategies in Bangladesh in which private and public efforts are tightly interwoven.

### II.F Institution Building

Ultimately, the Project aims to establish GED as a self-sustaining National Poverty Focal Point—with highly qualified professionals, state-of-the-art planning practices, and close linkages with other government entities involved with the collection, analysis, and utilization of data in the policy process. In this way, the project envisions gradually reducing the Government's dependence on national and international consultants in vitally important national policy issues. In particular, the Government is expected to gain and demonstrate sustainable capacity to—

- Analyze the social and economic implications of alternative strategies, policies, and development choices
- Make policy choices that are well informed and coherent across macro, sectoral, and project levels.
- Integrate the planning functions of line ministries with those of the Planning Commission.
- Maintain information flows across macro, sector, and project levels.
- Strengthen linkages among data producers inside and outside the Government, ensuring that data demand is conveyed to data producers
- Continuously monitor the status of MDG/PRS progress and fine-tune development plans.

GED is expected to provide strategic inputs in the decision-making process regarding sectoral programs and policies to officials in the sector divisions of the Planning Commission and the planning wings of the line ministries, enabling them to use the information generated through the modeling system in discharging their usual functions. The project will develop and facilitate the use of user interfaces for a wide spectrum of policy and planning practitioners. To ensure an effective flow of information and data, GED will strengthen its collaboration with various data producing and processing institutions, such as the Bangladesh Bureau of Statistics (BBS). These institutions will benefit from suggestions and advice from the viewpoints of users, which has seldom happened to date in Bangladesh.

### **II.G** Quality Control and Networking

Renowned international experts will undertake two visits to the project each year to validate the project's results and disseminate good practices. They will also develop and present papers with the professionals involved in the project. A National Reference Group will be established to hold three or four meeting each year for similar purposes at the national level. Finally, backstopping arrangements will provide support to professionals involved in the project as needed for the design of extensions to the modeling system. With the completion of higher studies supported by the project, national capacity to extend components of the system is expected to replace the need for such backstopping support. (See Output 6 in the Results and Resources Framework in Section-II of this document).

### II.H Communication Strategy, Public Advocacy, and Participation

The project will support a series of stakeholder seminars and workshops to increase public awareness of poverty reduction processes and strategies, to identify challenges to achieving the PRS/MDG targets, and to devise localized MDGs (or BDGs). Results of the analytical and modeling work performed under the project will be presented and discussed in these seminars with a variety of stakeholders, and this process will become part of GED's regular functions for continuation beyond the life of the project. Efforts will be made to involve development agencies, the Budget Analysis Unit of the Parliament Secretariat, independent research organizations, and civil society at large into the functioning of the project through these seminars and workshops and other venues for policy dialogue. The project will publish reports on PRS implementation progress and MDG progress, and all reports and forecasts will be circulated widely among stakeholders.

### II.I Exit Strategy

An exit strategy is embedded in the whole design of the project. Building the Government's capacity to prepare Poverty Reduction Strategies and other development plans—and to track and monitor MDG/BDG progress—is the project's central focus. All project activities will be interwoven into GED's regular functions, and the Government is expected to allocate sufficient resources for the independent continuation of these activities beyond the life of the project.

The project will support GED in developing a comprehensive set of macro-models with comprehensive data (disaggregated by gender, socio-economic groups, location, etc.) and in building capacity to maintain, update, and expand the models and databases. Practical experience alongside opportunities for training and higher studies will enable model building and quantitative analysis to become permanent features of the national planning process.

Partnerships across Government entities—and between the Government and the private sector, civil society, academia, and development partners—will be established and encouraged to build their own momentum. As described above, the mechanisms for communicating ideas, knowledge, and data will include workshops, seminars, joint training opportunities, a policy working group, national and international reference groups, user interfaces for use of the modeling system by a variety of policy and planning practitioners, and wide dissemination of the project's published work, including regular MDG and BDG progress reports.

By the end of the project, GED is expected to emerge as a self-sustaining National Poverty Focal Point with highly qualified professionals, state-of-the-art planning practices, and close linkages with other government entities and stakeholders. The project will use external expertise in a targeted fashion, ensuring that the Government gradually reduces dependence on national and international consultants in addressing national policy issues. The creation of a knowledgeable group of development planners in GED will enable the design of successive Poverty Reduction Strategies that reflect both consensus and rigorous analysis. The project is thus expected to have a lasting influence on future policy developments for pro-poor growth and equity.

### PART III. MANAGEMENT ARRANGEMENTS

The Planning Division of the Ministry of Planning will execute the project under the national execution modality (NEX), and General Economic Division (GED) will implement the project, as recommended in the evaluation-cum-formulation mission report. The management arrangements will therefore ensure the pro-active ownership and involvement of policy planners at GED and Planning Division, which are necessary for success of the project. UNOPS will serve as the UN Implementing Partner to implement/administer the international sub-contracting inputs. A Letter of Agreement (LOA) will be signed between the Planning Division, Ministry of Planning (as the Designated Agency of the project) and UNOPS for this purpose. Procurement of equipment/hardware, arrangements of study tours and fellowship will be implemented by UNDP under the Direct Country Office Support (DCOS) modality (Annex IV, and Annex VI) agreed between the Government of Bangladesh and UNDP. The project was initiated through an Advance Authorization signed by the Resident Representative on 23 November 2005 (Annex VII). This document represents both the Advance Authorization period, including the 2005 actual expenditures, and the full project period.

### III.A Implementation Capacity

GED is well qualified to implement the project. Since its inception in 1972, the Division has gained extensive experience in receiving, implementing, and managing technical assistance projects offered by various development partners, including UNDP. GED's responsibilities include the preparation and coordination of medium- and long-term development plans, day-to-day monitoring of the economic health of the nation, reviewing and evaluating plans and programs, and advising the Government and ministries on key socio-economic issues. GED naturally has a close relationship with all the line ministries, other departments, and agencies. In addition to preparing the country's first Poverty Reduction Strategy Paper (PRSP), GED played active role in preparing Bangladesh's first MDG progress report. GED and UNDP have developed a good working relationship. Some skill enhancement training in NEX procedures will be organized for the project personnel and GED counterpart officials by the UNDP-funded NEX Support project (BGD/04/012), executed and implemented by ERD, at the beginning of the project.

### III.B Management Structure

The evaluation-cum-formulation mission report identified some management problems in the earlier SHD Project, and GED recognizes that the earlier project's achievements were not integrated and utilized effectively in national planning and decision-making processes. These difficulties resulted largely from the project's sub-optimal location and segregated management structure in a distinct unit.

Considering the highly technical nature of the project and the need to overcome the earlier management difficulties, GED, as the National Poverty Focal Point, will be the institutional home of the new project and will provide overall leadership and guidance. The management structure will consist of a Steering Committee for policy guidance; a Policy Working Group to serve as a conduit between project activities and policy makers; a Tripartite Committee to advise on administrative issues; and a Coordination Committee to facilitate the day-to-day functioning of the project.

The *Steering Committee* will provide overall policy direction for the project. In order to facilitate quick decision-making, membership in the Steering Committee will remain small. Membership will be as follows (with the representatives of the ministries having at least the rank of Joint Secretary/Joint Chief):

- Secretary of the Planning Division (Chair)
- Member, GED (Co-Chair)
- GED professional staff member (Member-Secretary)
- Representative of the Planning Division
- Representative of the Finance Division
- Representative of the Planning Commission (concerned sector)
- Representative of ERD
- Representative of IMED
- Representative of UNDP
- Director General of BIDS
- National Project Director
- Senior Modeling Specialist/Project Coordinator

The key roles and responsibilities of the Steering Committee are the following:

- Review achievements and progress of the project biannually;
- Approve the annual work plan of the project;
- Provide policy guidance to project management and the Coordination Committee;
- Provide guidance needed for establishing effective collaboration between the project and data producing/processing institutions, including the various wings of BBS.

A *Policy Working Group*—established under the earlier SHD Project (BGD/93/008)—proved to be an essential coordination and management mechanism. The new project will therefore continue and strengthen the Policy Working Group. Membership will include, but is not necessarily limited to, the following:

The main responsibility of the Policy Working Group will be to review the project's policy analyses/briefs and provide technical inputs to the project's policy analysis process. It will ensure that policy briefs meet Government requirements for the preparation of medium- and long-term plans and official documents. It will provide a technical framework for linking the project's quantitative output with policy development and the preparation of PRS and MDG reports. The Member, GED, will guide the establishment of the framework and collaboration among project outputs, NPFP professionals, and relevant stakeholders, including the National Steering Committee on PRS and MDG Monitoring, line ministries, UNDP, and the Local Consultative Group for finalizing the policy

briefs required for these two reports. Other Members of the Planning Commission will also provide necessary guidance to the project so that the respective sectoral policy issues are properly addressed in policy briefs issued by the project.

For smooth functioning of project activities, a *Coordination Committee* will be established, headed by the National Project Director. Committee members will include a representative of UNDP, the Senior Modeling Specialist/Project Coordinator, and representatives of GED professional staff. The Coordination Committee will meet each month to facilitate the functioning of the project by (a) reviewing project activities and work planning for each month in accordance with the work plan approved by the Steering Committee; (b) examining the status of equipment and needs for equipment replacement/repair/purchase; and (c) assessing the status of logistical arrangements and advising the project accordingly.

### III.C Financial Management

Financial management will take place in accordance with the NEX Manual and UNDP rules and procedures. In addition, GED shall submit expenditure statements to the Coordination Committee and have review meetings with the Coordination Committee at least twice each quarter. The principles of the Harmonized Approach to Cash Transfers (HACT) will be adopted as and when finalized.

### III.D UNDP Country Office Support to Project Implementation

The UNDP Country Office will provide selective assistance (as per Annex IV) to the project during implementation in accordance with NEX regulations, especially in facilitating arrangement of NEX training through project BGD/04/012, arranging oversees training (study tours, higher studies, etc.), and procurement of equipment. Specific requests for assistance will be communicated to UNDP-Bangladesh through quarterly work plans, where concrete UNDP inputs will be indicated. The project budget will cover expenses related to this support.

### III.E National Professional Project Personnel and Other Support Personnel

The Government shall depute/attach to the project ten (10) desk-level officers with strong backgrounds in economics and statistics as national counterpart officers. A priority will be placed on gender balance in the selection of these officers. Desk officers of GED may be considered, among other Government professionals. The national counterpart officers will receive training in advanced techniques of development planning and poverty/socio-economic policy analysis under the project. Their services constitute an addition to the regular personnel resources to be provided by the UNDP funded project. In addition, UNDP will provide other support personnel to assist the National Project Director and his staff. These support personnel will receive remuneration in accordance with the policies and procedures of UNDP-Bangladesh applicable for UNDP funded projects.

### PART IV. MONITORING AND EVALUATION

GED shall arrange an inception meeting during the first quarter of project implementation. The National Project Director will submit quarterly progress reports (both physical and financial), in accordance with the approved work plan, to UNDP and UNOPS. Financial Reports shall be submitted to UNDP as per UNDP rules and procedures during the first week of each quarter. Annual audits will be undertaken by the Foreign Assisted Projects Audit Division (FAPAD), and UNDP, with support from the NEX support project (BGD/04/009) of ERD, will arrange for the services of financial

advisory firm(s) as and when necessary/requested. UNDP shall provide reports on annual cost sharing apportionment to concerned donors.

The project will be subject to periodic reviews in accordance with UNDP policies and procedures for monitoring the implementation of projects and programs. A project consultant (Chief Coordinator) will prepare Annual Project Reports (APRs) and Annual Work Plans (AWPs), which will be consolidated at the Coordination Committee level and submitted to GoB and UNDP. Upon request from UNDP, GED on behalf of the designated agency will convene a meeting for the purpose of conducting a Tripartite Program Review (TPR) with participation of major stakeholders to assess the progress and effectiveness of the program against stated objectives and to provide policy guidance. TPR meetings will be held at least once each year. UNDP and project consultants will develop Result-Oriented Monitoring Indicators (ROMI) for use in monitoring project activities.

A mid-term and a final evaluation of the project will take place in accordance with UNDP policies and procedures. The organization, terms of reference, and timing of the evaluations will be determined in consultation between the Government and UNDP. A separate budget line (under the Direct Country Office Support arrangement within the NEX modality) shall reflect the resources needed for the evaluation missions. The Evaluation Teams will each consist of an international consultant as Team Leader, GOB Representative(s) and a national consultant.

### PART V. LEGAL CONTEXT

This Project Document shall be the instrument referred to as such in Article I of the Standard Basic Assistance Agreement between the Government of Bangladesh and the United Nations Development Program, signed by the parties on 25 November 1986. The host country-implementing agency shall, for the purpose of the Standard Basic Assistance Agreement, refer to the government cooperating agency described in that Agreement.

The following types of revisions may be made to this Project Document with the signature of the UNDP Resident Representative only, provided he or she is assured that the other signatories of the Project Document have no objections to the proposed changes:

- Revisions in, or addition to, any of the annexes of the Project Document;
- Revisions which do not involve significant changes in the immediate objectives, outputs or activities of the project, but are caused by the rearrangements of inputs agreed to or by cost increases due to inflation; and,
- Mandatory annual revisions, which rephrase the delivery of agreed program inputs or increased expert or other costs due to inflation or take into account agency expenditure flexibility.

This Project Document is, for all purposes related to implementation, considered to be the legal document by which UNDP and GoB will be bound. The Government of Bangladesh may prepare for its own internal planning and approval purposes a matching document such as Technical Project Proforma (TPP). All efforts must be made to ensure that the provisions of the concerned TPP prepared are identical to those in this signed Project Document. However, in the event of any discrepancies (including, but not limited to, discrepancies in terms of financial provisions) between the Project Document and the TPP, the provisions outlined in this signed Project Document shall be upheld.

### SECTION IV: COST SHARING ARRANGEMENTS

A total budget of US\$ 5 million is envisioned for the project. UNDP commits an initial contribution of US\$ 2.5 million from its own funds (TRAC). The balance is considered "cost-sharing contributions from other development partners." UNDP and the Government (ERD and GED) expect to mobilize resources from other donors interested in PRS/MDG monitoring, tracking, and reporting. In the event that the project faces a continuing funding gap, UNDP will review the situation and consider further contributions depending on resource availability.

### ANNEX I

### Arrangements for Higher Training/Studies

An important component of the project is capacity building of the professional staff of GED in particular and the Government in general. This will be pursued through training for Ph.D. degrees, training for M.S. degrees, study tours, one-year professional trainings, and/or short diploma courses in relevant areas.

The Ph.D. program will be highly selective. The project will consider only those candidates who are accepted to top-ranking graduate programs. Successful candidates will have strong backgrounds in economics and research in related fields. Adequate orientation and training in quantitative exercises and socio-economic modeling—including demonstrated proficiency in using modeling systems such as the system developed in the earlier project—shall be a prerequisite. As quality and grading systems vary significantly across universities, the grade/class obtained in previous degrees is, in many cases, an inadequate indicator for the potential or promise of individuals. As required for application to top-ranking graduate programs, candidates must take the Graduate Record Examination (GRE) and a standard language proficiency test (e.g., the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS)). The results of these tests are considered proxies for applicants' competence for rigorous Ph.D. programs. Following the norms of reputed graduate programs, the project will require candidates to achieve at least the following scores:

The project will give preference to candidates who are awarded financial assistance (e.g., graduate teaching or research assistantships providing partial or full tuition waivers and/or stipends).

For masters' degrees, the project will again consider only those candidates who are accepted to top-ranking masters' degree programs. Successful candidates will be promising government officers with strong backgrounds in economics and related areas. Preference will be given to those with working knowledge of economic modelling. Candidates for the masters' program will be required to have combined verbal and quantitative GRE scores of 1100.

Trainees for study tours and/or one-year programs of professional training on economic modelling and quantitative analysis will be selected from government officers who perform well in users' group training sessions.

The Ph.D. program will be concentrated in econometrics and/or international economics with an emphasis on modeling and forecasting. The broad areas in which the project will support the pursuit of M.S. degrees and short diploma courses include microeconomics, macroeconomics, international economics and trade, fiscal policy, monetary policy, environmental economics/green accounting, econometrics, and demography. Some of the programs will address economic diplomacy

and negotiation skills—these areas may not have direct relevance to modeling or economic analysis, but they are critical for Bangladesh's success in negotiating agreements and contracts relevant to the national economy.

A seven-member Selection Committee headed by the Secretary, Planning Division, will be responsible for selecting the candidates for higher studies based on the criteria described above. The other committee members will be the Member, General Economics Division, the Project Director (Member Secretary), representative of ERD, representative of UNDP, the Senior Policy Advisor and the Senior Modeling Specialist and Chief-coordinator.

The Ph.D. and M.S. degree program will be implemented by UNDP under the DCOS modality; the other training programs will be nationally executed (NEX modality).

Upon completion of their programs, the trained government officers must be placed in government institutions where their expertise is utilized to the maximum benefit of the nation.

Costs for PhD programs will be determined by the actual situation of particular universities and their locations. The following is sample cost structure:

Costs for the M.S. and Diploma programs will be similar but for shorter periods. M.S. and Diploma participants, however, will be discouraged from taking their spouses and children and will receive no allowances for them.

### Annex II

### Terms of Reference for International and National Consultants

The international and national consultants will form a team to analyze the poverty situation, undertake sectoral studies, frame an institutional strategy for PRS/MDG implementation, monitoring, and tracking, and develop new modules to be integrated with the existing modeling system. They will also train Government professionals so that quantitative analysis of the socio-economic situation and model building/updating become continuous and integral functions of the General Economics Division (GED) of the Planning Commission. This will ensure that GED will deliver quality outputs as a modern decision support institution of the Government for socioeconomic policy planning (particularly in preparing Poverty Reduction Strategies and PRS/MDG monitoring and tracking).

# 1. SENIOR MODELING SPECIALIST AND CHIEF COORDINATOR (SMSCC)

The International Senior Modeling Specialist and Chief Coordinator (SMSCC) will be located in GED. S/he will provide overall technical advice and oversight support under the direct supervision of the National Project Director (NPD) and/or the Deputy Project Director (DPD) and UNDP management. The principal responsibility of the SMSCC will be to undertake socioeconomic policy analysis and modeling to help identify alternative policy options and growth paths. S/he will also be responsible for overall coordination of the advisory services and technical assistance part of the project in consultation with the Chief Technical Supervisor (CTS) and the Coordination Committee. Assisting the CTS in designing and developing an integrated analytical framework will be another major responsibility of SMSCC. The SMSCC will also contribute to the development of a flow-of-funds Social Accounting Matrix (SAM) and Financial Computable General Equilibrium (CGE) model and provide related training.

- 1. Coordinate advisory services and technical assistance, including the tasks of national and international experts/consultants.

### 2. SENIOR ECONOMIST

The International Senior Economist will be located in GED. The principal responsibility of the Senior Macroeconomist will be to contribute to the development of a consistent macroeconomic framework for analyzing the short-, medium-, and long-term impacts of alternative monetary, fiscal, and trade policies on the economy. Other major areas of responsibility include the interpretation of model-generated results and guiding the modeling and analytical activities of GED to meet the requirements of PRS/MDG monitoring and the preparation of future PRSs.

The International Chief Technical Supervisor (CTS) will be located in GED. The SMS will assist the CTS in designing and developing an integrated analytical framework and will have responsibility for developing a flow-of-funds matrix and financial CGE. S/he will also provide training to Government officers and work in close cooperation with other consultants in the project.

### 6. ECONOMIST (ECONOMETRICS AND TRADE)

The International Economist (Econometrics and Trade) will be located in GED and will reside in Bangladesh. Estimation of parameters used in the modeling system and updating the socioeconomic database will be the principal responsibilities of the Economist. S/he will engage in other activities related to data and econometric estimation and will provide training on related methodologies to selected Government officers. S/he will also be responsible for mainstreaming trade policy issues in the modeling system.

- 9. Lead the trade-related aspects of the project's sectoral studies, particularly those related to trade negotiations and globalization;
- 10. Undertake other activities as required by the NPD and/or project management.

- 1. The Economist will be a reputed economist with extensive experience in econometric analysis and international economics;
- 2. Ph.D. degree in econometrics or economics with an emphasis on econometrics from a reputable university;
- 3. At least 10 years of experience in econometric modeling, data management, and applications;

- 5. Competence with econometric software (STATA, LIMDEP, E-VIEWS, MICRO FIT, etc.)

## 7. POVERTY ANALYSIS & MONITORING SPECIALIST (PAMS)

The International Poverty Analysis and Monitoring Specialist (PAMS) will be located in GED and will reside in Bangladesh. The principal responsibility of the PAMS will be to advise and assist other international consultants on the theoretical and operational aspects of poverty measurement. The PAMS will prepare templates of poverty estimates by different measures using data from household income and expenditure surveys, labor force surveys, poverty monitoring surveys, etc. The PAMS will engage in other activities related to data and econometric estimation and will provide training on related methodologies to selected Government officers.

### 8. SENIOR POLICY ADVISOR (SPA)

The Senior Policy Advisor (SPA) will be a national consultant located in GED and resident in Bangladesh. The principal responsibility of the SPA will be to assist and advise the Project Director and team in project implementation, coordinating with data producing agencies, and interacting with various stakeholders.

### Dear Dr. Rahman,

- 1.
