Brief Description of Initiation Plan

Bangladesh is a ratifying party to all the three Rio Conventions (RCs), namely United Nations Framework Convention on Climate Change (UNFCCC), Convention on Biological Diversity (CBD) and the United Nations Convention to Combat Desertification (UNCCD), along with other Multilateral Environmental Agreements (MEAs). The Rio Conventions and their protocols collectively set the overall context for Bangladesh's global environmental management, as the natural resource management regime is guided by these key global documents, translated as national level policies, strategies and plans. However, the country's capacity is still limited, along with the institutional and human resources, to implement the MEAs and national policy instruments effectively. There is a need for the local level and national institutions and researchers to further understand and internalize the issues of climate change, biodiversity conservation and land degradation. In order to better understand the dynamics behind the threats to Bangladesh's environment vis-à-vis global environment, the Government of Bangladesh (GoB) completed a GEF/UNDP supported National Capacity Self-Assessment (NCSA) Project. Through a broad-based consultative and participatory process, the Bangladesh NCSA identified the salient features of obligations under RCs, priority environmental issues, capacity development needs, either common to or cutting across the climate change, biodiversity and land degradation thematic areas. Based on this analysis, the GoB has developed a Capacity Development Action Plan (CDAP) to address these prioritized issues and capacity needs to fulfill Bangladesh's responsibilities and commitments toward implementing the Rio Conventions. Specifically, the CDAP identified six priorities for cross-cutting capacity development. This proposed project responds to the first and fourth priorities, i.e.: (1st) Trained and skilled manpower for sustainable environmental governance in place and (4th) Promotion of education, training and public awareness. Moreover, the CDAP strongly recommends an approach to capacity development through existing national training institutes, this project implements that recommended approach.

B. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe the PPG activities and justifications: The PPG will cover the following preparatory activities:

- 1. Baseline Studies and Strategy Development:
- A) Mainstreaming global environmental conventions into the vocational training and re-training structures for public institutions in Bangladesh:
- prepare institutional map of all institutions capable of providing training for public institutions on the Rio Conventions;
- assess existing curricula and human resources for delivering training on the Rio Conventions, including mainstreaming into the training of other sectors;
- design detailed project strategy for mainstreaming global environmental conventions into vocational training and re-training structures in Bangladesh.
- B) Mainstreaming global environmental conventions into human resources development systems for grassroots sustainable development practitioners:
- identfy sustainable development practitionners at the grassroots level and assess their approach to the global environment conventions;
- identify entry points for developing the capacity of sustainable development practitioners;
- design detailed project strategy for mainstreaming global environment conventions into activities of sustainable development practitioners through training and capacity development.
- C) Improved multi-sectoral environmental policies and programmes, and associated governance structures:
- identify the related ongoing interventions in the country;

- for these ongoing interventions, assess the M&E and knowledge management mechanisms;
- propose a mechanism for capturing all lessons from ongoing related interventions;
- design detailed project strategy to develop a system for capturing lessons from projects and programmes so the lessons can contribute to policy development and goverance structures.
- 2. Determination of partnerships, linkages and synergies:
- Through detailed discussion and dialogue, establish clear linkages between this project and the workprogramme of the Department of Environment, particularly with its efforts to coordinate implementation of the Rio Conventions;
- Determine the linkages between and amongst the project partner agencies, notably between the IUCN and the many involved local NGOs and CBOs;
- Develop close working synergies with the Bangladesh Green Development Programme (BGDP) (note: the BGDP is the UN's key vehicle for contributing to the Bangdladesh Climate Change Strategic Action Plan).
- 3. Secure government commitment to project strategy and to project implementation arrangements:

Make contact with key agencies. Negotiate with key government representatives to ensure full agreement on the project objectives, outcomes, outputs, and activities, including partnerships for support and government co-financing. Undertake consultations with key government representatives to secure agreement on project implementation arrangements, including roles, responsibilities, and accountabilities of lead and partner agencies.

4. Explore, and if feasible, secure bilateral and multilateral financing opportunities:

Explore potential for partnerships with bilateral and multilateral donor agencies and organizations. Negotiate partnerships with on-going projects to re-align their activities to meet project objectives. If appropriate, finalize co-financing agreements. Determine linkages with ongoing and planned projects, including the soon-to-start Bangladesh Green Development Programme.

- 5. Determine baseline value for the pertinent UNDP/GEF CD Indicators.
- 6. Define Monitoring and Evaluation (M&E) Plan:

Define a detailed M&E work plan and delivery strategy, including clear identification of responsibilities and accountabilities, as well as an appropriate budget allocation (based on best practices and UNDP guidelines). The Plan will reflect the requirements of the GEF M&E Policy and Capacity Building M&E framework. The Plan will also include provisions for an independent evaluation and provision to ensure the learning of lessons from implementation at both the mid-point and termination of the project.

M&E will be based on the Capacity Development indicators and the Capacity Development Scorecard (GEF Tracking Tool) prepared by UNDP and GEF and UNEP. The baseline and targets will be determined during this PPG phase.

7. Define Sustainability Plan:

The Sustainability Plan will outline an exit strategy, leading to the continuation of concerned activities without the need of long-term international financing.

8. Validation workshop

The workshop will gather representatives from all relevant stakeholders to present, discuss and validate the final draft proposal.

The final product of the proposed PPG phase will be a UNDP/GEF compliant medium-sized project document for submission to UNDP and GEF, including the following:

- A detailed work plan with detailed roles and responsibilities for project implementation;
- · A targeted, in-depth analysis of the baseline situation and needs;
- · An updated report on the partnership and co-financing opportunities for the proposed project;
- Explicit specification of all capacity building activities to be financed under the project and the rationale of their additionality to meeting Rio Convention objectives;
- A detailed deconstruction of the project strategy using the Logical Framework Approach (log frame);
- · A detailed monitoring and evaluation plan for the project that builds upon the log frame;
- · A stakeholder participation plan;
- Endorsement letters from the government and letters confirming co-financing commitments;
- Medium-Size Project document per GEF and UNDP formatting and submission requirements;
- Terms of Reference for key project staff, project management committee and key consultants.
