Summary of LPAC member comments on DRRF:

The LPAC meeting discussed the proposed four-year (2018-2022) project titled "Disaster Response and Recovery Facility (DRRF)". UNDP Deputy Country Director presented the opening remarks following a round of introductions by the committee members. Khurshid Alam, ACD, made the presentation of the DRRF, which also included the achievements and lessons learned from the previous interventions through the Early Recovery Facility (ERF) (see Annex).

During the LPAC, the following comments were noted:

Ministry of Disaster Management & Relief (MoDMR) representative gave the following comments:

- MoDMR suggested to include IMED and Planning Commission in the project's Advisory Board for better monitoring and coordination.
- MoDMR suggested to specify the details of the line ministries and private sectors to be included in the project's Advisory Board.

In response, UNDP clarified that private sectors and other relevant line ministries are not selected beforehand. It was agreed that in the first project advisory meeting, UNDP, MoDMR and ERD, will discuss on the membership of private sector and other ministries in the Board.

- The ERD representative gave the following comments:
 - ERD noted DRRF as a relevant and timely initiative. It appreciated DRRF's focus on the private sector engagement and engagement of NGOs for implementation for timely and effective recovery support at scale;
 - ERD requested for a brief explanation on comparative analysis between ERF and the proposed DRRF based on: i) key lessons learned and ii) the proposed project's value addition.

In response, UNDP referred that project has earned many lessons like post disaster recovery need to have the holistic approach including private and public infrastructure and private sector engagement is essential for preparedness to recovery. The project will now not only focus on early recovery — but also full recovery with economy-wide approach.

It also noted that: i) DRRF complements ongoing initiatives such as the National Resilience Programme (NRP) which is designed to reduce disaster risk and ii) DRRF's focus onbroader post disasterrecovery including needs assessment, timely response, integrated recovery and innovation iii) Project puts priority in Urban and mega disaster with diversified hazards. The project emphasizes on timely resource mobilization from international sources by meeting donors' requirements of independent assessments as proof of damage for disbursing recovery financing. The project will further enhance capacity of the government on preparedness for recovery as outlines in Disaster Management Act and Standing Order on Disaster.

ERD explained their internal procedure that may be needed their endorsement for projects.

In response, UNDPclarified that DRRF will follow a DIM modality and made justification based on its relevance in in disaster response and recovery. Under this modality, ERD recently signed several UNDP projects by providing a concurrence letter. UNDP made suggestion that ERD could consider following the same procedure for DRRF.

Noting the late sharing of the final draft project document, UNDP offered to have a follow up meeting with ERD, if required, where UNDP can provide clarification on DRRF. It was highlighted that the current project (ERF) will end on 30 June 2018, and it is not possible to allow a gap in between, given many ongoing activities. In this regard, if the DRRF cannot be approved by the end of June, UNDP requested ERD to explore alternative which further extend the ERF, until all the necessary procedures are completed for the DRRF to be launched.

MoDMR provided its full endorsement for the project. ERD requested NOC from MoDMR which MoDMR agreed to provide soon the meeting minutes is shared.

- Other comments included the following:
 - o It was recommended that the project establish clear links with the projects that DRRF will complement;

 - DRRF's flexible approach and conceptual framework was appreciated;
 DRRF will serve as a platform to launch various innovative approaches to DRR e.g. innovation in cash transfer, continued use of pre-qualified NGO roster.
 - The first Project Board meeting will select criteria for supporting small and medium size enterprise and private sector, when resources are available to provide them recovery assistance

3. Final LPAC recommendation(s):

- "Disaster Response & Recovery Facility" (DRRF) project faces no objection endorsed in the meeting considering its topmost priority to achieve SDGs.
- UNDP will implement the project through DIM modality, but will full ownership of key Government counterparts (MoDMR and ERD) and provide regular updates oninitiatives and progress through the project board;
- The first project meeting of the project Advisory Board following DRRF's implementation will finalize partnerships (private sector and line ministries)
- Meeting minutes will be circulated to government counterparts;
- UNDP will follow up with ERD for concurrence and next steps of ERD's endorsement.
