**Brief Description**

The "Extension" of the mentioned project will consolidate the results (and outcomes) that have been achieved under project "Support to the Development of the National Childhood Strategy and the National Strategy for Persons with Disabilities for the Kingdom of Bahrain".

Project activities will strengthen the capacity of all relevant stakeholders to implement the recently formulated strategies on childhood, disability and elderly. Activities will focus on improving coordination among stakeholders, establishing of effective and sustainable institutional arrangements for the implementation of strategies, promoting results and evidence based service delivery and establishing effective policy making, planning and practice.

Project activities in the extension period will be carried out in the framework of the outcomes of the existing project and will be guided by the same goals and principles. A new set of outputs (and activities) and a new budget have been developed for the project extension.

## **Justification for the extension**

After the successful development of the National Strategies for Childhood, Persons with Disabilities and the Elderly, the Government of the Kingdom of Bahrain, particularly the Ministry of Social Development, has prioritized their implementation with the objective of delivering expanded and improved social services to the people of Bahrain.

The implementation phase is expected to become more complex than the formulation phase because it involves the management of a large number of activities and a significant amount of funds across many areas, the coordination of many stakeholders, the operation of an extensive monitoring and evaluation framework, structural changes in a number of programmes and institutions, revisions of the legislative framework, etc. In this context, the Ministry of Social Development, which is the government body that led the formulation of the strategies and coordinates their implementation, has requested UNDP to extend its support in the current project to prepare for the implementation process and to put in place the mechanisms needed for implementation and coordination.

In response to the Ministry's request and based on its country programme and strategic priorities, UNDP Bahrain will continue providing support for the implementation of the three strategies in a holistic approach. The implementation process will further strengthen the capacity of governmental and non-governmental stakeholders. The Ministry of Social Development will continue to be the main partner through which UNDP Bahrain's support in the social sector will be delivered.

Thus, UNDP and the Ministry will extend the current project; Support to the Development of the National Childhood Strategy and the National Strategy for Persons with Disabilities for the Kingdom of Bahrain, for one year to ensure the initial preparatory stage of the implementation of the three strategies, and to facilitate a smooth transition from the development of strategies and set up of mechanisms, to the implementation of the mentioned strategies..

The extension of the current project will reinforce the outcomes that have been achieved so far and will lay the foundations for the activities that will follow in the new project. Project activities in the extension period will be carried out in the framework of the current Project Document and will be guided by the same principles.

MoSD and UNDP Bahrain, in close cooperation with other government institutions and non-governmental stakeholders, have identified the below key activities for the extension period:

- Strengthened coordination for implementation among all relevant stakeholders;
- Establishment of effective and sustainable institutional arrangements for the implementation of strategies;
- Results and evidence based service delivery;
- Effective policy making, planning and practice.
