

# **Project Inception Report**

## **Enabling Activities for the Preparation of The Bahamas' Second National Communication [PIMS 3212 CC EA]**

### **1. Schedule of project review meetings**

#### **(i) Steering Committee Meetings**

Steering Committee meetings will be held every two months. Inter-sessional meetings will be called, as necessary.

#### **(ii) Project related Monitoring and Evaluation activities**

Monitoring and evaluation activities will include quarterly reports and the inception report as well as any other reports or evaluations of project implementation as requested by Project Steering Committee, National Executing Agency and United Nations Development Program.

### **4. Monitoring and evaluation requirements for first year**

Four quarterly reports, the project inception report and an audit report will be required for submission to UNDP in the first year.

### **5. Project-related Partners**

#### **(i) Institutional roles & responsibilities**

The Executing Agency for the project is the Bahamas Environment, Science and Technology (BEST) Commission, Office of the Prime Minister. Executing Agency inputs include counterpart support, including allocation of technical experts, communication, office facilities, secretarial/administrative services, expertise in certain areas, and information services.

The National Climate Change Committee (NCCC) established in the course of The Bahamas' FNC preparation serves as the Project Steering Committee (PSC) and oversees the project implementation and ensures inter-agency coordination.

The UNDP Country Office in Jamaica serves as Implementing Agency for the GEF.

A Project Coordinator (PC) has been selected based on technical and organizational capabilities. The PC is a member of and serves as secretary to the PSC. The PC coordinates project activities among governmental agencies and other participants.

A National Technical Committee (NTC) consisting of individuals with expertise from the following sectors has been established - Government agencies: BEST Commission, Department of Agriculture, Department of Environmental Health Services, Department of Lands and Surveys, Department of Meteorology, Department of Statistics, Department of Education, Road Traffic Department, Ministry of Health, Ministry of Tourism, Bahamas Electricity Corporation,

Water and Sewerage Corporation, Office of the Prime Minister; NGOs: The Bahamas National Trust, The Nature Conservancy; and private sector organizations: Central Bank of The Bahamas, Grand Bahama Power Company. The NTC, supported as needed by national and international expertise, will be used to the extent possible to carry out the specific analyses called for as part of the project.

Team Leaders for GHG Inventory and Vulnerability and Adaptation Assessment will be engaged to provide technical input, consultations, background paper preparation, deliver project output as coordinated by the PC. They will closely interact as well as assist and monitor the activities of NTC in order to ensure quality outputs following the UNFCCC guidelines as outlined in Decision 17CP/8.

(ii) Coordinating actions & feedback mechanisms

The Project Steering Committee (PSC) functions to guide project implementation. The Committee works closely with the Project Coordinator, National Technical Committee (NTC) and Team Leaders to ensure the project is progressing as it should. There is regular dialogue through meetings and e-mail communications between all these players to provide constant feedback on project deliverables and tasks. Both the PSC and NTC are inter-agency with representation from a number of sectors as outlined above.

*3.2.4 Decide on the Tier level based on the IPCC Good Practice Guidance PG.*

8. Project establishment and start-up activities, and an update of any changed external conditions that may effect project implementation.

The first disbursement for the project was received in October 2006 and thus this needs to be the official start date of the project; this would mean the project end date would be August 2009 instead of April 2009. The first year of the project therefore runs from October 2006 to September 2007. The Project Coordinator was not appointed until July 2007. Project activities occurred from October 2006 to June 2007, but on a limited basis. The project is currently behind schedule, but the Project Steering Committee, National Technical Committee and GHG Inventory Team Leader have committed to work along with the Project Coordinator and to increase the frequency of working sessions so that by December 31<sup>st</sup>, 2007, the project can be back on schedule according to the workplan.

An Impact Assessment Framework workshop is schedule for November 2007 to enable completion of this project deliverable. This workshop will be conducted with high-level decision makers within national agencies. The workshop and follow-up meetings, as necessary, will enable the PSC to complete the Impact Assessment Framework as well as to identify practical indicators to assess the impacts of the SNC in incorporating climate change concerns into development and sectoral planning.

The PSC also intends to participate in a meeting being organized by the regional climate change center for dissemination of information relevant for inclusion in the SNC. The Bahamas SNC project intends to fund participation for four (4) individuals in this meeting.

Other activities scheduled for October through December 2007 include:

- a) Submission of National Circumstances document by Minister responsible for the environment for political endorsement by November 2007. It is hoped that this component of the SNC will be endorsed by January 2008; and
- b) Continued work to complete GHG Inventory.
