Justification:

SPWCC, in its attention to continue to work on laying down the foundations for creation of adequate witness/victim support and protection mechanism(s) throughout BiH local level courts and prosecutors' offices, will establish additional witness support offices at 2 locations in Federation of BiH and in RS, using experiences and lessons learnt from the previous Pilot Project. This will concretely entail coordination, grounding meetings and consequent signing of memoranda of understanding with implementing partners, employment, training and supervision of witness support specialists, possible interior interventions and furnishing of witness support offices (working office and waiting room for the witnesses), training of judges and prosecutors and building of witness support network that includes relevant governmental and non-governmental institutions that come into contact with witnesses/victims amounting 100,000.00 USD during the period of 11 months.
