# AMENDMENT NO 3 TO THE THIRD-PARTY COST-SHARING AGREEMENT

#### BETWEEN

The Swiss Confederation, represented by the Swiss Federal Department of Foreign Affairs, acting through the SWISS AGENCY FOR DEVELOPMENT AND COOPERATION (SDC) (THE DONOR)

#### AND

### THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

WHEREAS the Donor hereby agrees to contribute funds to UNDP on a cost-sharing basis (hereinafter referred to as "the Contribution") for the implementation of Integrated Local Development Project (ILDP) Phase II (hereinafter referred to as "the Project"), as described in the Project document Award ID BIH10/00093067<sup>1</sup> Project ID BIH10/00082160 - Integrated Local Development Project (ILDP) Phase II, in Bosnia and Herzegovina, and as attached as Annex I<sup>2</sup>,

WHEREAS UNDP is prepared to receive and administer the Contribution for the implementation of the Project.

WHEREAS the Government of Bosnia and Herzegovina has been duly informed of the Contribution of the Donor to the Project,

WHEREAS UNDP shall designate an Implementing Partner for the implementation of the Project (hereinafter referred to as the "Implementing Partner"),

WHEREAS certain provisions of the above mentioned Agreement will be replaced to read as in below;

The project document is formally annexed to this Agreement.

WHEREAS all provisions of the Agreement not amended herein remain unchanged and valid;

NOW THEREFORE, UNDP and the Donor hereby agree as follows:

## Ad Article III. Administration and reporting

The paragraph 2.1, section (a) of the Article III is hereby amended to read as follows:

2.1

(a) From the country office annual status reports of Project progress for the duration of this Agreement, as well as the latest available approved budget. The annual progress reports will consist of operational and financial reports. The reports will be submitted to the donor on the following dates: for the first year of implementation (Jan. 2012-Dec. 2012) by 28<sup>th</sup> February 2013; for the second year of implementation (Jan. 2013-Dec. 2013) by 28<sup>th</sup> February 2014; for the third year of implementation (Jan. 2014-Dec. 2014) by 28<sup>th</sup> February 2015; for the fourth year of implementation (Jan. 2015-Dec. 2015) by 28<sup>th</sup> February 2016; for the fifth year of implementation (Jan. 2016-Dec. 2016) by 28<sup>th</sup> February 2017; for the sixth year of implementation (Jan. 2017-Feb. 2017) by 30<sup>th</sup> April 2017; final progress report within 90 days after completion of the Project; inputs for the SDC End of Phase Report; additional reports upon request of SDC.

#### Ad Article XII. Entry Into Force and Duration

The paragraph 1 the Article XII is hereby amended to read as follows:

This Agreement shall enter into force upon signature and deposit by the Donor of the first Contribution-payment to be made in accordance with the schedule of payments set out in Article I, paragraph 1 of this Agreement and the signature of the Project document by the concerned parties. It covers the period from 1<sup>st</sup> January 2012 to 28<sup>th</sup> February 2017 and shall expire as soon as all mutual obligations are fulfilled.
