This Contract is entered into on 25th February, 2013 between Women's Issues Network of Belize through the Project "Strengthening Women's Representation in National Leadership in Belize" (hereinafter referred to as "WIN-Belize") and <u>Carmen Barrow</u> (hereinafter referred to as "the Individual Contractor") whose address is 56 Perez Road, Ladyville, Belize.

WHEREAS WIN-Belize desires to engage the services of the Individual Contractor on the terms and conditions hereinafter set forth, and:

WHEREAS the Individual Contractor is ready and willing to accept this Contract with WIN-Belize on the said terms and conditions,

NOW, THEREFORE, the Parties hereby agree as follows:

1. Nature of services

The Individual Contractor shall perform the services as described in the Terms of References which form an integral part of this Contract and are attached hereto as *Annex I* in Belize

2. Duration

This Individual Contract shall commence on 25th February, 2013 and shall expire upon satisfactory completion of the services described in the Terms of Reference mentioned above, but not later than 31st July, 2014 unless sooner terminated in accordance with the terms of this Contract. This Contract is subject to the General Conditions of Contract for Individual contractors.

3. Consideration

As full consideration for the services performed by the Individual Contractor under the terms of this Contract, including, unless otherwise specified, his/her travel to and from the Duty Station any other travel required in the fulfillment of the Terms of Reference in Annex I, and living expenses in the Duty Station, UNDP shall pay the Individual Contractor a total of US \$7,000.00 in accordance with the table set forth below. Payments shall be made following certification by UNDP that the services related to each Deliverable, as described below, have been satisfactorily performed and the Deliverables have been achieved by or before the due dates specified below, if any.

Strengthening Women's Representation in National Leadership in Belize

Terms of Reference: Consultant- Advocacy, Outreach and Media Campaign

Project Description:

Women in Belize have had low and even no representation in the national assembly because there is still a prevailing societal perception that women are not capable of being in leadership positions. The project therefore will address this critical socio-cultural issue in particular recognizing that the existing democratic system does not support gender equality at the highest level of decision-making. These structural, cultural and social barriers impede women's successful entry and presence at the highest levels of leadership such that women struggle to gain the support of their families and political parties to endorse their candidacy for political office; in indigenous communities, women often cannot hold public leadership positions and are expected to stay in the home.

A critical path to increasing women's participation in politics will be through changing local mind set and attitude toward women in political leadership. Therefore, the newly formed advocacy group will influence local attitude through active, ongoing outreach and sensitization campaigns. The campaign will build on the findings of three recent and critical research documents that have been produced: A Situational Analysis of Gender and Politics in Belize; Belize Gender Assessment and MDG Scorecard. All three documents identify challenges and barriers that preclude women from actively participating in national leadership and democratic processes in Belize. This rich body of knowledge will be the core reference for a media and communication experts that the project will contracted to roll out this output by formulating a responsive communication strategy in response to the recommendations of these findings highlighting key messages to foster attitudinal, cultural and structural change.

The advocacy campaign will include print media in the form of publications in the four leading newspapers that will increase the knowledge of women and the broader public of women on politics and democratic rights, CEDAW and MDG related human rights instruments. Print materials will also be created on the revised electoral legislation and the national governance framework that will educate the general public on the inclusive agenda with the proposed special temporary measures. These brochures and pamphlets will be distributed countrywide along with the newspapers. Television and radio spots will be produced and aired on the five radio stations and five television stations to sensitize the entire country, rural and urban areas on women and politics and democratic rights, the revised electoral legislations and the national governance framework inclusive agenda.

Scope of Work:

- a. Review Situational Analysis of Gender and politics in Belize; Belize Gender Assessment and MDG Scorecard to identify the challenges and barriers that preclude women from actively participating in National Leader and democratic processes in Belize.
- Develop and produce campaign strategy based on findings of documents in (a).

- c. Facilitate the development of and develop flyers, pamphlets, brochures, posters for distribution and write content for website and facebook page.
- d. Provide support to project team on making public media appearances.
- e. Provide support for the adoption of recommendations made during National Dialogue; develop and implement an action plan using recommendations.
- f. Strengthen strategic alliances within political parties, civil society organizations, media houses and national government.
- g. Manage every aspect of the campaign in their designated issue areas, including (but not limited to) making a campaign plan.
- h. Collaborate with the Outreach Coordinator, Video Producer, Advocacy body and Artist on advocacy strategy and content for video documentations on revised legislation and national governance framework and to design radio and television spots and messages.
- i. Monitor the latest news in the designated issue areas; look for opportunities for activism.

Expected Outputs and Deliverables:

- a. Plan of action for the advocacy, outreach and media campaign
- b. Flyers, pamphlets, brochures, information on website and facebook page
- c. DVD tapes on radio and television appearances
- d. Adoption agreement of recommendations
- e. Video documentation on revised legislation and national governance framework; radio and television spots and messages
- f. National consultations with political parties, civil society organizations, media houses and national government
- g. Comprehensive contact list of strategic alliances
- h. Comprehensive reports

Institutional Arrangement:

- a. The Consultant will report directly to the Executive Director of WIN-Belize.
- b. The Consultant will attend meetings of Project Execution Board as needed.
- c. The Consultant will attend meetings of the advocacy body

Duration of Work: Eighteen months

Basic Information Regarding Consultancy

Project and Title: Strengthening Women's Representation in National Leadership

Duration of assignment: The consultant is expected to work for a total of 35 days.

Brief description of the services requested from the consultant: To develop and produce campaign strategy based on findings in the Situational Analysis of Gender and Politics in Belize; Belize Gender Assessment and the MDG Scorecard. The consultant will also be expected to collaborate with the Outreach Coordinator, video producer and advocacy body to develop content for media messages.
