AMENDMENT TO THE CONTRACT BETWEEN

THE SWISS CONFEDERATION REPRESENTED BY THE FEDERAL DEPARTMENT OF FOREIGN AFFAIRS, ACTING THROUGH THE SWISS AGENCY FOR DEVELOPMENT AND COOPERATION SDC (THE DONOR)

AND

UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

Reference is made to the Cost Sharing Agreement (hereinafter "Agreement) dated in 18th October 2013 signed between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and the SWISS CONFEDERATION REPRESENTED BY THE FEDERAL DEPARTMENT OF FOREIGN AFFAIRS, ACTING THROUGH THE SWISS AGENCY FOR DEVELOPMENT AND COOPERATION SDC, with respect to the Project BOL/87369 "Strenghening the National First Response and Emergency Preparedness System", and as per Article X of the Agreement, any modification to this Agreement shall be made in writing between both parties and duly signed by the authorized representatives of the Donor and UNDP.

Therefore Parties hereby agree on the following;

WHEREAS the donor and UNDP now wish to amend the said Agreement in order to:

- a) Extend the duration of the Project to 31 December 2018.
- b) Increase the total amount of the Project in USD 788.000 (Seven hundred eighty-eight 00/100 United States Dollars)
- c) Change the currency from Swiss Franc (CHF) to United States Dollars (USD).
- d) The last disbursement will be made three months before concluding the agreement

WHEREAS such Amendment will result in an increase of USD 788,000 making this amended Agreement total USD 1,219,868

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows: [Reference is made to the new clause]

Article I. The Contribution

1. (a) The Donor shall, in accordance with the schedule of payments set out below, contribute to UNDP the amount of USD 2.007.868. The contribution shall be deposited in the

THIRD-PARTY COST-SHARING AGREEMENT

BETWEEN

NOW THEREFORE, UNDP and the Donor hereby agree as follows:

Article L. The Contribution

(a) The Donor shall, in accordance with the schedule of payments set out below, contribute to UNDP the amount of CHF 1,101,548 (One million one hundred and one thousand five hundred forty 06/196 Swim Franc). The contribution shall be deposited in the

- 2. The value of the payment, if made in a curroccy other than United States dollars, shall be determined by applying the United Nations operational rate of exchange in effect on the date of payment. Should there be a change in the United Nations operational rate of exchange prior to the full utilization by the UNDP of the payment, the value of the balance of funds still held at that time will be adjusted accordingly. If, in such a case, a loss in the value of the balance of funds is recorded, UNDP shall inform the Donor with a view to determining whether any further financing could be provided by the Donor. Should such further financing not be available, the assistance to be provided in the project may be reduced, suspended or terminated by UNDP.
- The above schedule of payments takes into account the requirement that the payments shall be made in advance of the implementation of planned activities. It may be amended to be consistent with the progress of project delivery.
- UNDP shall receive and administer the payment in accordance with the regulations, rules and directives of UNDP.
- All financial accounts and statements shall be expressed in United States dollars.

Article II. Utilization of the Contribution

- The implementation of the responsibilities of UNIDP and of the Executing Entity /Implementing
 Partner pursuant to this Agreement and the project document shall be dependent on receipt by UNIDP of
 the contribution in accordance with the schedule of payment as set out in Article I, paragraph 1, above.
- If unforeseen increases in expenditures or commitments are expected or realized (whether owing to inflationary factors, fluctuation in exchange rates or unforescen contingencies), UNDP shall submit to

the Donor on a timely basis a supplementary estimate showing the further financing that will be necessary. The Donor shall use its best endeavours to obtain the additional funds required.

- 3. If the payments referred to in Article I, paragraph I, above are not received in accordance with the payment schedule, or if the additional financing required in accordance with paragraph 2 above is not forthcoming from the Donor or other sources, the anissance to be provided to the project under this Agraement may be reduced, suspended or terminated by UNDP.
- Any interest income attributable to the contribution shell be credited to UNDP Account and shall be utilized in accordance with established UNDP procedures.

Article III. Administration and reporting

- Project management and expenditures shall be governed by the regulations, rules and directives of UNDP and, where applicable, the regulations, rules and directives of the Executing Entity/ Implementing Patters.
- UNDP headquarters and country office shall provide to the Donor all or parts of the following reports prepared in accordance with UNDP accounting and reporting procedures.
 - 2.1 For Agreements of one year or less:
 - (a) From the country office (or relevant unit at headquaters in the case of regional and global projects) within six months after the date of completion or termination of the Agreement, a final report summerizing project activities and impact of activities as well as provisional financial date;
 - (b) From UNDP Bureau of Management/Office of Finance and Administration, in annual cartified financial statement as of 31 December to be submitted no later than 30 June of the following year;
 - (o) From UNDP Bureau of Management/Office of Finance and Administration on completion of the project, α certified financial statement to be submitted no later than 30 June of the year following the financial closing of the project.
 - 2.2. For Agreements of more than one year:
 - (a) From the country office (or relevant unit at headquarters in the case of regional and global projects) an annual status report of project progress for the duration of the Agreement, as well as the latest available approved budget.
 (b) From UNDF Bureau of Management/Office of Finance and Administration, an
 - (b) From UNDF Bureau of Management/Office of Finance and Administration, an annual certified financial statement as of 31 December every year to be submitted no later than 30 June of the following year.

(c) From the country office (or relevant unit at headquarters is the case of regional and global projects) within six months after the date of completion or termination of the Agreement, a final report narrowarizing project activities and inspect of activities as well as provisional financial data.

inspect of activities as well as provisional financial data.

From UNDP Bureau of Management/Office of Finance and Administration, on completion of the project, a cartified financial statement to be submitted no later than 30 have of the year following the financial closing of the project.

If special circumstances so warrant, UNDP may provide more frequent reporting at the expense
of the Donor. The specific nature and frequency of this reporting shall be specified in an annex of the
Agreement.

Article IV. Administrative and support services

- I. In accordance with the decisions and directives of UNDP's Executive Board reflected in its Policy on Cost Recovery from Other Resources, the Contribution shall be subject to cost recovery for indirect costs incorred by UNDP headquarters and country office structures in providing General Management Support (CIMS) services. To cover these GMS costs, the contribution shall be charged a fee equal to 7%. Furthermore, as long as they are unequivocally linked to the specific project, all direct costs of implementation, including the costs of successing entity or implementing partner, will be identified in the project budget against a relevant budget line and borne by the project accordingly.
- 2. The aggregate of the amounts budgeted for the project, together with the estimated costs of reinformement of related support services, shall not exceed the total resources available to the project under this Agreement at well as funds which may be available to the project for project costs and for support costs under other sources of financing.

Article V. Evaluation

All UNDP programmes and projects are avaluated in accordance with UNDP Evaluation. Policy, UNDP and the Government of Bolivis in consultation with other stakeholders will jointly agree on the purpose, use, timing, financing machanisms and terms of reference for evaluating a project including an evaluation of its contribution to as outcome which is listed in the Evaluation Plan. UNDP staff commission the evaluation, and the evaluation exercise shall be carried out by external independent evaluaters.

Article VL Equipment

Ownership of equipment, supplies and other properties financed from the contribution shall went in UNDP. Matters relating to the transfer of ownership by UNDP shall be determined in accordance with the relevant policies and procedures of UNDP.

Article VII. Auditing

The contribution shall be subject exclusively to the internal and external sudding procedures provided for in the financial regulations, rules and directives of UNDP. Should the biconial Audit Report of the Board of Auditors of UNDP to its governing body contain observations relevant to the contributions, such information shall be made available to the Donor.

Article VIII. Completion of the Agreement

- 1. UNDP shall notify the Donor when all activities relating to the project have been completed.
- Notwithstanding the completion of the project, UNDP shall continue to bold usualized payments
 until all commitments and liabilities incurred in the implementation of the project have been satisfied and
 project activities brought to an orderly conclusion.
- If the unutilized psyments prove insufficient to meet such commitments and liabilities, UNDPshall notify the Donor and consult with the Donor on the manner in which such commitments and liabilities may be satisfied.
- Any payments that remain unexpected after such commitments and liabilities have been satisfied shall be disposed of by UNDP in consultation with the Donor.

Article IX. Terminadon of the Agreement

- After consultations have taken place between the Denor, UNDP and the programme country Government, and provided that the payments already received are, together with other funds available to the project, sufficient to succe all commitments and liabilities incurred in the implementation of the project, this Agreement may be terminated by UNDP or by the Donor. The Agreement shall cease to be in force 30 (thirty) days after either of the Parties have given notice in writing to the other Party of its decision to terminate the Agreement.
- 2. Notwithstanting termination of all or part of this Agreement, UNDP shall continue to hold mutilized payments until all commitments and liabilities incurred in the implementation of all or the part of the project up to the date of the termination have been satisfied and project activities brought to an orderly conclusion.
- Any payments that remain unexpended after such commitments and liabilities have been satisfied shell be disposed of by UNDP in comultation with the Donoc.

The Agreement may be amended through an exchange of letters between the Donor and UNDF. The letters exchanged to this effect shall become an integral part of the Agreement.

Article XI. Entry Into Force and Deration

This Agreement shall enter into force upon signature and deposit by the Donor of the first contribution-payment to be made in accordance with the ichedule of payments set out in Article I, paragraph. I of this Agreement and the signature of the project document by the concerned parties. This Agreement covers the period from 01 November 2013 to 31 December 2016.
