## 1. Background

The 2013-2014 DIPECHO Action Plan for the Caribbean aims to establish greater collaboration and coordination between partners, allowing programming of common outcomes and the harmonization of practices. Furthermore, it focuses on improving communication and dissemination of DRR key contributions in the region, by capturing evidence of success on how DIPECHO projects have allowed the most at risk communities to anticipate, withstand, adapt and sometimes, recover quickly from disasters.

The Action Plan takes account of the Hyogo Framework for Action 2005-2015: Building the Resilience of Nations and Communities to Disasters and reconfirms the commitment to regional initiatives to contribute to make schools and hospitals safer and cities resilient in disaster prone areas.

The regional project to be implemented by UNISDR includes the following elements:

- (1) Improving communication and dissemination of DIPECHO DRR tools and initiatives in the region,
- (2) Further advancing in the development of a common strategy towards DRR, as well as
- (3) Contributions to the consultation process leading to the post-2015 framework for DRR.

The specific objective (SO), results (R) and activities (A) from the UNISDR-DIPECHO project logical framework are presented in Annex 1 (previously provided).

- The responsibilities of the RLO are reported against the results and indicators of the DIPECHO action plan for 2013-2014. This report is therefore results-oriented. The key activities of the RLO according to the work plan are listed below: Coordinate the preparation/update of country documents in 9 countries at the regional level
- Support coordination with regional partners such as Caribbean Disaster Emergency Management Agency (CDEMA) and Association of Caribbean States (ACS)
- Support Petit Comité thematic working group
- Promote and support activities related to the International Day for Disaster Risk Reduction (IDDR) 2014 amongst DIPECHO partners and other DRR stakeholder

These responsibilities contribute to Results 1 and 2 as outlined in the Logical Framework. The results and the associated indicators into which the RLO contributes are outlined below:

Result 1 ‘Key DRR planning and consultative processes receive guidance and orientation for the identification of DRR priorities in the Caribbean region

- **Indicator 1.1** CDEMA and ACS apply DRR prioritization criteria in the formulation of CDM post 2012 and ACS plan for reduction of vulnerability to disasters.
- **Indicator 1.2** Initial and final regional workshop organized and produced instruments that facilitate information/coordination/rationalization of actions among DIPECHO partners.
- **Indicator 1.3** Criteria for Prioritizing DRR at the National Level incorporated in at least 1 new Country Document and disseminated to HFA focal points in 7 countries to update Country Documents.
- **Indicator 1.4** National liaison officers in two countries facilitating coordination between DIPECHO partners and national authorities and supporting the use and dissemination of tools produced in DIPECHO actions.
- **Indicator 1.5** HFA2 Consultations (one regional and two national) receive inputs from an ample base of DIPECHO stakeholders in the Caribbean reflecting main and distinctive priorities from the SIDS.

Result 2 of the Log frame ‘Strengthened dissemination, promotion and access to materials and knowledge produced in previous Action Plans in order to support DRR informed decision making in the Caribbean’.

- **Indicator 2.3** ‘Overall regional guidance provided for the promotion of the International Day for Disaster Reduction (IDDR) indicates the specific output to be achieved by the RLO.

Table 1 captures the progress achieved to date by the RLO. In particular the table highlights the tasks as outlined in the ToR for the RLO, the activities that have been undertaken by the RLO towards the achievement of the result, the results obtained to date and the percentage progress achieved. The percentage progress is compared with the respective indicator for the task.

## 2. Achievements of the Consultancy

This report captures the results achieved over the contract period of the consultancy by the UNISDR Regional Liaison Officer (RLO). The report reflects achievements related to Results 1 and 2 of the UNISDR regional project implemented under the framework of the Caribbean DIPECHO Action Plan 2013-2014 as prescribed in the TOR for the RLO and work plan submitted on 21 March. The results achieved are presented below in correspondence with the two Result Areas. The results are measured against the indicators highlighted in the section above.

### **Result 1: ‘Key DRR planning and consultative processes receive guidance and orientation for the identification of DRR priorities in the Caribbean region’**

The main achievements under this result area are related to 1) the coordination of the update/preparation of Country Documents for 9 countries in the Caribbean. and 2) the coordination of first component of the Project ‘Strengthening Public Investment in DRR and Climate Change Adaptation in the Eastern Caribbean’ led by the UNDP Barbados and the OECS in collaboration with UNISDR and the World Bank

#### **Country Documents and the Criteria for Identifying Key DRR Actions in Latin America and the Caribbean**

Country documents were updated in six countries and new CD documents were prepared for three countries. In the process of the updating/preparing the CDs, there has been stakeholder consultation processes that have led to the increased awareness of a broad range of public sector, private sector, civil society organisations and community members to contribute to DRR at the national and sub-national levels. Noting the aims of the CD, the awareness of stakeholders has been raised regarding the role of DRR to increase sustainable development. Stakeholders are also more aware of the DRR tools available through the DIPECHO programme. DRR tools, developed under the DIPECHO framework have been promoted during the national validation workshops to allow for the wider application of DRR principles across the sectors of the country.

In relation to the strengthened capacity of national disaster management systems enabling decision-making that integrates DRR, one final version of the CD for Dominica, five final draft CDs for Barbados, Grenada, Guyana, Saint Lucia and St. Vincent and the Grenadines; and two draft CDs for Trinidad and Tobago and Jamaica have been produced. Suriname has undertaken a consultative process as well to identify DRR priorities in the process of developing their draft CD based on the inputs from the national workshop (See Annex 2 for all CDs submitted).

The Criteria for Identifying Key DRR Actions in Latin America and the Caribbean (referred to as The Criteria hereafter) was applied in eleven countries of the Caribbean. The Criteria was applied at the national level in seven countries, in two countries at both the sub-national and national levels and at the sub-national level only in two countries. The key result has been the identification of DRR priorities at the national and sub-national levels (Report submitted previously). Based on these priorities a report has been produced which in order to inform the DIPECHO Action Plan 2015-2016. An additional report based on six feedback reports on the application of the Criteria in the Caribbean has also been prepared by the RLO (Annex 3).

For all countries, the knowledge of the DRR stakeholders in the national disaster management system has been increased as a result of the CD process which included the application of the Criteria. Knowledge has been gained on the DRR achievements, progress and the various ways that the stakeholders contribute to the DRR portfolio in the country. Further, the resource base of the national office has been broadened from the knowledge gained through the development of the CD. The key activities coordinated under the consultancy are presented below by country.

### **Country Document and Criteria Activities by Country**

*Barbados* - A draft final CD was prepared by the consultant Mrs. Danielle Evanson after extensive consultation with stakeholders, both individually and in groups. Inputs were garnered specifically from national stakeholders in Barbados Climate Related Tools Workshop held on 11 September and the coastal zone meeting to review the IDB vulnerability indicators on 15-16 Sept, 2014. The final focus group meeting was held on 17 October to fill existing gaps inCD. Comments were further provided by the DEM and the draft CD and interim report were approved on 23 October. The draft final CD was shared with the EMAC members on 20 October. A revised version based on DEM's comments was however re-submitted on 27 October. The CD was presented at the EMAC meeting convened on 28 October at the Savannah Hotel. The EMAC meeting has representation from 15 agencies. In general, the document was well received. The Committee decided that the document requires a few revisions. In particular, the consultant should consult with the agricultural sector.

As a result of applying the Criteria, Key DRR actions were identified at the national level and shared with the participants at the DIPECHO regional workshop held 16-17 October in Montego Bay, Jamaica. Timelines associated with the CD update in Barbados are shown below.

Grenada – The draft CD was submitted on 15 September and approved by NaDMA on 28 October. The national validation workshop was held on 29-30 October. Grenada's DRR priorities were identified based on the Criteria during the workshop. The final draft of the CD was submitted on 17 October for the review of NaDMA. The CD will be approved by the Grenada Cabinet. Timelines associated with the CD update in Grenada are shown below.

St. Vincent and the Grenadines – The draft CD was shared on 15 September in preparation to the national validation workshop which took place from 25-26 September at the office of the NEMO. A final draft of the CD was submitted by the consultant on 21 October along with the final consultancy report. The documents are currently under review by NEMO and the small committee established to review the CD. Based on the results of the Criteria, DRR priorities were identified for St. Vincent and the Grenadines.

Saint Lucia – The national validation workshops were held on 7 & 9 October in the South and North of Saint Lucia respectively. Based on the working sessions in the national workshop and the results of the Criteria, DRR priorities for Saint Lucia were identified for the DIPECHO regional workshop. The draft CD document was submitted on 17 November. The National Emergency Management Committee (NEMAC) is expected to approve the CD.

Dominica – A draft CD was submitted by the consultant Ms. Amonia Paul-Rolle on 18 August, 2014. The draft CD was presented and discussed in the national validation workshop held on 28-29 August, 2014. The draft final document was submitted on 27 September and the final document was approved by ODM on 3 October. The UNISDR subsequently provided comments to the consultant on the final documents on 12 October and endorsed the ODM's approval on 23 October. The ODM will advise on the exact date as they expect to present the CD in the same session with the CDM legislation.

Jamaica – The revised workplan was submitted on 6 October and approved verbally by ODPEM on 16 October and by UNISDR on 22 October. A zero draft CD was submitted by DRRC on 27 October. The national Consultation was held on 30 October and was attended by six public sector agencies. The interim report was later submitted on 13 November while the report on the

application of the Criteria was submitted on 20 November. The outputs for the consultancy are indicated in the table below.

**Trinidad and Tobago:** A draft CD was submitted on 5 September. Initial outputs from the criteria were provided to UNISDR on 10 October. The national priorities were shared during the DIPECHO Regional workshop held in Jamaica. It is expected that the final CD will be provided in mid-December given recent flood events in Trinidad that have derailed the process.

**Guyana** - The CD preparation process in Guyana is supported by the national liaison officer. Please see the consultant's report for progress on the country document. Critical dates have been provided for important outputs of the consultancy that will inform the administration of the consultancy.

### National Disaster Databases

The UNDP-led Project was implemented in 6 countries of the Eastern Caribbean – Saint Kitts and Nevis, Dominica, Saint Lucia, Grenada, St. Vincent and the Grenadines and Antigua and Barbuda. In relation to the results achieved, the capacity of 152 persons from across the 6 beneficiary countries was increased through training on the required inputs for and the use of the DesInventar methodology. The national training workshops on the DesInventar methodology were attended mostly by public-sector agencies. There were however some private and civil society sector actors in attendance at the workshops.



The national disaster management systems in the six countries were also strengthened under the Project through the establishment of their disaster loss accounting databases using the DesInventar methodology. The establishment of the databases was supported by two data collectors – Mr. Devin Kerins and Mrs. Nicole Williams. Mr. Kerins populated the databases for Antigua and Barbuda, Saint Kitts and Nevis and Dominica while Mrs. Williams carried out the work for St. Vincent and the Grenadines, Saint Lucia and Grenada. These two consultancies began on 18 August, 2014 and have been concluded as of 1 December, 2014. The final databases are attached as Annex 4.

Coordination of the two key activities under the UNDP-led Project was undertaken by the RLO with the support of the DRR Team at the UNDP and Mr. Julio Serje from UNISDR (Geneva). Support was also provided by CDEMA through Ms. Pamela Knights, the Communications Specialist. The activities were actively supported by the national offices in the six countries.

**Result 2:** ‘Strengthened dissemination, promotion and access to materials and knowledge produced in previous Action Plans in order to support DRR informed decision making in the Caribbean’

National offices and national DRR stakeholders have been exposed to the DRR tools produced under previous Action Plans, in particular the Criteria for Identifying Key Actions for Disaster Risk Reduction (DRR) in Latin America and the Caribbean. The RLO in her opening remarks at the national validation workshops highlighted the tools and shared the DIPECHO notebooks and the USB keys. The CD and other tools developed under previous DIPECHO Action Plans have also been promoted in the national validation workshops in the countries. The decision was made to implement the tool in St. Vincent and the Grenadines, Grenada, Suriname, Barbados, Dominica, Saint Lucia, Trinidad and Tobago and Jamaica. The tool is being implemented at the national level for all except Suriname that has applied the tool in two districts, while Dominica has applied the tool at both the national and sub-national levels.

The awareness of the Caribbean Disaster Emergency Management Agency (CDEMA) has also been raised as it relates to the DIPECHO tools, particularly the Common Format for the country document and the Criteria. These tools complement the work being undertaken on the country work programmes (CWP) at the national level. There was information sharing between the two agencies; CDEMA shared the country work programmes of the countries that informed the report on the DRR opportunities at the national level and as a region. Specific reference was made in the opportunities identified for each country to CWP activities. The draft CDs were shared with CDEMA as well.



### **3. Critical points and challenges**

Draft CDs have been submitted for nine countries and the validation workshops have taken place in all the countries. To date the CD for Dominica has been approved by the National Disaster Management Office. Draft final documents are available for all other countries with the exception of Suriname for which the draft document has been produced. All countries have been reminded of the urgency to finalize the process by the end of December and submit the final CDs. At this stage, Suriname is the most critical case for the Project. Noting the challenges that have been experienced in Suriname, it would be critical to maintain close collaboration with NCCR and the consultant. It may also be necessary to have further intervention by the Regional Manager or the Head of UNISDR.

### **4. Recommendations**

The Project will conclude by the end of December 2014. The work to be done in all countries, especially Suriname is now at a very critical stage. The implications of non-completion are important if the CDs are to be advanced beyond the stage reached previously. The advancement of the CDs to the level of Cabinet for approval would need to be advanced by the National Offices.

The continued collaboration among the RLO, consultants and the National Offices is of critical importance at this stage. Specifically, the consultants need to solicit the inputs to the CDs and the approval of deliverables. This will be critical for all countries that have not approved the final CD.
