| 17. Entry into Force: This Agreement, prepared in two originals, shall enter into force on the date of its signature by both the Principal Recipient and the Global Fund, acting through their duly Authorized Representatives identified in blocks 15 and 16 above. |

THIS AGREEMENT is made between the United Nations Development Programme (the "Principal Recipient") and The Global Fund to Fight AIDS, Tuberculosis and Malaria, a foundation established under the laws of Switzerland (the "Global Fund"). The Principal Recipient and the Global Fund are referred to herein individually as a "Party" and collectively as the "Parties".

RECITALS:

- (a) The Global Fund entered into a Program Grant Agreement with Population Services International/Nepal (PSI/Nepal) effective 19 November 2010 for the Grant Number MSA-910-G01-H (the "Original Grant Agreement"). The Original Grant Agreement was amended by Implementation Letters dated 22 February 2011, 20 September 2012, 15 April 2013 and 19 August 2013;
- (b) On 12 November 2012, PSI/Nepal informed the Global Fund of its intentions to resign from the role of Principal Recipient of the Original Grant Agreement, and on 18 January 2013 the CCM Steering Committee of the regional grant formally informed the Global Fund of its endorsement of the United Nations Development Programme, Asia-Pacific Regional Centre (UNDP-APRC) as a new Principal Recipient for Phase 2 of the Original Grant Agreement;
- (c) On 1 November 2013, the Global Fund approved the continuation of funding under the proposal that originated the Original Grant Agreement;
- (d) This Program Grant Agreement continues funding the program activities originally funded under the Original Grant Agreement;
- (e) The Global Fund has decommitted an amount of US\$ 6,984,356 from the Original Grant Agreement, and those funds are now committed under this Program Grant Agreement pursuant to the terms set forth herein;
- (f) This Program Grant Agreement sets out the terms and conditions on which the Global Fund will make available Grant funds to the Principal Recipient to implement the HIV/AIDS Program; and
- (g) This Program Grant Agreement is comprised of: (i) the face sheet; (ii) these recitals; (iii) the Standard Terms and Conditions attached hereto; (iv) the document entitled "Annex A Program Implementation Description", attached hereto; and (v) the documents entitled "Performance Framework Years 3, 4 and 5: Indicators, Targets and Periods Covered" and "Summary Budget Years 3, 4 and 5" attached to Annex A.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and intending to be legally bound, the parties hereby agree to the following terms and conditions:
